Dear Mr. Strickling,

As you know, the National Telecommunications and Information Administration (NTIA) requested that we provide NTIA with feedback on the many South Carolina-specific Broadband Technology Opportunity Program (BTOP) applications that have been submitted for consideration. In this letter, we list several projects that we believe will address South Carolina's unmet broadband needs and will advance our state's social and economic development objectives.

In an effort to ensure the grant review process was conducted with an appropriate level of diligence and expertise, we created the Broadband Advisory Committee to review and prioritize the grant applications. During Round Two, the Committee met on two separate occasions to discuss the merits of over 40 applications, receive comments from applicants and communications professionals, and select the applications that, in their opinion, best fit NTIA's grant criteria and South Carolina's needs. All applicants who wished to present their projects to the committee were given an opportunity to do so. The applications that the Committee recommended are listed below.

Sustainable Broadband Adoption

For sustainable adoption projects, the Committee gave priority to, among other criteria, applications that address broadband adoption on a statewide basis.

Elauwit Community Enhancement Foundation LLC- South Carolina Public Housing Broadband Adoption Project

South Carolina Educational Television - Bringing Broadband Home

V-Health - V-Health Telehealth Services

Farmers Telephone Co-op - Adopt a Laptop

Public Computer Center

For public computer center projects, the Committee gave priority to, among other criteria, applications from entities that have an established base in their community, have a track record of providing similar services, and address multiple areas of the State.

Community Infrastructure

For community infrastructure projects, the Committee gave priority to, among other criteria, projects that serve the target area the best and funds available to support the project apart from the federal dollars.

City of Columbia - Capital Community Broadband Services Infrastructure Project

We believe the Broadband Advisory Committee's recommendations reflect the BTOP's and American Recovery and Reinvestment Act of 2009's (ARRA) goals of enhancing South Carolina's broadband and economic development capabilities.
