During this past quarter, the University of Utah (U of U)/Utah Education Network (UEN) has placed priority on completion of the Environmental Assessment (EA). This Special Award Condition must be completed before any network build out activities can begin, such as ground excavation and new construction. The first and second draft versions of the EA were submitted in July and September, respectively. NTIA reviews of these draft EA documents found that additional information was needed including further consultation with the State Historic Preservation Office and the Army Corps of Engineers. After working with these two agencies, the U of U/UEN have completed the SHPO consultation and the 3rd draft EA has been submitted for review. Work continues on language contained in the contract agreements with Telecommunications Partners that will meet NTIA requirements. Additionally, the U of U/UEN is concluding meetings with all effected stakeholders and vendors to finalize network designs, implementation plans and sign off on contracts. These activities, when completed, will position the U of U/UEN to launch the implementation phase of the project.

The U of U/UEN has been working closely with NTIA BTOP program officers and consulting organizations in efforts to complete the Environmental Assessment and the contracts with Telecommunications Partners. The major challenges faced in completing the EA has been the amount of time required to complete surveys and begin consultation on Historic Sites and in getting access to the appropriate representative from the Army Corps of Engineers to begin their consultation. The delay in finalizing Telecommunication Partner contracts is due to an inability to identify an acceptable means of meeting the security interest requirement for the government.
