Zayo was notified of three route changes after we submitted our original draft EA. These route changes are being driven by the pole providers along the route as well as an airport expansion project. Zayo had to make changes to our original draft EA submittal. Because of these changes, we have had to issue 2 mods that increased our EA cost and delayed our schedule. Because of the extra EA work and engineering issues, Zayo has had an increase in labor cost. This explains our increase in expenditures. Zayo received permission from the Government to proceed with engineering while waiting on our draft EA submittal and our EONSI.

Zayo received permission from the Government to proceed with engineering while waiting on our draft EA submittal and our FONSI. The third draft EA was submitted on September 28, 2010.

Our Draft EA is done, but because it was the last day of the quarter, we have not been invoiced for this yet.

Zayo issued our Engineering RFP to 10 firms on September 1, 2010. Received Bids back on September 8, 2010. Based on the information we received back, Zayo determined that based on the size of the project and the time limit we had for the engineering phase, we would award the route in three sections to the three lowest bidders. Zayo Awarded the Engineering to RCG, TurnKey and JDH. All three are small businesses and familiar with the pole providers in the area as well as with this type of work and government.
