After completing the environmental assessment, KINBER has received a FONSI and is able to proceed with project construction. KINBER is still in negotiations with its contractor FIBERTECH (FT) related to a 20-year maintenance agreement and finalization of the purchase agreement (construction contract). However FT has requested a waiver of the mandatory performance bond for 100% of the project cost. If FT is not successful in obtaining a waiver, KINBER will need to select another contractor through a competitive RFP process. KINBER has begun developing an RFP as a contingency plan. KINBER has engaged an audit firm to conduct an annual financial review. KINBER staff and board members continue to attend public and professional meetings to promote the project. This included the first statewide Pennsylvania Broadband Summit where KINBER participated as a vendor with an informational booth.

KINBER's current vendor, FIBERTECH has requested a waiver of the performance bond requirement. KINBER is currently working with their program officer to determine if this is possible. In the meantime, KINBER has started a RFP process if the waiver request is unsuccessful since KINBER will need to select a new vendor or vendors to build the network. Without the waiver, the construction process will be stalled by at least 3 months due to the RFP process, vendor selection and contract negotiations. If necessary, KINBER anticipates being able to select a new contractor in mid-December 2010 and start pre-construction work (make ready and permitting) in January 2011.
