 The initial Environmental Assessment Draft was submitted on 11/29/10. Subsequent to final submission revisions were requested by the Federal Program Officer. At NTIA's request a revised BTOP Baseline Report was submitted on 12/20/10.
 It is assumed in forward looking reporting commentary / forecasting related to use of BTOP funds that a FONSI will be issued by 2/1/11.
 Decorah Iowa (BTOP grant sub recipient) has completed their 28E organizational agreement and has proceeded to the formal project planning phase.
 High level engineering was substantially completed during the reporting period.
 All elements of the BTOP project have been committed to the Microsoft Project format as the basis for ongoing detailed management by the BTOP team.
 Discussions regarding Special Award Condition related to overlap of other federal projects were conclusive and clearance is expected in the upcoming reporting period.

 Dealing with the SHPO in Iowa caused a delay and additional required effort in finalizing the EA draft. The affected area was on tribal lands and the tribal Historic Preservation Officer agreed to place archeological aspects of the project under their oversight which effectively resolved the issue. The ICN has also agreed as a component of the EA to stop construction and take appropriate mitigating

action if any archeological issues are discovered during the actual construction process. This applies not only on tribal lands but in all other areas of the project as well.

Requiring IRU vendors to certify that the Davis - Bacon requirement for BTOP have been met may be problematic for vendors because they consider fiber IRU's to be "a service" and not a hard asset sale. There is the potential that vendor RFP response for New IRU's could be inadequate due to this requirement.

The first draft Environmental Assessment was submitted one month prior to the required deadline. All NTIA requested revisions were completed and final EA Draft is on file at NTIA.
It is anticipated that based on the Final EA Draft a FONSI will be issued prior to 2/1/11 releasing project funding for use.

All RFP's will be released, responses received and analyzed (pending any issues related to vendor response due to Davis – Bacon requirement for New IRU's) , and vendor awards made during the upcoming reporting period.

Detailed engineering refinements, finalization of migration planning, and equipment staging / mobilization procedures will occur in the upcoming reporting period.

Ethernet site upgrades will commence during the upcoming reporting period.

Decatur County build components will be substantially completed by the end of the reporting period.

It is anticipated that all Special Award Conditions will be cleared during the upcoming reporting period including the review of potential overlap with other active BIP/BTOP projects will be completed in the upcoming reporting period.

Ongoing operational network interface discussions directed at long term cross usage operational agreements with Iowa Health System will occur during the upcoming reporting period.

The project requires the Iowa Legislature (convening in January 2011) signoff of purchases that exceed statutory limits. This event should occur by the end of the upcoming reporting period.

The Decatur County build component somewhat weather dependent. Assuming a normal winter (snowfall and temperature) the build should be substantially completed by the end of the reporting period. If snowfall is abnormally high or average temperatures are abnormally low it could negatively impact the project timeline by 30 – 60 days.

Requiring IRU vendors to certify that the Davis - Bacon requirement for BTOP have been met may be problematic for vendors because they consider fiber IRU's to be "a service" and not a hard asset sale. There is the potential that vendor RFP response for New IRU's could be inadequate due to this requirement

All timelines involving the release of BTOP funding assumes a FONSI will be issued by 2/1/11. A delay in funding release will create a commensurate delay in program timelines (as reported in Revised Baseline Report).
