Moving from proposal to actual award and implementation has caused the management team to review, refine and often modify preliminary program planning elements, desktop engineering assumptions, initial line item allocations and management practices.

Estimates of those participating in the network, thus affecting the overall sustainability model, has been significantly enhanced now that the project is funded; requiring us to re-budget the capital resources needed to meet expected demand. The real lesson learned here is that once programs have a firm foundation, the leadership team must be flexible enough to meet new obligations and opportunities; all while ensuring compliance with BTOP policies.
