MCNC received the notice of award on 08/18/10. MCNC formalized an agreement with Golden Leaf Foundation of North Carolina related to Golden LEAF's provision of \$24M in matching funds for the project. MCNC has begun work on a sub-recipient agreement with ERC. MCNC engaged in initial discussions with the 6 BIP/RUS winners in North Carolina that have projects in BTOP 2 build areas to insure that potential overlaps are identified and partnering to avoid these overlaps are discussed. The goal is to work together to achieve MCNC and the BIP recipient's respective goals. On 09/10/10, MCNC released an RFP for selecting an engineering and environmental assessment firm. The RFP was set to close on 10/4/10. MCNC also had discussions with several entities/service providers, which are interested in IRUs of fiber as part of the project. MCNC submitted the request to the NTIA for our 6-month budget on 09/17/10. As of 9/30/10 MCNC has incurred \$288k of expenditures for pre-award costs and legal fees in preparing the various contracts the grant will require. As of the end of the quarter we had not as yet requested reimbursement, so federal funding as of 9/30/10 was \$0.00. Reimbursement of these expenses occurred in early October.

MCNC anticipates awarding a design and environmental firm a contract to perform those activities during the early part of the second quarter. Until February the only work they can perform will be related to the baseline engineering and whatever effort is required to complete the environmental assessment draft. Discussions will continue with those IRU providers in hopes of being in a position to execute on those contracts as close as possible to the issuance of a FONSI. MCNC will continue to work with the RUS winners and NTIA in hopes of coming to agreement on what will need to occur in those areas of overlap such that federal funds aren't expended twice in the same area. MCNC expects that in this quarter discussions will begin with vendors for the provision of construction materials with the goal of executing a contract as early as possible to insure availability of materials. Depending on when certain sections of the project are slated to begin, MCNC will start the application process for relevant permits needed along the route.
