11b. Describe any challenges encountered with vendors or subrecipients.

The University of Alaska Anchorage Institute of Social and Economic Research (ISER) and Connected Nation worked to extend the existing research sub-award expiring at the end of Q1. The Alaska Broadband Task Force expressed a desire to keep ISER's sub-award current in order to fulfill additional research for the Task Force now that their timeline has been extended into Q2 2013.

Within the Q3 2012 Performance Progress Report (PPR), Connect Alaska presented two sub-recipient organizations in the Subcontracts Table totaling \$233,684. Per clarification received by the National Telecommunication and Information Administration's (NTIA) State Broadband Initiatives' (SBI) program office, funds designated for sub-awards should be classified and included within the "Other" budget category. As a result of this clarification, Connect Alaska has removed the two sub-recipients from the Subcontracts Table in the Q4 2012 PPR and continues to show a variance in the federal funds awarded between the subcontracts table (above) and the subcontracts line item on the Budget Worksheet of \$233,684.
