Connect Iowa (CIA) successfully submitted to the National Telecommunications and Information Administration (NTIA) an update to the state broadband dataset. The data update submission includes datasets for 98.02 percent of the provider community, or 198 of 202 total providers. There were 196 participating providers and 2 additional non-participating providers whose estimated coverage areas were submitted. Of the 196 participating providers, 55 supplied an update to their network or coverage area(s), while 133 reported no change. The remaining 8 represent providers who previously submitted data but were non-responsive in this update. The 4 providers that were not represented in the dataset have refused to participate in the voluntary program or were non-responsive to multiple contact attempts.

10bb. Please describe any challenge or obstacle that you have encountered and detail the mitigation strategies the project team is employing The Connect Iowa program continues to be challenged with educating Community Anchor Institutions on the importance and the nature of gathering data on location and broadband connectivity in accordance with the requirements of the State Broadband Initiative (SBI) Notice of Funds Availability (NOFA) Technical Appendix. The challenge is minimized by engaging sector and organizational leaders, with the assistance of our state clients, as stakeholders to distribute a CAI broadband survey on our behalf. Response has been significantly higher when the survey is distributed by the sector leaders. Connect Iowa will focus on one sector per month to better direct attention and outreach efforts toward specific sectors.

For Q1 2012, Connect Iowa's match percentage based on total expenditures was 16.90%. Thus Connect Iowa will fall short of the required match percentage by 3.14%. Connect Iowa is working with the Iowa Economic Development Authority to identify additional sources of match. Through the receipt of in-kind match from sub-recipient, the Iowa Association of Regional Councils, volunteers participating in the Local/Regional Technology Planning Teams and CIA Advisory Committee, as well as datasets from various state entities, Connect Iowa expects to meet it's required match percentage in Q2 2012.

The Federal Communications Commission (FCC) announced its plans to distribute \$300 million in wireless infrastructure subsidies to support the construction of high-speed mobile broadband networks. These subsidies – called the Mobility Fund – will be allocated later this year. In response, Connect lowa released maps and analyses comparing the FCC's list of areas eligible for subsidies to its own broadband inventory information. This analysis confirmed that the vast majority of the areas of lowa lacking 3G technology do not, in fact have adequate mobile broadband service. However, it also appears that many parts of lowa that do not have access to high-speed mobile broadband service are not on the FCC's list of eligible areas.

Connect lowa's latest broadband availability estimates, using the most recently published 2010 Census household data, indicates:

- 97.6% of lowa households have access to fixed broadband service of at least 768 kilobytes per second (Kbps) downstream and 200 Kbps upstream (excluding mobile and satellite services).
- 92.5% of lowa households have access to fixed broadband service of at least 3 megabytes per second (Mbps) downstream and 768 Kbps upstream (excluding mobile and satellite services).
- 2.4% of lowa households remain unserved by any fixed broadband provider, representing approximately 29,400 unserved households that do not have access to a fixed wireless or wired broadband service offering (excluding mobile and satellite services).

Broadband Capacity Building Quarterly Milestones Year 3, Quarter 1

Milestone: Connect Iowa Office Administration and Iowa Broadband Deployment Governance Board support.

This milestone was partially met. Connect lowa continued to provide administrative project oversight involving a variety of tasks that encompass administering the project plan, managing workflow and timeline, verifying work quality, gathering documentation in support of community outreach/projects, and preparing reports as required by the lowa Economic Development Authority and other stakeholders. The continued implementation of the position of Program Manager for the Connect Iowa program proves to be extremely beneficial towards providing support for the program and expanding the broadband adoption rates in the state of Iowa. However, due to circumstances outside of Connect Iowa's control, the Iowa Broadband Deployment Governance Board (IBDGB) has not been reinstituted, as such Connect Iowa's program staff have not held bi-monthly meetings as described within the approved project plan.

Milestone: Conduct the meeting(s) of the Iowa Broadband Deployment Governance Board

This milestone was not met. The lowa Broadband Deployment Governance Board (IBDGB) has not been reinstituted with new members assigned to carry out the work of broadband adoption in the state. The IBDGB has not convened since April 2011 and has yet to reorganize, and therefore, the future of the statutorily created IBDGB remains uncertain at this time. Connect Iowa has worked in conjunction with the Iowa Economic Development Authority to pursue alternative methods of completing this milestone in future periods via either a reconstituted IBDGB or alternative methods.

11b. Please describe any challenge or obstacle that you have encountered and detail the mitigation strategies the project team is employing Broadband Capacity Building

The status of the statutorily created lowa Broadband Deployment Governance Board is still unknown at this time. Connect Iowa, in conjunction with the Iowa Economic Development Authority, continues to purse alternative methods for holding bi-monthly and or quarterly state stakeholder meetings in future periods. Connect Iowa has recently instituted a Connect Iowa Advisory Committee, which held its first meeting during the quarter.

Technical Assistance

The peer review process was unable to be finalized before the end of Q1 2012. At this time, an appropriate peer review partner has been identified and a contract agreement has been signed. The peer review process is anticipated to be completed in Q2 2012.
