The beginning of this quarter marked the end of the first Justice in the Practice of Law Summer Certificate Program at North Carolina Central University (NCCU) School of Law (SOL).

On July 19, 2012, Legal Aid of North Carolina (LANC) held a Child Custody Clinic. Participants received legal advice for their child custody cases.

On July 26, 2012, LANC hosted a Continuing Legal Education Program (CLE) on "Interviewing Victims" for its attorneys throughout the

On August 2, 2012, Greg Clinton presented at The University of North Carolina - Chapel Hill on "Teaching in a Videoconference Environment." He discussed Technology Assisted Legal Instruction and Services (TALIAS) and how instructional technology influences student learning processes.

On August 8, 2012, the Pittsboro Office of LANC held an Expungement Clinic for participants with criminal records.

On August 8, 2012, LANC held a Child Custody Clinic. Participants received legal advice for their child custody cases.

On September 5, 2012, NCCU SOL held a panel discussion with the remaining members of the "Wilmington Ten" to discuss their conviction and request for pardon of innocence from Governor Beverly Purdue.

On September 11, 2012, NCCU SOL's Family Law Clinic hosted a question and answer session for participants to ask questions related to child custody, child support, and divorce to the supervising attorney in the family law clinic. This session was co-sponsored by the N.C. Fatherhood Development Advisory.

On September 12, 2012, NCCU SOL had an Eagle Empowerment Seminar, "Blue Lights In Your Rearview: Navigating Traffic Stops". Criminal law attorneys discussed individual rights to help reduce the stress and danger involved with police stops.

On September 17, 2012, LANC held a Child Custody Clinic. Participants received legal advice for their child custody cases.

On September 18, 2012, NCCU SOL's Family Law Clinic hosted a session, "Understanding the Ins and Outs of Establishing a Child Support Order." The supervising attorney discussed the importance of paternity testing, how child support is determined, the types of child support orders, the impact of custody on a child support order, and important resources.

On September 25, 2012, NCCU SOL hosted a session, "Collateral Consequences the 'Invisible Punishment." In this session, attorneys from the Southern Coalition discussed the collateral consequences of a criminal conviction and available relief mechanisms, including certificates of relief and expungements.

On September 27, 2012, NCCU SOL hosted a "Hazing Speaks" panel discussion on recognizing the signs of hazing and what to do. This program was co-sponsored by NCCU's Office of Greek Life, National Pan-Hellenic Council, Marching Band Sound Machine, and Athletics.

TALIAS events and sessions used HD videoconferencing and broadband.
