On January 22, 2013, NCCU SOL's Family Law Clinic hosted a seminar on "Child Support Establishment." The supervising attorney discussed the importance or paternity testing, how child support is determined, the types of child support orders, the impact of custody on a child support order, and other important resources.

On January 23, 2013, NCCU SOL hosted a "Hazing Hurts" panel discussion on recognizing the signs of hazing and what to do. This program was co-sponsored by NCCU's Office of Greek Life, National Pan-Hellenic Council, Marching Band Sound Machine, and Athletics.

There was an error made on the Q4 2012 report when calculating Contractual Federal Funds. The Actuals from Project Inception through End of Current Reporting Period for Contractual Federal Funds was reported as \$650,091 and it should be \$649,991. The error resulted from adding up all the categories that encompassed Contractual on the Grant Inception to Date report. The total was calculated with an extra \$100 due to misreading a figure. The error was recognized once the Q1 2013 report was finalized and the Contractual Federal Funds was lower than the previous quarter.
