10. Personnel

10a. If the project is not fully staffed, describe how any lack of staffing may impact the project's timeline and when the project will be fully staffed.

Approximately 10.2 FTEs worked on the project during Q1 2013 -- two from the Governor's Office of Economic Development (GOED) and 8 from the Automated Geographic Reference Center (AGRC). There was no increase in GOED staffing between Q4 2012 and Q1 2013. There was an increase of approximately 4 FTEs in AGRC staffing as explained in the attachment labeled: 13Q1PPR_Question 10_11_12_UT. The Utah Broadband Project was fully staffed at the end of Q1. However staffing levels will vary from quarter to quarter are dependent upon the level of effort expended for various activities during the particular quarter as explained in the attachment referenced above. In addition, GOED staffing levels will change slightly once contracts associated with the implementation of the capacity building detailed project plan amendment approved by the National Telecommunications & Information Administration Program Office on January 17, 2013 are executed. GOED stands for Governor's Office of Economic Development and AGRC stands for Automated Geographic Reference Center. Note: Staffing table in 10B was completed pursuant to

instructions for Question 10B from Quarterly PPR Instructions. Also, employees who worked less than 2 hours (which rounds to an FTE of 0) were listed as an FTE of 1 percent based upon guidance from Utah's NTIA Program Officer.

At that time, any new verification sources and methodology will be considered in order to best meet mobile broadband data verification needs.</p>
