ESRI houses the customized BBStat application in their highly available, monitored, and managed environment. Their services include maintaining a staging environment for data verification and compatibility as well as a production environment for client access.									

Consumer feedback is collected in the form of broadband inquiries. These inquiries represent any type of communications received from the public regarding broadband service. Once broadband inquiries are received across the state, this information is overlaid with the broadband availability information which was collected through the State Broadband Initiative (SBI). This allows for a real-world comparison of the broadband landscape to the information received from broadband inquiries. Broadband inquiries are able to provide three types of information: 1) residents who do not have broadband but want it; 2) residents who have broadband but want a different provider; and 3) residents who do not have broadband, but the broadband inventory maps indicate that they do. If residents within a region state that they are without broadband, but the broadband inventory maps show otherwise, this allows the project team to approach the providers within that area in an effort to trim down their coverage to more accurately represent real-world availability on the ground.

Within the Q2 2011 Performance Progress Report (PPR) our vendor Connect Puerto Rico proposed to target 2 additional companies in order to achieve a total field validation rate equal to or exceeding 68.42% before December 31, 2011. As of this report, field validation

has been completed on 66.67% of the provider universe.

As part of the State Broadband Initiatives (SBI) grant program, our vendor, Connected Nation, conducts independent validation and verification of the information that broadband providers report to us. In addition, an engineering review process is in place for estimating broadband service availability of firms that chose not to participate in the SBI program and do not share estimates of their broadband network with us. In Puerto Rico, for example, the semi-annual submission estimates the service coverage area, as the result of extensive field testing on the island and visits by our vendor's engineering team, of one cable company on the island that has not provided data. A separate white paper describing these validation and verification processes was provided to the FCC in coordination with the submission. These procedures have been used by our vendor in Puerto Rico and this process may be employed again by Connect Puerto Rico if it is deemed necessary.

During Q3 2011, Connect Puerto Rico, working in close coordination with the Puerto Rico Office of the Chief Information Officer (OCIO), continued gathering data on the location and broadband connectivity of Community Anchor Institutions (CAI), in accordance with the data requirements of the State Broadband Initiative (SBI) Notice of Funds Availability (NOFA) Technical Appendix. Efforts have been focused on conducting outreach and raising awareness of this important project through a statewide campaign.

Connect Puerto Rico has an ongoing mission to educate CAI throughout the state on the importance of participating in the project. We continue to utilize an online survey in both Spanish and English and raise awareness of the importance of CAI broadband connectivity.

On behalf of the Commonwealth of Puerto Rico, Connected Nation (CN) edited the survey instruments for the 2011 Residential Technology Assessment and the non-adopter telephone surveys, incorporating recommendations received from third-party consultants where appropriate. These surveys are designed to measure trends in technology adoption, barriers to adoption, and awareness of available broadband service among Puerto Rico residents.

The Office of Chief Information Officer (CIO) and Connect Puerto Rico coordinated the creation of the Puerto Rico Broadband Taskforce (PRBT). The inaugural meeting, facilitated by Connect Puerto Rico, took place on May 24, 2011, and the founding Charter was signed. In attendance were the five original founders: the CIO of Puerto Rico; the President of the Puerto Rico Junta de Reglamencion de las Telecomunicaciones; a representative from the Internet Society of Puerto Rico; and representatives from the IT vendor and telecommunications provider subcommittees. The goal of the PRBT is to author a Strategic Broadband Plan for Puerto

Rico that will provide a blueprint to help bridge the digital gap across the island. In order to ensure key stakeholders provide input to the Strategic Plan, the PRBT is currently composed of 12 members representing stakeholders from the Broadband ecosystem on the island. Connect Puerto Rico serves in a supporting capacity to the PRBT. In that capacity, Connect Puerto Rico provides multiple deliverables to the PRBT such as working products geared towards the completion of the Strategic Plan, including Strategic Plan outlines and guidance documents. Further, Connect Puerto Rico supports the PRBT by informing on broadband issues as they relate to Puerto Rico. Three PRBT meetings have taken place during Q3 2011 as work progresses towards the completion of the Puerto Rico Strategic Broadband Plan. 11b. 11j. Are there any additional project milestones or information that has not been included?

On behalf of the Commonwealth of Puerto Rico, Connected Nation will conduct a survey that oversamples households that do not subscribe to broadband. This survey will be in addition to the previously scheduled residential survey. This updated and improved methodology will provide a greater level of analysis regarding barriers to technology adoption among different socioeconomic and demographic groups by surveying non-adopters in Puerto Rico in a way similar to that conducted by the Federal Communications Commission (FCC) as part of the National Broadband Planning effort. This approach will help create a demographic and socioeconomic profile of the population of non-adopters in Puerto Rico, which can then be applied at the local level of detail by area planning teams, to assist in developing local adoption initiatives that will target the barriers that are unique to that area. In Q3 2011, CN refined the script and met with third-party contractors to plan the analysis methodology for this survey.

In Q3 2011 Connect Puerto Rico continued to build off the relationships that are already being developed through the work of the Puerto Rico Broadband Task Force and the OCIO. Additionally we are working closely with key members of the healthcare sector to receive existing data already collected on the Island and partner together to release a healthcare specific survey during Q4 2011. 11k.
