Project Indicators (This Quarter)

Long Term Evolution (LTE) Round 1

On June 30, 2018, the grant-funded network transitioned to AT&T, the private partner of the First Responder Network Authority, at the close of the business agreement and approval of the asset transfer agreement from the National Telecommunications and Information Administration (NTIA) and approved by National Oceanic and Atmospheric Administration (NOAA). The Los Angeles Regional Interoperable Communications System (LA-RICS) Public Safety Broadband Network (PSBN) has been operating a spectrum lease agreement with FirstNet since its inception. Since the transition has occurred, LA-RICS is no longer operating the PSBN.

Public Safety Broadband Network (PSBN) Site Transition to AT&T:

During the 3Q 2018, due to issues within AT&T and user equipment transitioning, AT&T decided to modify their transition plan to cutting over the sites directly to AT&T core vs. using the 10G link they installed to transition sites sooner. AT&T has provided their transport circuit cutover schedule on a weekly basis since the 4Q 2018 to keep LA-RICS updated on changes to the site cutover timing. As of the end of the 3Q 2019, 40 sites have received new transport, and have transitioned off the PSBN to the AT&T system.

Network Monitoring and Operations

Currently all operations are monitored by Motorola Solutions, Inc. (MSI) and AT&T as of 6/30/2018. LA-RICS continues to work with FirstNet and AT&T on their Local Control capabilities provided by AT&T and our ability to monitor the new FirstNet network. The new Local Control is being rolled out to the agencies as they sign on for service. Local control has been provided to the agencies during the 1Q 2019. Further meetings with AT&T have provided more definition around uplift and priority settings and how they will be implemented. Detailed time frames have not been established yet for the rest of the Local Control functionality. A meeting was scheduled for the end of September 2019 to get a better handle on future enhancements, but was moved to Mid-October 2019.

Network Optimization

During the 3Q 2019, no changes were made to the PSBN by MSI for Optimization; any changes to the network are now handled by AT&T and only to sites that have been transitioned to National Public Safety Broadband Network (NPSBN).

Special Events

There were no special events conducted during 3Q 2019.

Status of PSBN Agency Onboarding

LA Sheriff Department - 1,435 routers installed with 1,435 active on the network.

LA County Fire Department - 694 routers installed with 694 active on the network.

These numbers are the final numbers of active BTOP provided Modems that were put into service on the network. These modems will be reducing over the 3Q and 4Q due to being non-compliant with the AT&T/FirstNet system and will replaced by compliant certified equipment during the last 2 quarters of 2019. A separate program is keeping track of returned Modems to LA-RICS from the replacement program. The disposition requests for the older devices will be provided to NTIA and NOAA, who will ultimately provide the disposition instructions for the older, non-compliant devices.

All agencies onboarding program for LA-RICS have been concluded. No further on-boarding work is contemplated. All future on-boarding of agencies is at the sole discretion of AT&T/FirstNet

LTF Round 2

LA-RICS received formal approval of Objectives 1 and 2 from NTIA on 6/28/2018.

Objective 1 (26) Site Augmentation:

Work continued on PSBN Round 2 during 3Q 2019 for the following: Final site identification and concurrence with AT&T, Site Access Agreement (SAA) negotiations, creating environmental assessments for the first 15 sites and the second 11 sites. Zoning Drawings (ZDs) and Construction Drawings (CDs) have been completed for 13 sites, of those, 3 sites are in building permit process. Construction contracts have been awarded for 4 sites, and Invitations for Bids (IFBs) are being issued for 6 sites. SAAs have been fully executed for two sites. SAA for 6 Southern California Edison sites have been fully approved by both parties, they are planned to be executed immediately before start of construction, since the execution of SAA triggers rent payment.

Objective 2 Status:

Bid packages were issued to potential responders during the 3Q 2019 for the procurement of the Cell On Light Truck (COLT). Bids were received from the potential bidders on September 10th. Bid evaluation and contract negotiations will continue into 4Q 2019 to be ready for the December board meeting. LA-RICS and AT&T will also be working on terms for the FirstNet Remote Mobility Zone (FRMZ) service, which allows the building procurement and deployment of a COLT to run on the FirstNet AT&T service. AT&T has provided the minimum required elements that have to be purchased by AT&T (Radio equipment, satellite modem and FirstNet connection services), the contract and terms need to be vetted and agreed upon. Initial meetings with AT&T on the scope and supplied equipment started in 2Q 2019 and will continue into the 4Q to complete a contract with AT&T on the FRMZ services before the December board meeting.

Outreach Reporting

Various meetings continued in 3Q 2019 with AT&T to discuss technical and program management concerns, transition logistics as well as assignment and assumption agreement meetings for the migration of the PSBN to the NPSBN. During this reporting period, Executive Director Edson and Jacobs Program Management continued meetings with City Managers and/or Police and Fire Chiefs from the cities of Claremont, Covina, Inglewood, San Fernando, Signal Hill and South Pasadena to discuss potential Round 2 PSBN sites.

Board Actions:

On 7/11/2019 the Board approved an amendment to the Land Mobile Radio (LMR) SAA for Monte Vista Star Center (MVS2) to be a collocated LTE2 site. LTE Round 2 SAA for Inglewood (IGPD), Irwindale (IRWPD), Scholl Canyon (SCHCYN) and THOMSEN were approved by the Board on 8/1/2019.

LTE Round 1- Initial 76 Sites Program

Continue to Work with AT&T/FirstNet to implement Local Control as Agencies sign on with the FirstNet system and continue with device transitions to the FirstNet Network.

PSBN Site Transition to AT&T:

AT&T has 40 of 75 sites transitioned to date. Currently we are tracking both site access agreements and site cutovers to ensure a majority of the sites are transition to AT&T FirstNet Core during 4th Quarter 2019.

PSBN Round 2

Objective 1 – (26) Site Augmentation: It is expected that environmental assessment documentation will be submitted for all 26 sites. We expect to have Site Access Agreements fully executed for 20 sites, and building permits issued and equipment ordered for those same sites. We expect to have finalized the complete list of 26 sites to be built in Round 2. Eight more sites will be ready for submission as soon as final reviews have been made by the property owners. Draft CDs are being reviewed for the remainder sites. ZDs are in process for an additional seven sites. We expect to have designs completed and building permit applications submitted for an additional 2 sites in November, 2019, 15 sites in December, and the remaining 6 sites in January, Construction is expected to start at one site in December, 2019, 4 sites in January 2020, 13 sites in February, 6 sites in March, and the remaining 2 in April.

Objective 2 – Cell On Light Truck (COLT):

4th Quarter 2019 COLT work will entail finalizing contract details and creating an order for procurement the COLTS and have that approved at the December board meeting. LA-RICS technical staff will be working with LA-RICS procurement to finalize the AT&T/ FRMZ service scope with AT&T, during 4th Quarter 2019 to meet the December board meeting.

LA-RICS requests of approval for the retention of BTOP funded assets to continue to fulfill the objectives of the BTOP grant as well as provide beneficial use of the asset throughout its useful life was provided to NOAA/NTIA on 7/24/19.

Negotiations with agencies for LTE Round 2 site access agreements are underway. As we get closer to construction activities, outreach to residents/businesses within 500 feet of a site will be required.
