B. Executive Summary, Project Purpose and Benefits

Essay Question

10. Executive Summary of the proposed project:

The expansion of broadband access and connectivity is vital to the economic development and viability of families, institutions, businesses, and communities across North Carolina. According to census data from 2000, over 80 of the 100 counties in the state are defined as rural and represent un-served, under-served, and "hard to reach" locations for broadband infrastructure. In July 2009, the North Carolina state government released a broadband inventory map that documented broadband access and availability across the state. The inventory determined that while broadband service, at that time, was available to 92% of North Carolina households statewide, 241,000 households were being un-served by broadband providers. Regions of the state that showed the greatest need for broadband access and connectivity included the Western, Coastal Plain, and Southeastern/Sandhills parts of the state. State government and social services recognized the necessity of adopting broadband technology in order to remain economically competitive, while specific areas of education, legal justice, and health care are sited as especially impacted by lack of access to broadband.

State government has continued to prioritize broadband connectivity and adoption to respond to these challenges. North Carolina has seen key investments in the development of middle middle infrastructure, as a result. However, while the expansion of broadband infrastructure and networking has been made possible by projects like the Building a Sustainable Middle-Mile Network for Underserved Rural North Carolina project of MCNC, last mile initiatives are

required in order to engage end-users in the available resources. Throughout North Carolina, the growing broadband infrastructure creates an opportunity for institutions like North Carolina Central University School of Law to craft inter-institutional and cross-regional programs that promote broadband adoption and meet critical needs in our communities.

The NCCU School of Law Virtual Justice Broadband Project will draw new and under-served users to broadband through a unique application of technology that provides legal education and resources to communities across the state. The project will respond to several key needs in North Carolina, by providing remote learning opportunities to low and median income students at HBCUs, offering pro bono legal resources via the Virtual Justice model, and encouraging broadband adoption through the innovative video telepresence design. NCCU School of Law will partner with Kontek Systems to custom-design a system for specific use in remote legal applications, at Elizabeth City State University, North Carolina Agriculture and Technology University, Fayetteville State University, and Winston-Salem State University. These anchor institutions will work with NCCU School of Law to provide distance learning opportunities in legal concepts, as well as pro bono legal education for low-income populations in each region.

The impact that poverty has on access to legal justice is great. In 2005, the North Carolina Supreme Court commissioned a study chaired by Chief Justice Sarah Parker to explore the need to expand civil legal representation for people of low income and modest means in the state. An initial report of the North Carolina Equal Access to Justice Commission in 2008, found that: "When they need assistance with a civil legal matter, over 80% of low-income people and people of modest means cannot afford to pay attorneys and are unable to secure representation from publicly funded attorneys or pro-bono volunteers."

The Virtual Justice Broadband Project will respond to pressing legal issues facing low-income communities, particularly in Family, Veterans, and Civil Law. The project will concentrate both on low-income communities in the state and on institutions serving African-American populations. There is a significant geographic and demographic overlap between North Carolina regions under-served by broadband access, and those with high concentrations of poverty and minority populations. Of the counties currently being un-served or underserved by broadband, the majority are located in the Coastal Plain and Southeastern/Sandhills regions of the state, where many of the state's poorest communities live. According to the North Carolina Rural and Economic Development Center, twenty-three counties in North Carolina had poverty rates over 18% in 2003. All of these counties are rural, and 19 of them are located in the Coastal Plain

region. All of the 23 counties in which North Carolina's lowest income communities live are counties currently under-served by broadband. Finally, these persistently poor counties have the highest concentration of African-Americans in the state. While greater than 50% of the 560,000 rural people living in poverty are white, the poverty rate for rural blacks, which was 27% in 2003, is more than 1.5 times greater than the rate for rural whites. In 10 Coastal Plain counties, all of which are under-served by broadband access, more than a third of blacks live in poverty. Another region of focus for the project includes counties in the Southeast/Sandhills region, especially Pender, Robeson, and Columbus Counties, which also show significant concentrations of low-income African-Americans lacking in broadband access.

The universities that are participating in the project, particularly Elizabeth City State University and Fayetteville State University, serve as anchor institutions for these target populations. These institutions recognize the potential of broadband expansion to transform these communities for the better, by connecting low-income individuals with critical resources. NCCU School of Law is the ideal institution to design and coordinate the Virtual Justice Broadband application, given our commitment to incorporating technology and our proven approach to community legal education. NCCU School of Law is the only HBCU in the state and one of only two public institutions with a professional program in Law, and has been voted #1 Best Value in a law school education by National Jurist in 2009 and 2010 and is ranked 20th overall in the nation. Additionally, during the 2008-2009 academic year, 502 students participated in pro bono and clinical internships and externships at NCCU School of Law. These students provided 9,767 hours in free legal assistance to approximately 93 legal organizations, at a value of more than \$1.1 million in services.

The total budget of the NCCU School of Law Virtual Justice Broadband Project is \$2,832.426. The budget includes a 30.1% match of \$853,900, provided by in-kind and direct contributions from the project partners. Through this project, 7 new jobs will be created, three of those new positions at the NCCU School of Law, and one at each anchor institution.

11. Project purpose:

A growing application for broadband technology, telemedicine, has demonstrated the potential of broadband to connect vulnerable populations to vital social resources. The University of New Mexico School of Medicine, a leader in the nation in the adoption of telemedicine, conducted studies that demonstrate that the quality of their care has improved, while costs at the hospital have been reduced, as a result of applying telemedicine. These strategies, which include web-

based professional consultation and image-sharing, have resulted in a major reduction in hospital costs. The Center for Telehealth and Cybermedicine Research at the University of New Mexico School of Medicine demonstrates the capacity of broadband technology to bring medical care to underserved populations more efficiently.

The Virtual Justice project will employ a similar strategy, using broadband technology for legal education and resources in underserved communities. The project will build on the existing use of broadband technology at each institution, by expanding video tele-presence and remote learning to the seven universities. By capitalizing on the Building a Sustainable Middle Mile Network for Underserved Rural North Carolina, a project of MCNC, NCCU School of Law will carry broadband access the last mile for anchor institutions that serve disadvantaged populations in North Carolina.

The NCCU School of Law is uniquely positioned to respond to these challenges, because of its accomplished academic program and clinical services, as well as the adoption of broadband-based learning. Voted #1 Best Value in law schools, and 18th in the nation in technology, NCCU School of Law has established its program as an effective model for technology adaptation in an educational setting.

Currently, the school employs 12 smart classrooms, which are fully equipped with a touch panel controlled A/V integration system to allow for fully immersive learning experiences for teachers and students. NCCU has also implemented a lecture capture system, which allows students to review recorded material via the web, including class meetings and special events. In less than three years time, the school has accomplished a 97% user-rate among faculty and a 38% user rate among students. Since implementation of this system the amount of recorded material made available for viewing has risen from 82 hours annually in 2007 to over 1,000 hours annually for 2010. Students may access recordings from both on and off campus and have viewed as much as 1,716 minutes including of 256 viewings over a 24-hour period. Popular courses frequently surpass 20,000 minutes of viewing time while the top 5 courses viewed average 5,607 minutes of viewership.

The project will respond to the purpose of this funding by providing training, equipment, and access, to educational institutions and end-users, in order to expand existing clinical legal programs and create undergraduate legal seminars at each university. Currently, NCCU School of Law administers a wide variety of clinical programs, including Family Law, Civil Litigation,

and Veterans Law. The Law School participates in community-based legal education, which will serve as a model for one program area of the project. Clinical attorneys conduct face-to-face educational sessions with low-income individuals seeking knowledge about the law. These sessions do not provide legal representation, but rather, give consult- and advice-only guidance that empowers individuals to access legal justice by understanding law and pro-se, self representation.

NCCU School of Law Clinical Program will expand its proven, effective free service exponentially, and at less burden to individuals who participate. Rather than incurring the expense and challenges in order to participate in-person, individuals will access this education remotely. This will provide rural and low-income individuals access to legal resources that might not otherwise be available. Additionally, they will gain awareness and knowledge about broadband applications like video telepresence. For NCCU School of Law, the project represents an opportunity to develop its model of Virtual Justice through broadband adoption. Anchor institutions will enhance both the scope and purpose of their broadband access to meet the needs of low-income people across the state.

Legal seminars will be made available through this project to undergraduates at each of the anchor institutions. While NCCU is currently employing broadband-based learning, this project will add capabilities that do not exist in legal education in North Carolina. Students and Faculty will experience real-time, high-definition video telepresence that provides a state-of-the-art remote learning experience. Students will have access to technology, through broadband, that provides an immersive video-conference environment. In addition to gaining academic knowledge of legal concepts, students will experience invaluable exposure to broadband capabilities.

The project is consistent with the statutory purpose of the funding because it provides widespread opportunities, especially for youth and low-income individuals, to gain training and experience in the use of broadband technology and several dynamic applications. The project also focuses on underserved populations throughout North Carolina that have been identified as priority areas for improving broadband access and adoption.

12. Recovery Act and Other Governmental Collaboration:

The NCCU School of Law Virtual Justice Broadband Project will increase the impact of existing Middle Mile Network broadband expansion projects, by carrying this technology directly to

endusers, while responding to other service needs in the state. The Building a Sustainable Middle-Mile Network for Underserved Rural NC project of MCNC, which was granted \$28,225,520 in Round 1 of BIP/BOP, funding has as its primary statutory goal, improving affordability and access for education, health care, community institutions, and last-mile providers.

Through that project, MCNC is able to provide middle mile broadband infrastructure to and connectivity across 37 North Carolina counties, with over 20 representing unserved and underserved populations. The project encompasses the communities of nearly half of the state's residents, and represents a vital step forward for broadband infrastructure, as well as education, economic development, and social services.

The NCCU School of Law Virtual Justice Broadband Project is responding to the opportunities presented by the MCNC project, to utilize the enhanced capacities at anchor institutions and provide state-of-the-art education and social service opportunities to the same underserved communities. As University of North Carolina schools, each of the anchor institutions are on the improved broadband networks provided through the MCNC project, and there is a significant overlap between the communities served by these institutions and the more robust and connected network built through the MCNC project.

The NCCU School of Law project provides an efficient opportunity to leverage those investments, as the existing anchor institutions are already supported by the network, and committed to expanding adoption and use of broadband capacity through their institutions. Kontek Systems, as the system integrator, will design an application unique to the project, with a special focus on Virtual Justice and legal education. Kontek Systems will work with North Carolina Research and Education Network (NCREN), if necessary, to ensure that each site will function efficiently, and at full capacity, toward the objectives set out in the project.

13. Technology Strategy:

The Virtual Justice project will establish video telepresence and synchronous education across the four anchor institutions. The project will require the expansion of existing capabilities at NCCU School of Law as well as the anchor institutions. Each anchor institution will acquire a complete high definition room telepresence system, configured to support both remote client/attorney legal clinic consultations and educational seminars. This equipment will include video network infrastructure upgrades to support secure firewall traversal and data encryption.

NCCU School of Law, as the coordinating partner, will acquire a multi-screen video telepresence system that will serve both as the host room for faculty instruction and legal clinic consultations and as the control point for remote monitoring and management of the six remote systems. It will also acquire video network upgrades to support multi-site video calling and secure firewall traversal.

In order to coordinate the technical and programmatic aspects of the project, NCCU School of Law will hire three administrators at NCCU and one located at each anchor institution to manage the project. Project administrators at each institution will be charged with working with the NCCU technical staff to coordinate the use of videoconferencing, teleconferencing, remote learning and the other applications. Administrators will also work with faculty at each institution to implement the two program objectives: community clinics on law, and legal undergraduate seminars.

NCCU School of Law is developing a comprehensive marketing strategy to raise awareness about the capacity of broadband-based learning to improve the quality of education and access to legal justice. This public education campaign, which is being coordinated by the lead applicant and implemented by the partners statewide, will help each anchor institution identify project participants, both students and community members, most in need of broadband access and the opportunities presented by this project.

14. Innovative Approach:

The Virtual Justice Project is an innovative approach to broadband adoption, because it expands the application of Virtual Justice to include remote learning and immersive video-conferencing capabilities through broadband technology.

Specifically, the project will encourage broadband adoption, at an institutional level, by offering a resource in legal education that is desperately needed in low-income communities. Participants will be drawn to the resource by a proven approach to group learning, and they will gain awareness and knowledge about broadband as a result. The high-resolution technology is ideal for this purpose as it is designed to allow participants a fully immersive experience, with real time communication and interaction, without requiring obtrusive or burdensome interaction with equipment. The system will be designed so that users can approach the technology, with little training, and interact directly with its video telepresence capabilities.

Indirectly, users who participate in the project will have exposure to user-friendly broadband applications that will encourage them to pursue broadband access in their own homes and discover more applications. As awareness of these vast broadband applications grows, the demand for broadband access increases.

One major challenge to the Virtual Justice application, which relates to confidentiality and information integrity, is addressed in an innovative way by the project. Previously, when legal professionals used broadband video technology in their work, they required Integrated Services Digital Network (ISDN) communication lines in order to ensure secure transmission. Often the recurring monthly cost of these ISDN lines were cost-prohibitive for users serving low-income clientele.

This project will employ AES encryption technology, which allows secure communications over standard broadband IP networks and meets the requirements for HIPAA compliance, thus making Virtual Justice that much more accessible to vulnerable communities. This innovation is a key component of the project that is only made possible through the expanded adoption of broadband throughout the state.

29. Vulnerable Populations

The NCCU School of Law Virtual Justice Broadband Project will target three vulnerable populations in North Carolina: African-American, Low-income, and Youth.

Regions of the state currently un-served and under-served by broadband have high concentrations of low-income and African-American populations. The Coastal Plain and Southeast/Sandhills regions, which will be target areas for the project, show an overlap of lack of broadband access, persistent poverty, and African-Americans. According to a recent North Carolina government report on broadband connectivity, 241,000 rural households are currently un-served by broadband connectivity. And while greater than half of the rural poor are white, the poverty rate amongst African-Americans in those same regions is more than 1.5 times greater than the rate for whites.

30. Accessibility

In accordance with federal statutes (Section 504 of the Rehabilitation Act of 1973) and state statutes (North Carolina Gen. Stat. § 168A-7; Section 3) governing access in publicly funded institutions, each of the participating anchor sites is fully accessible to qualified participants with varying abilities. In order to ensure that the project is welcoming and accessible, project facilitators will be trained to present the technology in a manner consistent with accessibility, as set down in federal and state statutes.

34. Sustainability:

In March 2009, a bill entitled Broadband Technology Funds [House Bill 826 (S1002)] was introduced in the North Carolina House of Representatives to authorize a \$7.4 million matching funds pool to leverage federal funds through the American Recovery and Reinvestment Act for Broadband Technology Opportunity Grants for the purpose of mapping and deploying broadband technology in the State's rural communities. The State of North Carolina recognized its opportunity to leverage federal investment and greatly impact the existing broadband infrastructure and adoption in the state.

Currently, the legislation has been referred to an appropriations committee, and the funds have not yet been authorized. The Virtual Justice project meets multiple objectives of this funding priority, and one part of the sustainability strategy will be to pursue those state funds should the pool ever become authorized. The project partners will work to identify additional potential funding sources that are consistent with the scope and goals of the project. The project timeline includes several months of research and planning in order to identify such resources to sustain the project.

The Virtual Justice Project will also be sustained through program income and additional funding sources beyond the two-year grant period. The undergraduate seminars in legal concepts will generate revenue, via course tuition, at each anchor institution. This income will be applied towards equipment maintenance and administrative costs associated with each remote location.

North Carolina Central University developed an internal incentive program to encourage the adoption of distance education at the institution. Individual faculty are encouraged to develop

online courses and, if enough courses are offered in a given unit, the university hires additional permanent faculty to support the unit. These financial incentives support the expansion of distance learning, which NCCU School of Law intends to benefit from. The adoption of remote learning seminars through this project will create incentive to expand the Law School faculty and increase its capacity to support the project.

The Virtual Justice model itself is sustainable, because it does not rely on major capital investments, or dedicated faculty and staff at the anchor institutions beyond the new positions.

Budget narrative	Total project cost is \$2,832.426. Total federal request is \$1,978,526, and match is \$853,900. Project costs include equipment purchase (\$999,403), installation (\$174,978), and systems support (\$89,745), personnel and fringe benefits (\$833,400), facility and network maintenance and support (\$600,000), training materials (\$25,000), marketing/awareness (\$75,000), pre-grant expenses (\$30,000) and grant writing (\$4900). Pre-grant expenses (\$30,000) include teleconferences and videoconferencing between partners, travel for meetings, staff for project development, and materials. The \$4,900 grant writing cost covered contracting a grant writer (Dannette Sharpley Consulting) to complete the federal request. Other First Quarter costs include equipment purchases for the NCCU hub and 4 remote sites. NCCU hub purchases include 1 Polycom RP4X (\$500,420), 1 Polycom Bridge Upgrade (\$99,327), and 1 VBP (\$7,076). Remote site purchases include 4 HD1X systems (\$91,069 per unit, or \$364,276 total) and 4 VBP (\$7,076 per unit, or \$28,304 total). Other First Quarter expenses include \$75,000 contract expenses (Kompleks Creative, Inc.) to launch Marketing Campaign and develop Assessment Tool. The cost will be spread out over the two-year grant period, with half paid upfront and the remaining half upon project completion. Other expenses to be spread over the grant period include hiring and training staff to implement the project, and system support by Kontek. Personnel expenses to include 1 Project Manager at NCCU (\$50,000 per year for two years), 1 Project Coordinator at NCCU (\$50,000 per year for two years), 1 Project Coordinator at NCCU (\$30,000 per year for two years) and 4 On-site Managers at anchor institutions (\$40,000 per year for two years). Eight staff attorneys at NCCU School of Law will staff the program part-time, over a 2-year period (\$9,000 per year for two years). Fringe benefits for all 6 new hires is \$134,400, which includes Project Manager

	(\$22,400 each, or \$89,600 total). Kontek Systems will provide systems support and train each staff, and work with NCCU School of Law to develop training materials for end-users. Systems support costs over the 1 year include RP4X support (\$60,689), HD1X support (\$3,740), Bridge Upgrade support (\$17,996), and VBP support (\$7,320), \$89,745 total. Both the support and training (\$25,000) expenses will be incurred initially and spread out over the grant period (year 1 for support, and two years for training). In-kind contributions of \$120,000 per institution over a two year period include the donation and maintenance of one room to serve the project, and the use of broadband access, and network and systems support. This total project cost is \$600,000 over a 2-year period. Remaining project expenses include the hiring in year 2 of a Site Instructor at NCCU Hub to further develop and expand programming. The cost of that position is \$75,000 to be incurred in the 4th Quarter for year 2.
Budget reasonableness	The total installed cost of the each anchor institution telepresence system is \$106,249. In rationalizing the choice of Polycom over competitors, there are important features that justify the costs. Cisco markets a fully immersive telepresencing package that offers most of the same features as Polycom. However, the Cisco solution is less affordable and has limitations to adoptability, because it is an entirely proprietary closed system. The full information sharing functions, particularly security and resolution, are only accessible when Cisco products are "talking to each other". These limitations, which are not an issue with Polycom, would severely hinder the ability to expand the use of the Virtual Justice program, particularly through the incorporation of a Polycom Converged Management Application. The CMA would allow end-users to participate from their homes, expanding the impact of broadband adoption and the project benefits exponentially. The University of New Mexico's Center for Cyberhealth and Telemedicine has documented the cost savings and efficiency of

telemedicine. They developed a windshield time cost estimator that demonstrates the inefficiency when doctors and patients are routinely transferred across territory for services. A similar estimate can be developed to demonstrate the value of providing legal needs over broadband. In 2008-2009, the clinical program provided 9,767 hours of free legal service at a value of \$1.1 million. This figure doesn't factor in the cost to clients traveling from remote areas of the state. In the Virtual Justice project, the program will increase its offerings of free legal service to remote communities, with far less financial or environmental impacts due to travel.

For low-income populations, gaining broadband access and experience, as well as qualified legal education is invaluable. Legal Aid of North Carolina published a report in 2003 assessing the legal needs in the state, and identified civil legal challenges as particularly difficult to overcome for low-income people. In many cases, without private legal representation, individuals have little to know access to courts, and have no opportunity to advocate for themselves in legal proceedings. Through the Virtual Justice project, the participating institutions will help to close the gap in legal representation between low-income populations and those with greater financial wealth.

The project is also an extremely valuable investment in the potential of low-median income undergraduates. Students who participate in the seminar program and pursue careers in law will have an advantage in applying to law schools and succeeding in those programs. On average, degrees in law are worth between \$750,000 and \$1,000,000. The Virtual Justice Broadband Project is a wise investment in the potential of low-median income African-American college students who are currently under-represented in most professional careers, including law.

Demonstration of need

The NCCU School of Law would not be able to implement the Virtual Justice Broadband Project without the assistance of federal funding. In a year in which the state budget shortfall may reach \$4 billion, state budget cuts to the University of North Carolina system have required

austerity measures and allowed very few new projects to be funded. Kompleks Creative is developing a comprehensive marketing plan that will reach 500,000-1,000,000 individuals per year for the project. Kompleks will use a branded image approach by popularizing both the concept of Virtual Justice and the NCCU School of Law, in advertising the project opportunities.

The targeted outlets include the cities and surrounding areas of each anchor institution: Winston-Salem State University (Winston-Salem), North Carolina A&T University (Greensboro), NCCU School of Law (Durham), St. Augustine University (Raleigh), Elizabeth City State University (Elizabeth City), Fayetteville State University (Fayetteville), and UNC Pembroke (Lumberton).

The primary target population for this project includes low-to-median income individuals who have legal needs that they are not able to resolve through alternative legal services. Many North Carolinians living at or near the poverty level have gained legal support through non-profit Legal Aid and other pro bono resources. Individuals with sufficient income for private practice attorneys, tend to have adequate access to representation. This project will target those individuals who require education about legal concepts and resources, and either 1) do not qualify for Legal Aid due to income restraints, or 2) do not understand their right to access such services. While race and ethnicity vary widely in this income bracket, this marketing strategy will specifically target African-American and Native-American populations. Kompleks will primarily focus on radio strategies for reaching the project's target audience. They will also employ print media, online advertising, and television strategies for outreach and awareness. Direct-mail will be uniquely targeted toward legal aid networks with direct contact to those individuals in need; while strategically timed press activities will help to build a market before the project begins.

The secondary target population includes undergraduate students at each institution. These students are predominantly low-median income African-American and Native-American youth studying at Historically Black and Native-American Serving institutions. Kompleks will focus those strategies on poster and print media, online advertising, and Facebook-style social networking.

This marketing plan differs from conventional approaches in that it will not center its imaging on broadband technology and access, but rather on the Virtual Justice application. Recognizing that the target populations have been under-served by broadband and internet access, this approach will avoid confusing, intimidating, or alienating potential new users by highlighting the legal

resources available, instead of the technology. Every media strategy will include talking points, which highlight broadband and distance learning as the vehicle for this program, but the campaign will rely on interest in the service to draw new users to the technology.

48. Measuring Campaign Impact: Describe how you will measure the impact of the awareness campaign.

Kompleks Creative, Inc. will employ a variety of strategies to measure the impact of the campaign. For the online strategies, a combination of online clicks and impressions tracking, google analytics and conversions will be used to gauge the impact of that aspect of the campaign. Kompleks will track the impact on users through sign-up and registration processes, as well as participant surveys, by asking questions about how individuals learned of the project and about participants who were new broadband users. Kompleks will provide period reports to assess and document the effectiveness of media strategies throughout the 2-year grant period.

NCCU School of Law is well-prepared to implement the project in coordination with the technology partners and anchor institutions, as a result of its experience with the broadband-based learning and academic programs. NCCU School of Law, as demonstrated by its investment in information technology facilities, is committed to promoting, supporting and integrating appropriate technology that is seamless, up-to-date, and user-friendly. Under the Federal Title III, Part B act "Strengthening Historically Black Colleges and Universities", the NCCU School of Law received funding to develop and strengthen its technological capacity to meet the needs of predominantly low-income students in a law program.

Some of the technology being utilized at the School of Law includes The West Educational Network (TWEN), which is a broadband-based online classroom management system. This system, similar in concept to BlackBoard, was designed specifically for use in law schools. Additionally, the facility has implemented an Audience Response System (APS-Clickers) for use in classrooms, that also has broadband-based capabilities. Because of the success of the Title III investment, the NCCU School of Law has fully developed and staffed the the information

technology-based system and has transferred the maintenance for the operation to the North Carolina state budget, which now fully supports the management and facilities costs.





This letter is being submitted in support of the NCCU School of Law Virtual Justice Broadband Project. As a participating anchor institution, Elizabeth City State University (ECSU) is excited about the potential of this project to increase broadband adoption, enhance technological capacity, and strengthen programs at the university. ECSU is working to complete a Memorandum of Understanding, indicating our intention to participate in the broadband expansion in the following ways: 1) dedicating a learning space that will be used for legal seminar courses and pro-bono clinical services; and 2) implementing an undergraduate seminar in legal concepts to be taught remotely by NCCU School of Law participants.

Currently, our institutional broadband access consists of 100 megabits per second speed connection. Participation as an anchor institution will improve our broadband access usage by bringing in additional programs that will benefit the community we serve, and enhance our ability for future education and research growth. This project is important to our institution, as we educate and serve a community that to-date has not had free access to the technology and resources provided by broadband internet access. The demographics served by our institution are predominantly rural students of color from low-income communities.

According to US Census data and telephone surveys in 25 block groups within the seven census tracts of Pasquotank County, within which ECSU is located, 255 out of 850 households in block group 2 are without broadband connectivity. Though the group has the county's sixth highest median income at \$33,529 due in large part to the presence of the university, it is well below the national median income of \$52,029 (2008 US Census Bureau figures). This initiative is particularly important to them and our university.

Many local residents, as well as those from neighboring communities in Hertford, Gates, Chowan, Perquimans Currituck, Bertie, Halifax, Northampton, Washington, and Nash receive a wide-range of specialized services from the staff and faculty at Elizabeth City State University, including access to the University Drug Information Center. The university currently provides

Information about chronic diseases and medication to the community through its Drug Information Center ran by the School of Pharmacy. It is a resource center that provides information about prescription and non-prescription medications including vitamins, minerals, dietary supplements and alternative therapies to people in the community. It also provides relevant, accurate, and unbiased drug information to healthcare professionals and communities in north eastern North Carolina and south eastern Virginia. There is no charge for any its services, and general health consultations are available with a pharmacist by appointment. A high-speed broadband connectivity to this facility will improve communications with the public while reducing operational cost for this center.

Our university will contribute in-kind services in the form of learning spaces and staff and administrative support to implement the project. We will also contribute funds and help to sustain the project by providing the NCCU School of Law with a percentage of the income earned through undergraduate seminar registration fees. We believe there is a demand for this service and are encouraged by the results of a similar partnership we have with UNC Chapel Hill School of Pharmacy.

The Virtual Justice project brings multiple statewide priorities, including broadband adoption, distance learning, and legal justice into focus. With the support and participation of our institution, this project can make a significant impact on the rural communities in the northeast part of the state of North Carolina.

In addition to the in-kind contribution of space, our institution is also providing broadband access, network and systems support, and facility maintenance to support the site that will be utilized for this project. 


