MBC provides optical transport services, using SONET/TDM, Wavelength, and Ethernet Connections. Ethernet circuits are provisioned as Ethernet over SONET, and each circuit has dedicated STS's for transport delivery. Standard contract terms are 24 months.

MBC provides secured, carrier-class collocation space (in 1/4 rack increments are 12 rack units) for members. Due to grant funds being used in the construction of the MBC backbone network, Dark fiber IRUs are no longer offered. Fiber lease arrangements are considered on a case by case bysis.
