During the quarter Zito continued to connect anchor institutions and other customers along the project's path. Zito continued informational brochure mailings to potential anchor institutions. With this project Zito Media Communications II, LLC was able to bring broadband internet speeds to our last mile service areas that did not have it previous to this project. Also, the project brought competition and better rates in the project area to anchor institutions and other commercial customers. Zito created 50 jobs under the project. Zito's commercial division is continuing its outreach with economic development groups and chambers of commerce to bring broadband options and services to underserved areas. With this project Zito was able to interconnect anchor institutions, such as a regional medical provider, to allow easy patient file transfers between multiple locations in the region and new broadband services to local governments. Finally, Zito will continue to provide non-discriminatory and open access to the network for all anchor institutions, commercial customers, and last mile providers.
