We have met with all five participant anchor institutions (TSTC, STC, UTPA, UTB, &amp; UTHSC) to review facility engineering plans. Engineering has started at all five CAI locations. We also purchased and closed on land in three locations - Brownsville, Weslaco and Edinburg. We completed the engineering design and staking in Rio Grand City. We completed the engineering drawing and 50% of staking of the Harlingen (Treasure Hills) to Brownsville (Hwy 48) middle mile route segment. We completed duct searches in Brownsville, McAllen, Edinburg and Harlingen.</p>

Complete building design and start construction in Brownsville, Weslaco and Edinburg. We are purchasing middle mile fiber in anticipation of long delivery intervals due to high fiber demand.
