A prime example is a CAI that experienced speeds of 56 Kbps to 512 Kbps, depending on location, and it is now running a 100 Mbps Vlan and is connected to the internet at 100 Mbps as a direct result of the BTOP Project. This type of bandwidth was simply unattainable prior the BTOP facilities construction because of the prohibitive cost to reach remote areas over difficult terrain.
