PLEASE NOTE: The data provided in response to questions 15 and 16 below are simply re-produced from the State's most recent Annual PPR, because they reflect the currently approved project, though that original project direction has been overtaken by events. Due to regulatory and budgetary issues stemming from the passage in February 2012 of the Middle Class Tax Relief and Job Creation Act (for example, NTIA's partial suspension of grant funds, the FCC's termination of the State's conditional permission to use the 700 MHz public safety broadband spectrum, and FirstNet's uncertainty whether it will permit the State to use such spectrum), the direction and budget of the State's project is in flux. The State has proposed a revised project to FirstNet; FirstNet has stated that it will respond to the State's proposal in February 2013. The State intends that, with FirstNet's guidance, it will then submit to NTIA a revised project budget, including revised data in response to questions 15 and 16 below.
