The NJ BTOP project team continues negotiations with FirstNet on a potential project "pivot" as well as on the Spectrum Management Lease Agreement (SMLA) to allow use of the spectrum. Site identification resources continued in July and August; site identification activities were completed in August. In addition, an initial coverage design for the Route 21 corridor began and a job description for site assessors compiled. A Memorandum of Understanding (MOU) was drafted and sent to New Jersey Transit regarding the cash match for the project; negotiations were completed and the MOU was executed in July. The addendum to the NJ Transit MOA, striking the language regarding credits, was executed in September. Initial match installment of \$1.5 million was received in September, expending 27% in cash match allowing the project to come into match proportionality. The State filed for and received a short extension of the project until December 2013, as the project team continues to refine the project direction and prepare documentation for the full extension of the project until September 2015. The project team continued revisions to the project website and social media accounts.
