Please describe significant project accomplishments completed during this quarter (600 words or less).</p> <p>Merit has finalized all remaining easements for the project, including all hut easements. Ground preparation is underway at the hut sites. Merit has installed fiber in the Enventis build area under the St. Louis Bay in Duluth, MN as part of a joint build with Enventis, a BTOP recipient. Merit received their Ottawa National Forest and Hiawatha National Forest Permits. Merit also received all Department of Environmental Quality (DEQ) permits. Property appraisals were conducted for easements at the Bad River Tribe site. Merit connected Round 1 fiber (another BTOP-funded project) to Round 2 fiber at the Mackinaw Bridge. Merit completed procurement for Huts and selected a contractor to place the huts at their final destination. Merit connected Forest Park Schools (Community Anchor Institution) and began servicing them in May 2012. Merit has begun prep work for additional Community Anchor Institution sites. Merit has completed route planning engineering work for the project. Merit formed an environmental inspection team to review/finalize documentation and inspect sites pre/post construction to ensure environmental compliance during the build.</p>

2a.	Overall Project	24	Construction is in full swing for Round 2 across all segments. Merit anticipates having a significant amount of infrastructure installed over third and fourth quarter.
2b.	Environmental Assessment	100	Merit has exceeded our Environmental Assessment (EA) costs; we are currently at 556%. This is partially due to an underestimate based on RFP responses Merit had received in the past, and partially due to unexpected challenges in obtaining clearances for in Wisconsin and Minnesota. Since Merit will continue to incur costs related to the Environmental Assessment, Merit is considering a revision to the budget to incorporate the latest estimate of the Environmental Assessment cost at completion, which will be around 600%.

The length of time it has taken to get the Finding of No Significant Impact and get permits continues to impact the project, but Merit has increased the pace of construction to make up time during the second and third quarters in 2012. Merit anticipates having a large portion of infrastructure completed before the weather changes later this year. Merit is still working to obtain pole permits and complete make ready prior to construction. Merit is working to obtaining the remaining Right of Way permits and easements from the Bad River Indian Tribe, by making frequent visits with the tribe and working closely with the BIA. Merit is working to obtain outstanding Wisconsin environmental permits so work can be completed on this portion of the project.

Merit anticipates obtaining remaining environmental and wetlands permits at the Bad River Tribe site as well as easements along the route with the Tribe. Merit anticipates having telecom huts placed in Escanaba, Powers, and Iron Mountain. Merit is hoping to have a significant amount of new infrastructure installed along the Upper Peninsula. Merit anticipates completing and lighting fiber from Oscoda to Harrisville as well as Gaylord to Mackinaw City. Merit plans to have all CAI permits submitted by the end of the quarter as well as all sites in some phase of construction (excluding the sites pending NTIA approval for changes). Merit will focus on overall construction and environmental compliance over the next quarter.

- Network miles expected to be deployed next quarter: 250

- Merit anticipates connecting 20 CAI sites during the next quarter assuming the backbone fiber is in place for the sites to be connected to.

- Agreements in place with Broadband/Last mile providers: Merit currently has six agreements in place, and anticipates one additional. -ACD.net will be dropping off of the project during Q3 2012 and will be reflected as removed in the subsequent reports.
