

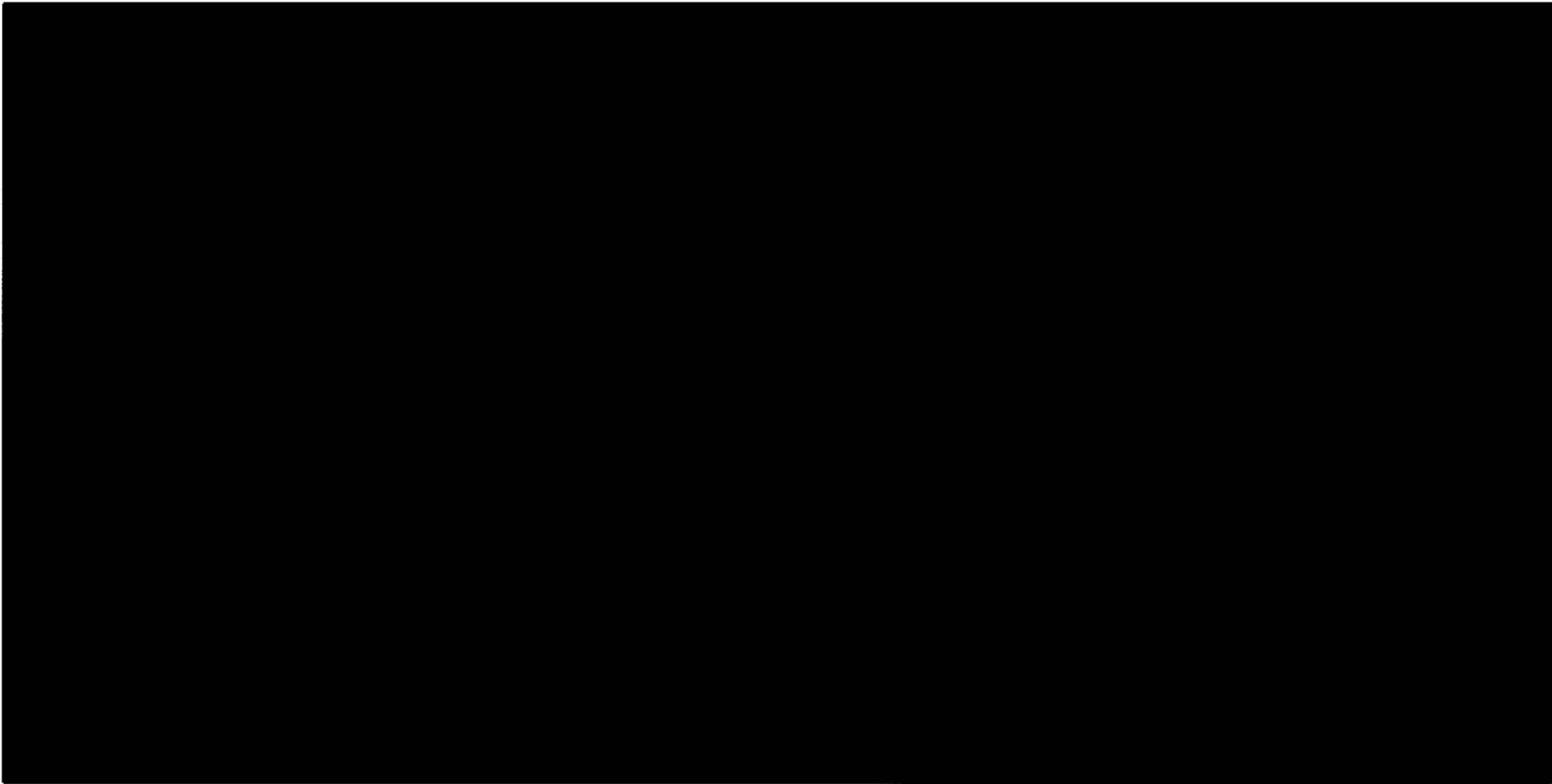

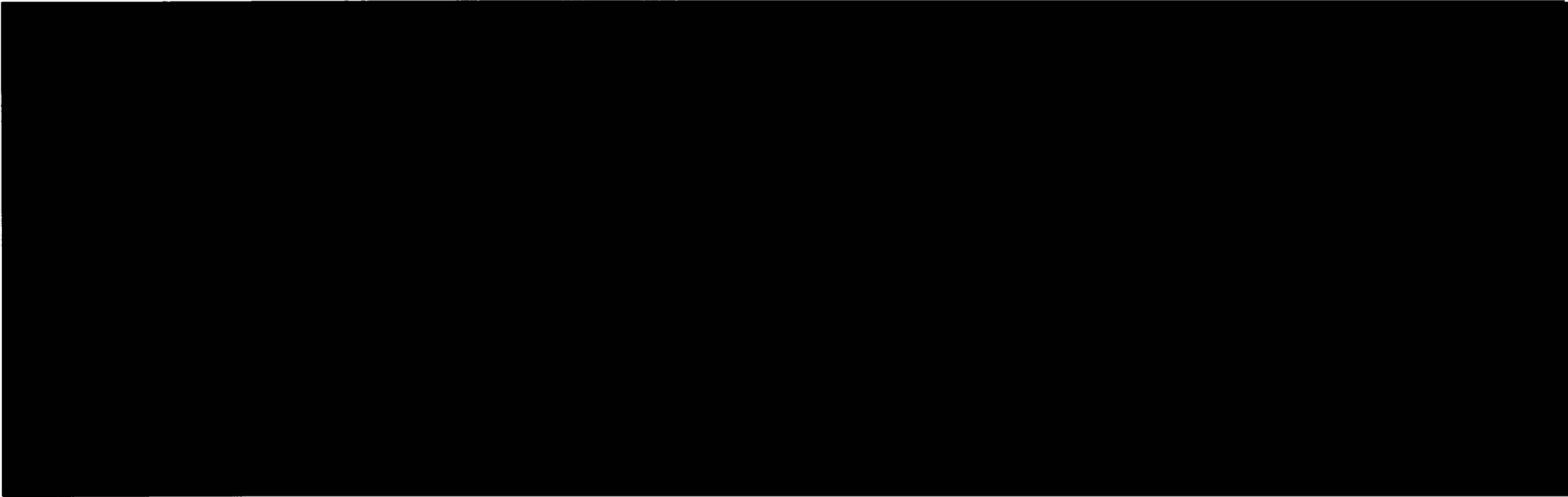

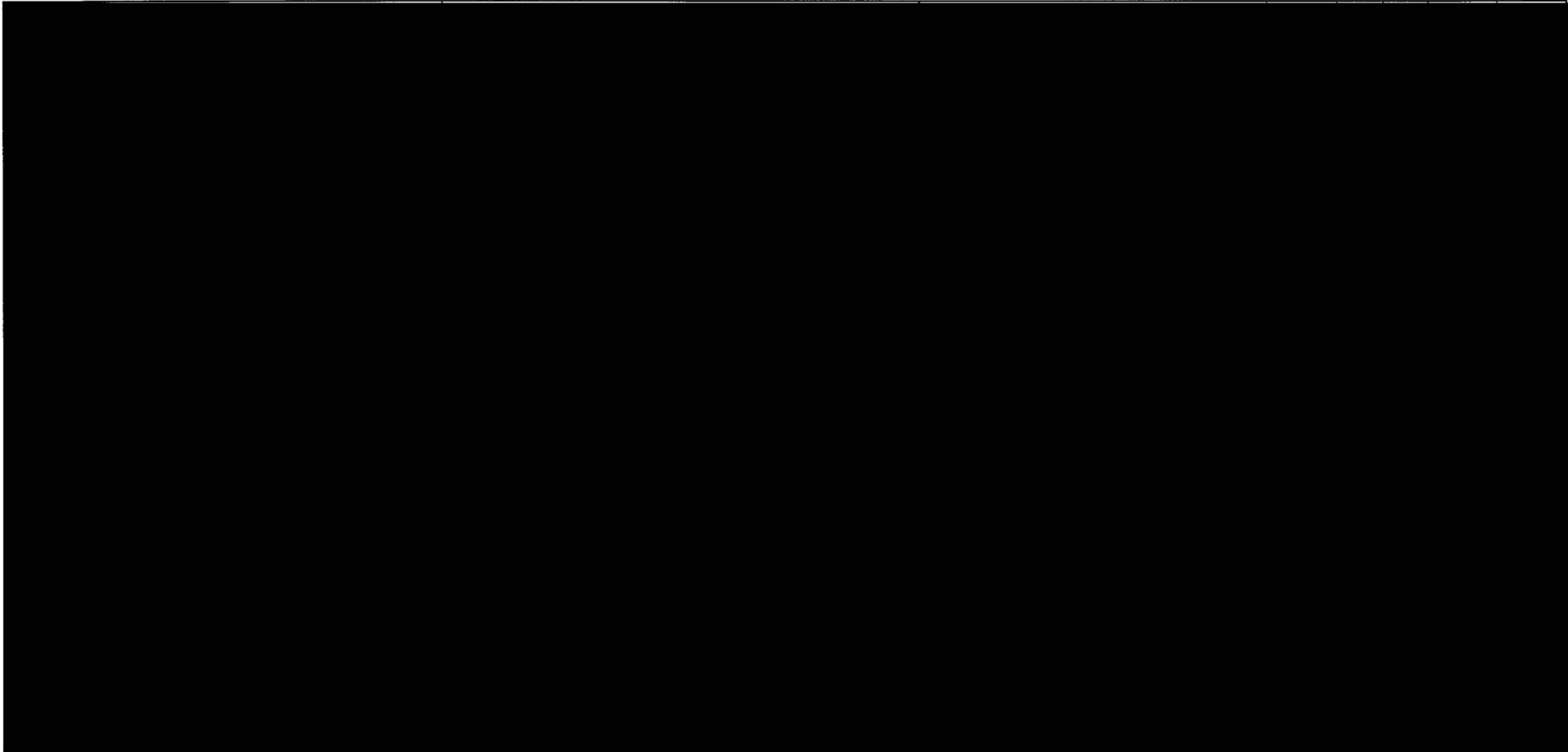
OKLAHOPMA BROADBAND MAPPING SUBCONTRACTOR RESOURCE COST BREAKDOWN BY TASK
