B. Executive Summary, Project Purpose and Benefits

Essay Question

10. Executive Summary of the proposed project:

This project will provide comprehensive broadband access, academic classes, and training for job-skills development, educational attainment, and business creation to underserved and vulnerable populations in eastern Burke County, an area experiencing high unemployment (over 14 percent), low educational attainment (32.4 percent of adults have not graduated from high school), and poor social service infrastructure. The collapse of manufacturing industries in this region has plunged into poverty many families who previously enjoyed middle-class standards of living. Among the consequences of reduced income are decreased mobility, lower capacity to acquire home computers, and the inability to pay for high-speed broadband services, which generally cost in the neighborhood of \$40 per month. The area has experienced large-scale factory closures and low educational attainment for more than a decade and is lacking in public facilities such as a JobLink Center or large public library for job-skill development and public broadband access.

Olive Hill Community Economic Development Corporation (CEDC) is a core member of a public-private partnership to redevelop the former Waldensian Mills textile plant in downtown Valdese, North Carolina. In addition to the public computer center, this 70,000-square-foot facility will house a business incubator, a teleconference center, a theater, educational programs, and low- and moderate-income apartments. The public computer center, with 45 workstations and SMART Board technology, will be a key component of the facility and will be a center of worker retraining, business development, educational certification, job seeking, and access to basic services, including tax preparation and bill paying. The center will be conveniently located within walking distance of many distressed neighborhoods and will allow educational programs

from the area community college to be offered in a welcoming environment that is viewed as part of the fabric of the local community.

The Waldensian Mills plant closed eight years ago and was a major employer for the region. The mill complex is in very good structural condition with an excellent roof, solid walls, and floors supported by steel I-beams. A \$400,000 grant to the Town of Valdese from the N.C. Rural Economic Development Center is being used to provide essential facility upgrades, including ADA access ramps, an elevator, bathrooms, and electrical refurbishments.

Partners include the applicant, the Town of Valdese, Western Piedmont Community College, and the local Employment Security Commission. The facility is being redeveloped by Airlie LLC, a civic-minded developer focusing on adaptive reuse of factories and small-town revitalization. State support and technical assistance is provided by the North Carolina Rural Economic Development Center, JobLink, and the area Workforce Development Board.

The target geographical area is eastern Burke County, with a year 2000 population of 38,500 over eight census tracts. For the county as a whole, median household income in 2000 was \$35,629, with per capita income of \$17,397 and a poverty rate of 10.7 percent. The unemployment rate in December 2009 stood at 14.2 percent, and 32.4 percent of the population had not earned a high school diploma.

The public computer center expects to serve 7,500 visits per year from 2,000 individuals from over 800 households. Olive Hill CEDC is an established community organization serving minority and other traditionally disadvantaged populations in Burke County and three adjacent counties. Our mission is "to positively impact the social, physical, educational, and economic environment of area communities." We help people increase their income and build assets with three main strategies: small-business ownership and job creation through business development and expansion, home ownership, and financial life skills. We have close relationships with funding organizations, including local and state foundations, state government grant-making entities, and federal programs targeting disadvantaged members of society. We have a full-time staff of five and one part-time administrative assistant. A seven-member board of directors from throughout the community brings a wide range of professional skills to guiding the organization in achieving its mission.

Jobs will be created and saved in two important ways. First, the center will support the creation and/or expansion of an estimated six businesses owned and operated by low-income and traditionally disadvantaged individuals, including a recycling and demolition company that is a subsidiary of the applicant. In the first 24 months of operation, approximately 30 to 40 new jobs are expected to be created through business incubation. Second, online skill-development and educational-certification programs will help prepare the general public for re-entering the

workforce, maintaining current jobs, or increasing income potential. Each year, more than 300 individuals using the center for broadband-accessed classes from Western Piedmont Community College will find new jobs or retain existing employment.

The total cost of the project for a three year period is \$576,742, with \$448,742 in BTOP grant funds, \$70,000 in local cash match, and \$58,000 in in-kind support. Project partners will achieve long-term operational sustainability by incorporating the public computer center into Olive Hill CEDC's core operating budget. Post-grant operational funding will come from block grant appropriations to Burke County from the North Carolina Golden LEAF Foundation (as one of the most economically deistressed counties in the state, Burke is eligible for \$2 million in grants every two years from Golden LEAF) and by establishing programs within the center that receive external financial support from local, state, and federal agencies.

11. Project purpose:

The Problem: Educational attainment, job-skill development, and competent general life management increasingly requires computer literacy and reliable access to broadband Internet service. In eastern Burke County, individuals and families facing economic hardship too often cannot afford to buy a computer and pay for broadband internet subscription service. Many do not understand how to use online services in a way that can improve their lives. This area of 38,500 people does not have a JobLink, large library, or other job-development resource center. Some have limited access to public transportation to attend community college or other job-skill trainings provided in Morganton, the county seat located approximately 12 miles away. The region, especially the town of Valdese, has suffered from the near-total collapse of the textile and furniture industries and has experienced mass layoffs and plant closures for a decade. Outside of low-wage retail service jobs, very few large scale employers have expanded or relocated to this community. The unemployment rate for Burke County in December 2009 stood at 14.2 percent. In 2000, 32.4 percent of the population had less than a high school diploma. Our Solution: With few large employers remaining in the area, Olive Hill Community Economic Development Corporation is implementing a strategy to increase job skills through small business incubation and start-up support, as well as targeted job-skill development and educational certification that will equip unemployed and disadvantaged individuals to successfully apply for jobs; join small growing businesses; or establish their own entrepreneurial endeavors. With the Town of Valdese, Western Piedmont Community College, and private developers, Olive Hill CEDC is participating in the rehabilitation of the former Waldensian Mills textile plant as a business-development incubator and center of community and small-business

activity. This 70,000-square-foot complex, located in downtown Valdese, is in very good structural condition with an excellent roof, solid walls, and floors supported by steel I-beams. The facility will open in 2010 and grow to house businesses, training and educational facilities, and low- to moderate-income apartments. The 3,200-square-foot public computer center will be an integral part of the overall strategy of empowering disadvantaged individuals with access to information and skills needed to survive, and thrive, in a challenging economic climate. This public computer center will house 45 computer workstations in two rooms with reception offices and additional storage space. Olive Hill CEDC will manage the center and provide public access during operating hours. Trained staff will offer specialized user training including online job searches, online bill paying, tax preparation, and after-school support for youth. Western Piedmont Community College will provide educational programming via online class offerings including GED certification, resume development and over 250 online classes via the N.C. Community College System's Ed2Go program. The Town of Valdese will provide guidance on fiscal oversight and funding development, as well as ongoing grantsmanship. The Burke County Employment Security Commission will provide online resources and scheduled site visits to meet the needs of the unemployed. The North Carolina Rural Economic Development Center is providing seed capital and technical assistance. Outreach to vulnerable populations will be accomplished through the applicant's existing networks with small businesses, referrals from the county's Employment Security Commission, and guidance from the area Workforce Development Board.

This community-based solution will provide broadband education, awareness, and access to an estimated 2,000 individuals per year from over 800 households, many of whom cannot afford, or otherwise do not recognize the value of, computers and subscription broadband access at home. It will foster the incubation of an estimated six new businesses employing over 30 people. The computer center will expand and enhance other services offered at the facility. Olive Hill CEDC, a minority-controlled community nonprofit, has deep roots within vulnerable populations and will succeed in bringing members of these populations to the center for development of job skills and web-based financial literacy. An outcome of this service will be to increase awareness of the importance of having computer skills and Internet access in the home. The project will advise users of affordable home solutions to internet-accessible computer systems, thereby increasing the number of subscribers and broadband usage in the service area.

Replicability: This strategy brings educational opportunity and business development support directly to the heart of a struggling community in a manner that will attract people who otherwise would not be able to access online services. Abandoned factories dot the landscape of small-town America. This project will provide a positive example of rehabilitation of "old economy"

infrastructure through partnerships between municipalities, nonprofits, local educational institutions, and state and federal support. The public computer center will increase broadband usage among the unemployed, the underemployed, and those with low-educational attainment. It will enhance the overall efforts of the applicant in its work to: (1) focus on growing jobs through local entrepreneurial activity relying primarily on homegrown entrepreneurs; (2) create a nurturing environment to support the development of untapped talent, skills, and local resources, and; (3) build an environment conducive to entrepreneurial activity, intellectual stimulation, openness to new ideas, access to institutions of higher education (Western Piedmont Community College), affordable transfer of information, and community support.

12. Recovery Act and Other Governmental Collaboration:

The applicant and the Town of Valdese are receiving technical support and seed capital from the North Carolina Rural Economic Development Center ("Rural Center"). The Rural Center awarded the Town a \$400,000 grant in 2008 for the rehabilitation and reuse of the Waldensian Mill, where this facility will be housed. These funds were appropriated to the Rural Center by the North Carolina State General Assembly, and a portion of the funds are being used as a match requirement for ADA access and other infrastructure improvements that will allow the public computer center to operate. A minimum of \$70,000 of Rural Center grant funds will be used to the direct benefit of the public computer center.

13. Technology Strategy:

The Center will acquire bandwidth from Charter Communications using coaxial cable with 20 Mbps download and 2 Mbps upload capacity, connected to two Cisco routers. Additional hardware will include a KVM Monitor Server, APC battery backup, and an IBM X3550 M2 file server. We will be using a LAN at each workstation. We do not anticipate public wireless at this time, but can allow users with personal laptops to access through LAN connections. There will be two primary computer rooms in the center, each measuring approximately 900 square feet. One room will be arranged with workstations lining the periphery of the room and facing walls for staff monitoring. This room will be dedicated to general public access. The other room will have workstations arranged in rows for formal classroom education or general public access, depending on scheduling. This room will be equipped with a "SMART Board" with peripherals to allow for online or digital presentations.

institutional IT support will be provided by IT staff at Western Piedmont Community College, with ongoing training for the center director and Olive Hill CEDC staff.

14. Public Availability:

This facility will be available to all members of the general public. If computer workstations are available at their time of arrival, no individual will be turned away from access. The facility will hold structured classes at certain times, largely at night. The center will have two primary computing rooms, allowing one room to be available to the general public during all hours of operation. An after-school program will allow students to do homework and develop computing skills in a room dedicated to their use during after-school hours. Online courses offered by

Western Piedmont Community College and other educational institutions will be available to users, and tuition structures will vary according to class and need. Tuition for online courses with an average six week duration range from \$65 to \$125. The center itself will not charge tuition for these courses, and the applicant will not materially gain from these charges. The applicant may develop structured courses that will require small fees to cover expenses not covered by grant funds, such as specialized software or non-staff instructors.

15. Restrictions on Center Use:

The center will not be restricted to defined purposes. However, users will not be allowed to view pornographic materials or other materials deemed to be disruptive to the computer center activities. A filter will be in operation for computers used during after-school programs for middle school and high school students.

16. Involvement of Community College:

Collaboration with Western Piedmont Community College will be an essential part of Center services. A major focus will be using the N.C. Community College System's Ed2Go curricula, which includes more than 250 online courses to increase employment skills, small-business management, and life-management skills. Courses in high demand include Accounting Fundamentals, Creating a Successful Business Plan, Starting Your Own Small Business, Computer Skills for the Workplace, Website Design, Buying and Selling on eBay, Internet Navigation, LSAT Preparation, individual courses for all Microsoft Suite Applications, Resume Writing, and QuickBooks for Contractors.

Each course consists of 12 lessons which are supplemented with interactive quizzes, assignments, tutorials, live instructor support, and online discussion areas. These courses can be accessed online at any time and take a recommended 6 weeks to complete. Online GED courses are offered on an ongoing basis through the community college and are free for those who are unemployed.

The college's Small Business Center staff will provide on-site seminars and courses as center staff identify demand. Courses are free and include How to Start a Business (12 hours), Writing a Business Plan (12 hours), eBay Basics (nine hours), Tax Implications of Starting a Business (two-hour seminar provided by the NC Dept of Revenue), and Start Your Own Business Workshops (12 hours).

21. Description of the involvement of the partners listed above in the project.

The Town of Valdese is a valued partner and is providing matching funds of a minimum of \$70,000 from a Rural Center grant to rehabilitate the former Waldensian Mills plant as a business and community center that will house the public computer center. Town Manager Jeff Morse is providing fiscal oversight support for all grant funds secured for the project. Mr. Morse has managed and participated in projects creating over 1,200 new jobs and over \$100 million in industrial investment to Valdese and Burke County.

Western Piedmont Community College is providing educational curricula and expert guidance on technology accessibility. WPCC will provide ongoing curricula development and training to center staff on technology maintenance and upgrade options. WPCC is providing assistance with identification of future funding partners. WPCC's Small Business Center will provide ongoing seminars on small-business development at the public computer center.

The Burke County Employment Security Commission has encouraged the applicant to develop a center in eastern Burke County where the unemployed and underemployed can access vital job-seeking support. The ESC will partner with the center to provide the full range of ESC web-based job-search tools and will provide scheduled site visits for one-on-one consultations. Airlie, LLC owns the Waldensian Mill complex and is responsible for physical site improvements and renovation. The principal partner is Mr. Clark Irwin, who has focused his efforts on adaptive reuse projects for small town revitalization, including an 80,000 square-foot mill complex in Morganton. He has served on the Main Street Advisory Board for 10 years. The N.C. Rural Center is a major source of financial and technical support for Olive Hill and has facilitated pre-development support for the public computer center. It has awarded \$65,000 to Olive Hill CEDC for community development and has awarded \$400,000 to the Town of

Olive Hill CEDC, a minority-controlled community nonprofit, has deep roots within vulnerable populations and will succeed in bringing low-income, unemployed, and youth participants to the center for development of job skills, web-based financial literacy, and enhanced learning. Outreach to vulnerable populations will be accomplished through the applicant's existing networks with small businesses, referrals from the county's Employment Security Commission, and guidance from the area Workforce Development Board. Trained staff will offer specialized user training including online job searches, online bill paying, tax preparation, and after-school support for youth. Western Piedmont Community College will provide educational programming via online class offerings including GED certification, resume development and over 250 online classes via the N.C. Community College System's Ed2Go program. The public computer center will have one room designated for after-school study hall for middle school and high school students. This is particularly needed for families in which the breadwinner (often a single mother) is working until well after students get home from school. The objective is to develop good study habits, enhanced computer skills, and a sense of how computers empower the educational experience.

Fifteen percent of computers will have ADA peripherals, including magnification screens, text-to-audio software, and wheelchair-accessible carrels. All computers will have instant messaging and other texting capacity. Braille keyboards will be available for adaptation to any workstation.

Outreach

32. Public Computing Centers Outreach

Olive Hill CEDC will collaborate with the Employment Security Commission, Western Piedmont Community College, area middle schools and high schools, public housing authorities, and our client businesses to identify individuals in need of ready access to broadband for economic empowerment. Computer center staff will make regular contact with these organizations to maintain steady recruitment and referrals. The Burke County ESC will recommend that clients from eastern Burke County contact or visit the public computer center for assistance in searching for jobs, writing resumes, and developing skills needed for reemployment. ESC staff also will visit the facility on a regularly scheduled basis to provide jobseeking consultations.

Olive Hill CEDC will have access to ESC systems to identify new job opportunities for clients. Western Piedmont Community College's Small Business Center director will work with business-incubator clients and also refer small businesses to the public computer center. The college's distance-learning program will refer students to the center who do not have reliable home access to broadband or who require an atmosphere more conducive to online education. Project leadership also will contact guidance counselors in eastern Burke County public schools to encourage students to come to the center after school to complete homework or learn computing skills. Students who drop out of high schools can be contacted about earning their

GEDs at the center. Housing authorities in Valdese and Morganton will be enlisted to inform residents of opportunities at the public computer center. Existing Olive Hill CEDC staff will provide a combined half-time-equivalent solely to outreach and recruitment. We have chosen this strategy because we believe partnerships with other support organizations are the best way to ensure full utilization of the public computer center.

Each station will be equipped with Dell computers, as recommended by our community college partner. Each station will have a flip-top work station with a wire management tray and a workstation carrel. Workstations will be equipped with 72" or 36" power table kits, infeed plugs, and armless chairs with casters. The center will have approximately 25 headsets for personal audio and VoIP compatibility. Mice will be wired (to prevent loss), with magnification capacity for the visually impaired. Six workstations (three in each room) will be wheelchair accessible. High speed black-and-white printers (we prefer HP) will be allocated to groups of five workstations and one color printer will be available in each room. The workstations will be networked to allow users access to any idle printers as needed.

Training and education will be divided among staff-led on-site instruction, online community college courses, and specialized on-site trainings working with the Small Business Center at Western Piedmont Community College. Center staff will provide computer-competency assessments for all users requesting training and education and will assist in identifying online courses or services to meet their needs. For example, users looking for jobs will be directed to job listings available online through the Employment Security Commission. For the novice user, staff will provide orientation training on how to turn on a computer, open software, access the internet, and browse. A major focus of the center will be utilizing the N.C. Community College System's Ed2Go curricula, which includes more than 250 online courses to increase employment skills, small-business management, and life-management skills. Courses in high demand will include Accounting Fundamentals, Administrative Assistant Fundamentals, Braille Transcription, Creating a Successful Business Plan, Starting Your Own Small Business, Using the Computer Classroom, Computer Skills for the Workplace, Database Development, Website Design, Buying and Selling on eBay, Certificate in End of Life Care, Personal Finance, GED Preparation, Internet Navigation, LSAT Preparation, individual courses for all Microsoft Suite Applications, Technical Writing, Veterinary Assistant, Supply Chain Management, Fundamentals of Supervision and Management, SAT and ACT Preparation, Professional Sales Skills, Resume Writing, OuickBooks for Contractors, and Photoshop Fundamentals. Each course consists of 12 lessons, each of which is supplemented with interactive quizzes, assignments, tutorials, live instructor support, and online discussion areas. All online computer classes qualify for 2.4 Teacher Renewal Credits for each class satisfactorily completed. These courses can be accessed online at any time and take a recommended 6 weeks to complete. Structured online community college occupational courses will be offered on an ala-carte basis. through ongoing assistance from local and state funding organizations. As one of the most economically distressed counties in the state, Burke County is eligible for \$2 million in grants every two years from the N.C. Golden LEAF Foundation, a quasi-public entity that administers funds from the 1998 Tobacco Master Settlement Agreement. Olive Hill CEDC, along with all key local partners, participates in a consensus process for allocation of these funds and will negotiate support for the center. We also have an ongoing relationship with the N.C. Rural Center and expect continued support from that institution. As the only facility for job-seeking and job-skills development in the eastern part of the county, the public computercenter will strengthen its partnership with the regional Workforce Development Board and establish ongoing programs with JobLink. These relationships will make the project eligible for core operating funds, including rent. Local foundations that we expect to support the center beyond the life of the federal grant include the Z. Smith Reynolds Foundation, the Mary Reynolds Babcock Foundation, and the Duke Endowment for the Rural Carolinas.

Annual core operating costs for the public computer center will be approximately \$85,000, including salaries, rent, subscriptions, and maintenance. Jobs will be created and saved in two important ways. First, the center will support the creation and/or expansion of an estimated six businesses owned and operated by low-income and traditionally disadvantaged individuals, including a recycling and demolition company that is a subsidiary of the applicant. The applicant's subsidiary, CHL-W LLC, is a minority owned materials reuse, recycling, and demolition firm. CHL-W LLC will work for the developer as a subcontractor for facility renovation. The project developer, Airlie LLC, has existing relationships with socially and economically disadvantaged subcontractors, including a plumbing business and a sheetrock business. We anticipate these subcontractors will be hired for facility upgrades.

PCC staffing, buildout, and direct support from PCC activities will create at least 6 jobs. In the first 24 months of operation, approximately 30 to 40 new jobs are expected to be created through business incubation. Second, online skill-development and educational-certification programs will help prepare the general public for re-entering the workforce, maintaining current jobs, or increasing income potential. Each year, more than 300 individuals using the center for broadband-accessed classes from Western Piedmont Community College will find new jobs or

Olive Hill CEDC has five full-time permanent staff: an executive director, director of operations, two community-development specialists, and an economic-development specialist. We also have a part-time administrative assistant. AmeriCorps Vista has appointed Olive Hill CEDC as a volunteer organization to provide outreach and education to link resources to other agencies and provide training, and to establish ongoing community programs.

Our organization is led by Ms. Beverly Carlton. Ms. Carlton has worked in the field of community-based nonprofit organizations since 1979, and has served as executive director for Olive Hill CEDC since its founding. She holds a B.A. in Business Administration from Lenoir Rhyne College and has completed trainings in housing development finance (NDC, 2000), community development administration (UNC-Chapel Hill, 2003), and rural economic development (N.C.
