Chronic disease rates, many of which are linked to poor health behaviors, are also high. BRFSS data indicates that 23% of Rabun Co.'s residents are obese and 6% have diabetes. Despite the poor health of this community, the availability of disease prevention/management support is limited. Project partners believe that a healthy workforce is an employable workforce, so health must also be addressed as a workforce issue.

Limited resources also exist among local law enforcement and firefighters to access critical training and to coordinate disaster and emergency responses. Often, these public responders are required to attend trainings that are up to 65 miles away, which translates to high travel costs and increased time responders spend "out of community." Just as a healthy workforce is a vital component of positive economic growth, so to is the community's public safety infrastructure, making this facet of the Technology Works! a critical one.

Specifically, the Rabun Co. Public Computing and Employment Center will be located in ground floor of Rabun Co. Health Dept. in Clayton, GA. By redeveloping a currently under-occupied county facility, the PCC will provide a one-stop resource to retrain and re-employ Rabun Co.'s workforce. PCC offerings will include a public computer lab, office space and consultation rooms for the GA Dept. of Labor, classroom facilities for NGTC, testing rooms for the Georgia Work Ready Assessment, interview rooms, and training facilities for public emergency responders. A health library staffed by volunteers, including physicians and nurses, will also be established.

Mountain Lakes will also host a PCC in its renovated wellness center. Located on Mountain Lakes' campus, this PCC will have the capacity for 147 individuals in an auditorium, and will offer both a small group learning center and 13 individual workstations. While health care education/workforce staff training will undoubtedly be the focus of the center, public safety trainings will also be offered.

Proposed solutions to these critical problems clearly addresses the BTOP statutory purpose focused on providing broadband education awareness, training, access, equipment and support to community anchor institutions, job-creating strategic facilitates, and vulnerable populations. Combined, the PCCs will provide 15,250 visits annually; given the fact that it is estimated that each person using the facilities will visit five times on average, an estimated 9,150 total users will be served during the three-year project period.

The Technology Works! management team is made up of Kim Ingram, CEO of Mountain Lakes and representative of the project's fiscal agent, Sean Brady, Director of the Rabun County Chamber of Commerce and the Development Authority of Rabun County, and Steve Dougherty, President, North Georgia Technical College. This team has worked together in one aspect or another for several years. In addition, the team has outreach into supporting organizations that will only serve to strengthen the project over time. Resumes for each clearly demonstrate educational, professional and project specific readiness.

In addition to demonstrating readiness from a project management perspective, Mountain Lakes, the lead applicant, and project partners also have the capacity and readiness to successfully carry out the proposed project from a logistical, partner and technological perspective. Mountain Lakes is committed to establishing the wellness center, and will soon begin completing the renovations necessary to do so. Given the fact that this process is underway at the time of BTOP application submission, Mountain Lakes leaders anticipate that construction will be complete just prior to the beginning of the grant funding period. Once a grant notification of award is received, , Mountain Lakes will be in the optimal phase of construction to install the requested equipment to establish the Mountain Lakes-based PCC. As such, Mountain Lakes is poised to initiate the action plan to achieve project objectives upon receipt of grant funds.

3 FTE jobs will be directly created as a result of the project. This total represents the project director and two facilitators that have been included in the project budget, and the federal funding request specifically; however, the project management team notes that, using the rule provided by the President's Council of Economic Advisors (\$92,000 of government spending creates one job-year), the project will create 12 additional jobs. The project management team also estimates that 100 jobs will be induced, as industry relocates to the area to capitalize upon a more highly trained workforce.

In order to effectively carry out project implementation plans, \$1,097,091 is requested in federal funding; an additional \$968,102 will be provided as in-kind/cash match contributions.

12. Recovery Act and Other Governmental Collaboration:

Technology Works!, if funded, would be the first successful effort by this partnership to benefit from the American Recovery and Reinvestment Act of 2009. We hope to use this application as a foundation for building out a super network of community-wide education, training and information sharing that will result in replication and expansion. At this time, existing community resources are being leveraged in support of the proposed project. Our application is supported by the North Georgia Network, a recipient of Round 1 BTOP funding.

In designing this project, the partners involved chose 3 critical issues to focus on: workforce training/economic development, health and public safety. These issues are priority concerns demonstrated by the number of community anchor organizations in support of this project. In addition, we are currently researching funding in the following areas:

- Dept. of Labor DOL provides a number of programs that support job training in specific high demand areas. These programs are being considered by the partnership and the community college as a means for providing specific certification and degree programs that will develop a highly skilled workforce.
- Dept. of Agriculture Mountain Lakes is looking at 2 major programs in this area that provide funds for the construction of critical care hospitals and the RUS DLT grant program. Adding to our capacity to care for community residents is critical and hospital construction funding is necessary in order to expand our capacity to provide essential healthcare services. The RUS DLT grant can serve to connect the delivery of healthcare and education in innovative ways that will increase and enhance essential services in our region.

- EHR the partnership will be looking at developing a system for the implementation of electronic health records. A plan and targeted funding resources will be ready by in the near future.
- Dept. of Education the local school district will join the partnership in exploring resources through the RUS DLT grant but also will look at Invest in Innovation, Title I, Enhancing Education Through Technology and IDEA in order to broaden their ability to provide services and information through broadband applications.

Projects that fit these programs are being researched. Much will depend on the community's ability to focus local resources on match as well as develop plans that can be implemented quickly and sustained long-term. The partnership anticipates seeking assistance in an estimated amount of \$3.5 million in 2010-11.

Rabun Co. is a small, rural community faced with a number of critical issues but we are developing a strong partnership that will work together to prioritize and address our needs. Lack of financial resources have hurt this community in the past but by coming together we hope to be able to leverage local funds and state and federal programs to ensure that we have a highly trained, healthy and safe community.

13. Technology Strategy:

The equipment chosen was done so after careful study and comparison. It is critical to this project that we design a model that delivers the services we need while providing the scalability needed to grow as we progress. We believe that the project as proposed will be more than substantially complete in the first 2 years, provide a robust system for delivering conferences, training, and workshops and is scalable providing us the option to grow as we drive broadband sustainability. Proposed equipment will provide interactive video conferencing in the auditorium located at Mountain Lakes Medical Center, conferencing capabilities at the PCC locations for small group work, wireless access at both sites and computers at the PCC sites. Infrastructure will be located at the Medical Center to insure the operation of the project.

Video Conferencing Bridge: Video calls will connect through an MCU. We chose an entry-sized, high-definition conferencing bridge. It offers a low-risk, cost-effective solution for HD multipoint video conferencing. It provides a seamless transition path to HD for connections with existing SD environments and has an option to upgrade the capacity when required.

bring compatible headsets for use as well. Each PCC will have Braille keyboards w/ USB connections as well as a Braille Printer. Video can be used for sign translation in most cases so that we can insure access for the hearing disabled. The portability of the computers will allow for individual learning as well as small group. The computers will be video conferencing enabled adding to the ability to communicate and learn using these broadband devices. Video will be delivered to the computers through a PC client and will have business quality video. This will also allow for meeting with people across the county for planning and implementation purposes as well as training and workshops.

Other peripheral equipment will include a printer and projector at each site. The project will consider requests for additional software and peripherals as requested by participants and partners.

Installation, technical training and 3 years of manufacturer warranty are included in the cost. The federal request for warranty is for 1 year and the participating partners will continue to fund maintenance on all equipment beginning in year two of the project and going forward.

Technology Works! PCCs will be established in key community anchor institutions, specifically within Mountain Lakes and the building occupied by the Rabun Co. Health Dept. facilities, that residents are accustomed to accessing. This positioning is particularly important given the fact that both organizations have a significant reach among low-income residents. This existing "relationship" that these organizations have with those that are most in need of services will allow for broad dissemination of PCC availability, and for tailoring of programs to meet the needs of those that are low-income/unemployed.

Technology Works! has also been designed to ensure availability for all populations, rather than a specific subset of the population. This availability is evidenced by the proposed provision of ESL courses that will meet the needs of Rabun Co.'s growing Latino population, the inclusion of specialized equipment that will remove barriers to PCC access among those with disabilities, and the proposed inclusion of a wide variety of services and educational programs.

PCC availability is also supported by proposed evening and weekend hours, which allows those with work schedules outside of the "typical" workweek to access services. These hours are

particularly important to those that may be employed but seeking credentials and/or licensure through North Georgia Technical College (NGTC) offerings, or those that wish to participate in health-related trainings outside of work hours.

The wide range of technology is also aimed at facilitating broad PCC access. The number of workstations has been strategically considered to ensure that capacity meets anticipated demand and the auditorium/small conference room settings will be established to meet the needs of those that wish to participate in group activities. The inclusion of video conferencing technology also facilitates access to a vast number of educational and professional opportunities that are simply not available in Rabun Co. Offering broadband access using individual, small group and large group activities insures that the project reaches a maximum number of citizens. Utilizing video expands opportunities for those not inclined to participate in some on-line learning – specifically, individuals with limited English and reading skills as well as some citizens with physical and mental disabilities. In short, this equipment ensures that the PCCs have global connectivity for all in need of access.

Technology Works! partners also realize that those with low incomes may find fees a barrier for participation. With this in mind, PCCs will charge rent to the GA Dept. of Labor and NGTC to offset ongoing expenses, and organizational participants (e.g. the local police dept) may be charged modest fees for PCC use. Individual participants will not be charged fees to use PCC workstations; however, all fees and tuition costs currently associated with educational course offerings will be assessed.

15. Restrictions on Center Use:

Technology Works! PCCs will not place any unnecessary restrictions on center usage. Rather, hours, locations and availability of facilitators and volunteers have all been planned in order to facilitate optimal access. Additionally, both PCCs will be open to the general public instead of restricting use to a specific subset, or subsets, of Rabun County's population.

While broad access to PCCs will be a high priority, reasonable restrictions will be placed on the use of PCC workstations themselves to ensure both equity and safety. For example, time limits may be placed on individual workstation use if demand exceeds capacity during peak hours and the no. of individuals that may participate in either small or large group settings may be limited due to either facility or training capacity.

As the applicant and fiscal agent, Mountain Lakes strongly believes that the involvement of the area's community college is a critical component of the project. As such, North Georgia Technical College (NGTC) has been included not only as a primary project partner, but NGTC representatives will also be included on the project team. NGTC staff will provide GED testing/preparation, Georgia Work Ready testing and ESL classes in the PCCs. Further, NGTC will use classroom teleconferencing equipment to connect with programs of study and instructors; these programs include accounting, automotive, business management, cosmetology, criminal justice, culinary arts, health sciences, emergency services, communications, and other skilled trades. At least 850 individuals are estimated to take advantage of the NGTC's offerings at Rabun Co. PCC locations.

The PCCs are uniquely positioned to leverage workforce needs and job skill training through the co-location with the newly staffed local Department of Labor office. Having this close association with NGTC will provide education/training relevant to current as well as future job skills needs of Rabun Co. The PCCs in Rabun Co. will also provide the college with greater exposure and should serve to increase enrollment at its current campuses.

A letter of support evidencing NGTC's commitment to the project has been included, as has a resume of the organization's president, who has agreed to serve on the project team.

African Americans: While African Americans make up just 1.7% of Rabun Co.'s population, the project management team recognizes that these individuals are often disproportionately affected by the current economic downturn. With this in mind, special efforts will be made to disseminate PCC availability among key institutions that serve African American clients.

English as a Second Language: North Georgia Technical College has committed to providing ESL classes at the Rabun County Public Computing and Employment Center, and an interpreter will be available at key times to assist with individual needs. Spanish language outreach/educational materials will also be offered.

Disabled: To accommodate those with disabilities, both PCCs will be handicapped accessible, and will include computer peripherals designed to meet the needs of those that are hearing/vision impaired. The addition of video conferencing can enable sign language interpretation services for the deaf.

Low-income: Because low-income adults often face barriers to participation in economic/education activities, all public outreach and class offerings will be designed with the needs of these individuals. This group, which includes a significant proportion of Rabun Co.'s residents (18.2% lives in poverty), will be provided with opportunities to advance educational attainment through skilled trade certificate programs, to receive health education that considers financial barriers to preventive approaches, and to access project materials that are designed to eliminate barriers associated with low literacy. To further support low-literacy learners (Rabun Co. has an illiteracy rate of approximately 14%), video conferencing will be offered to facilitate access to training. Literacy training will also be offered.

Unemployed: As a primary target group, a multitude of services will be provided to those that are unemployed through the inclusion of space in the Rabun Co. Public Computing and Employment Center for the GA Dept. of Labor, which will focus on employment training, resume building, job search skills and the like.

Youth and senior citizens will be targeted for health training. Given the national obesity crisis, workshops centered on nutrition and exercise will be offered. In addition, seniors face health issues related to diet/exercise; providing comprehensive health/wellness information to this group is essential.

30. Accessibility

Accessibility will be a central component of all Technology Works! implementation plans. To provide a welcoming environment to individuals with disabilities, both PCC locations will be handicapped accessible, and compliant with all Americans with Disabilities Act requirements. Further, the Technology Works! centers will incorporate video conferencing technology, which will allows for the provision of sign language and other services to assist the hearing impaired. This technology also accommodates those with varied learning styles, in that it effectively combines visual and auditory learning and real-time interactivity. Provisions are included to assist the visually impaired access the proposed services as well.

In addition to offering an environment and technology that promote accessibility, the PCCs' hours afford accessibility among those that work both day and evening shifts; free access to the centers also ensures that those with low-incomes can take advantage of PCC services without incurring financial hardship.

All project partners understand that accessibility is an essential component of the project and in our processes for reviewing project progress we will regularly examine and remedy barriers to access.

31. Other Languages

Because Rabun County is home to a rapidly growing population of Latino individuals, a deliberate focus will be placed on providing outreach and resource materials in Spanish. The project management team will also take advantage of existing key organizations that already serve Latino clients in order to disseminate messages regarding PCC availability and specific training offerings. Such organizations will include local churches, and health and human service organizations. Spanish language outreach messages will also be distributed at Mountain Lakes Medical Center locations, and at the public health department. Both are critical message dissemination locations given the fact that PCCs will be located within, or share, facilities.

Education and training will also be conducted in Spanish, as demand requires. Specifically, North Georgia Technical College has the capacity to offer English as a Second Language classes as necessary to accommodate needs.

Training and Education

34. Peripherals and equipment

Peripheral equipment to be located at each of the PCCs will include the following:

- 1 high speed, high volume printer, fax, scanner (all-in-one) at each PCC (total 2).
- 1 dual Braille printer at each center (total 2)
- 2 Braille Keyboards with USB connection at each center (total 4)
- 1 document camera at the auditorium for presentations
- 1 projector at each of the PCCs for workshops, training and presentations (total 2)

Peripheral equipment was chosen to enhance the learning environments at each of the PCCs and the auditorium site at Mountain Lakes. The availability of printers will allow clients to print necessary documents as they relate to training, job searches, etc. There will be a small charge for printing services in order to cover the cost of supplies and maintenance on the printers. Keyboards and printers for use by sight impaired clients will be available at no charge. A document camera for use in the auditorium located at the Medical Center will enhance presentations and workshops held there. Projectors will be available for presentation purposes at each of the PCCs for use in small groups and workshops and training.

Project partners will consider additional peripheral equipment based on client need and demand for services and will seek outside funding in order to upgrade, update and add peripherals as needed.

All workstations in the Technology Works! PCCs will offer Microsoft Office Pro software, and have Internet browsers. Workstations will also have a PC client-based video system to provide business quality video connectivity. Video equipment will have Natural Presenter Packages to allow for duo video and collaboration.

While no specialized software is required at this point, such software may be added as the project moves forward and demand requires it. Based on this, a regular review of software needs will be a part of the review and evaluation process.

36. Training and education programs

Given the focus of Technology Works! on providing training and education specific to the needs of the Rabun Co. workforce, several training and programs will be offered:

For those individuals in need of basic computer skills training, classes will be offered specific to the use of the Internet itself as a resource for information. These classes will focus on empowering PCC users to use the Internet as a research and reference tool, in addition to a mechanism for participating in the Internet-based economy and culture (e.g. through social media such as Facebook). These courses, which will vary from four to eight hours in length, will introduce PCC users to their computers, managing email, and assessing Internet-based information (i.e. assessing website content credibility). Additionally, classes specific to typical software program use, including Microsoft Word and Excel use, will also be offered. For all of these courses, paid facilitators will use established curricula. Web site reference sheets that include basic steps for accessing a web site, web-based searching will also be posted at all PCC workstations. Additionally, an information assessment, likely a brief set of questions a web site user can ask to assess credibility, will also be posted for reference. Certificates of completion will be offered to participants.

Rabun County Public Computing and Employment Center

In addition to offering basic computer skills classes, the Rabun Co. Public Computing and Employment Center will also house a local office of the Georgia Department of Labor. At the Center, the Georgia Department of Labor staff would process unemployment applications, consult on an individual basis with job seekers, maintain a database of available positions in Rabun Co., and provide prospective employee screening and referrals to employers among many other services.

North Georgia Technical College staff will provide GED testing and preparation, Georgia Work Ready testing, English as a Second Language classes, and use classroom teleconferencing equipment to connect with its programs of study and instructors that include accounting, automotive, business management, cosmetology, criminal justice, culinary arts, health sciences, emergency services, photography, communications, and a wide variety of other skilled trades. All of these programs, the majority of which are 3 credit courses, will adhere to existing curricula and achievement standards; successful completion by participants will result in a certificate or diploma, as defined by the specific course.

Interview rooms and public training facilities will also be available at this center, in addition to a health library. Mountain Lakes Medical Center Auxiliary volunteers, and appointments will staff the health library, with retired physicians and nurses available to assist PCC users with individualized searching on health conditions and health-related resources by appointment. This component of the Rabun Co. Public Computing and Employment Center is particularly important given the fact that the center will be positioned on the ground floor of the Rabun Co. Health Dept., which provides health care-related services to indigent populations.

Rabun County Public Computing, Health and Training Resource Center On-site facilitators will teach classes related to preventive health care at this PCC, and provide the public with access to health care lectures, interactive education through an auditorium, a conference room and individual workstations. Health professionals will also offer special topic educational offerings focused on chronic disease management and disease prevention.

In addition to onsite facilitators, the following specific experts/expert organizations will serve as instructors via video conferencing technology:

- The GA Public Safety Training Center, the US Dept. of Homeland Security, and Federal Emergency Management Agency, the US Forestry Service and Sheriff's Office Training Officers in the region will provide instruction specific to law enforcement and emergency preparedness and response.
- Medical faculty members at Emory University, with which Mountain Lakes Medical Center has affiliations with, have agreed to provide CME to physicians with privileges at Mountain Lakes. Additional medical training will be provided as needed.
- Chamber of Commerce and economic development-related trainings will be accessed via the GA Dept. of Economic Development and the GA Dept. of Labor.

In addition, the PCCs will provide local organizations the opportunity to participate in state/national meetings and other "learning exchanges" that would otherwise be inaccessible. This participation is critical in learning best practices, elevating the local workforce to meet or exceed national norms, and to offer a less measurable, but just as critical sense of connectedness to those with similar work/challenges.

At both centers, Technology Works! will utilize both Technology Works!-dedicated staff, North Georgia Technical College faculty and experts from throughout the state/nation to ensure that all trainings and educational offerings are relevant to the specific needs of the Technology Works!'s

42. Sustainability:

Mountain Lakes, the Development Authority of Rabun Co., North Georgia Technical College (NGTC) and all project partners/supporters are committed to financially sustaining the project beyond the funding period. While the substantial initial investment costs associated with establishing the project prohibit implementation without of federal funds, modest ongoing costs associated with operations once established will be largely incorporated into the organizations' annual budgets. Specific commitments are:

- o Project coordinator/ facilitator salaries will be assumed by Mountain Lakes and the Development Authority; these salaries will be offset by rental fees charged to the GA Dept. of Labor and NGTC for use of PCC space beyond the funding period
- o Rabun Co. government support will continue in regard to the in-kind space, and site-specific support (e.g. security/lawn maintenance) to the Rabun Co. Public Computing and Employment Center,
- o Support for the technical components of the project will be provided by Mountain Lakes' information systems specialists.
- o Funding, both internal and external, will be sought to secure additional equipment as the project expands. Both Mountain Lakes and the Development Authority have the capacity to, and a strong track record for, securing third-party funding.
- o The project is expected to attract new students to NGTC which will support their continued partnership, drive usage and provide a platform for expanding the project and its benefits.

Because many of Technology Works!'s partners are likely to save travel dollars as a result of the project, Mountain Lakes believes that creating a formal system for organizational users of the PCCs to contribute to their operations is reasonable. Specifically, a fee structure will be established to support the ongoing use of the Centers once funding concludes, with the number of projected users and the hours of proposed usage taken into consideration as fees are assessed. Once a fee structure is in place, both project partners and businesses/organizations that have not previously participated in the project will be invited to do so, as capacity allows. It must be noted, however, that individuals will not be charged for PCC use to avoid the establishment of financial barriers to access – only groups such as the local chamber, or law enforcement agencies that represent formal organizations would be asked to pay modest fees.

This approach allows Mountain Lakes and its partners to maximize PCC equipment while incurring only reasonable local travel costs.

Equipment - The Technology Works! partner members actively engage in competitive bidding for services and equipment as a routine business practice, and as is the case with renovation -related costs, will engage in such bidding specific to securing Technology Works! non-construction associated equipment and services. Further, state and government contracting will be utilized in regard to Technology Works!-related purchases, as appropriate.

Educational materials and training/office supplies – The small amounts requested for the project will provide adequate resources for the trainings/educational offerings of Technology Works!, but copies and duplication of materials will ensure that training/educational materials are not purchased unnecessarily.

Contractual – Budgeted dollars for contractual items are based on previous experience and competitive bidding practices, and represents essential activities of the project; service agreements and the like are essential, particularly during the initial phases of the project, to ensure optimal use of equipment.

Given existing economic conditions, Technology Works! could not be implemented but for federal funding support. Each of the key partner organizations face limited budgets, decreasing resources and an increasing requirement to "do more with less."

As with Critical Access Hospitals around the nation, Mountain Lakes has experienced decreases in reimbursement while simultaneously being called upon to provide unprecedented levels of charity care. As unemployment rates increase, the number of uninsured individuals also increases, leaving families dependent upon charity care to maintain or achieve good health. Given this, Mountain Lakes must deploy every strategy available to simply maintain the provision of high quality care for which it is known. The organization must also approach emerging needs and opportunities with both flexibility and creativity. Technology Works! represents such an approach, in that planned renovation of the wellness center, and availability of existing staff and resources (e.g. outreach efforts that are already occurring) will be leveraged. In turn, this leverage allows Mountain Lakes to contribute the project's success through the dedication of in-kind resources, while relying on federal funds to support the significant upfront costs associated with establishing PCCs.

Demonstration of need

Similarly, the Development Authority of Rabun Co. has limited resources and budget dollars from which to draw upon to establish PCC access; however, with the injection of federal funding to support equipment purchases and the like, the Development Authority can reasonably commit to providing the in-kind contributions required to support PCC operations both during and after the funding period.

As with other project partners, North Georgia Technical College has faced significant budget limitations during the past several years. Given these financial constraints, NGTC does not have the ability to establish new distance education sites due to high upfront costs of securing equipment, despite obvious benefits. Should federal funding

be provided to support equipment procurement, NGTC would have the ability to provide distance education opportunities to those in Rabun Co. with minimal ongoing costs. These costs will be minimized largely as a result of the use of video conferencing technology, which will allow instructors to avoid travel to remote locations and to be "present" in multiple locations simultaneously. The establishment of distance education capabilities in Rabun Co. will also positively contribute to student enrollment, which will further sustain the project.

The State of Georgia is faced with cutting an additional \$2 billion from its budget this year and those cuts will reach deep into project participants as well as restrict essential services to the community members. High unemployment, a lack of health/wellness services and persistent poverty in the area creates not just the need for federal assistance but the need for this project.

In addition to demonstrating readiness from a project management perspective, Mountain Lakes, the lead applicant, and project partners also have the capacity and readiness to successfully carry out the proposed project from a logistical, partner and technological perspective. Mountain Lakes is committed to establishing the wellness center, and will soon begin completing the renovations necessary to do so. Given the fact that this process is underway at the time of BTOP application submission, Mountain Lakes leaders anticipate that construction will be complete just prior to the beginning of the grant funding period. Once a grant notification of award is received, , Mountain Lakes will be in the optimal phase of construction to install the requested equipment to establish the Mountain Lakes-based PCC. As such, Mountain Lakes is poised to initiate the action plan to achieve project objectives upon receipt of grant funds.

All project partners are also ready to implement the project plan respective to their individual organizations. 

The Rabun County Board of Commissioners supports Rabun County's "Technology Works!" grant application and has the intent to provide the space needed to create the Public Computing and Employment Center. Approximately \$2 million in funds are set aside to renovate this facility and could be made available for this project. This facility would be located in the existing Rabun County Public Health Department building in Clayton, Georgia and adequate space is available there to accommodate all proposed activities.

Our unemployment rate in Rabun County is high, at 13.1% in January 2010. We currently do not have a full-time Georgia Department of Labor office in our community to assist our residents in filing for unemployment or applying for new jobs. We also do not have adequate access to workforce retraining opportunities through primary educational providers such as North Georgia Technical College. Access to the computers and technologies needed in today's job search is also very limited in Rabun County.

Through the Technology Works! Initiative, Rabun County has a unique opportunity to create a centrally-located facility that can meet the technology and workforce development needs of our rural community. It will house new full-time offices for the Georgia Department of Labor, North Georgia Technical College, and a public computer lab. There is currently no such facility in Rabun County to meet the critical needs of our unemployed and underemployed workforce.



The Development Authority of Rabun County is proud to be a partner in the Technology Works! initiative with Professional Resources Management and will help operate the Public Computing and Employment Center (Center) located in Clayton, Georgia. This Center will create new economic opportunities in direct support of the Authority's mission by providing free access to computing technologies, creating a new Georgia Department of Labor office in Rabun County, and providing greatly expanded classroom facilities for North Georgia Technical College to enable a workforce development and retraining program. The Center will also create 1 new full-time job and assist in the hiring and retraining of countless other job seekers.

Unemployment is high in Rabun County, at 11.8% in December 2009. The closest Georgia Department of Labor office is in Cornelia, Georgia at a distance of over 30 miles from Clayton. Gentlemen:

I am writing in support of the BTOP grant request by Mountain Lakes Medical Center and the Rabun County Economic Development Authority in Rabun County, Georgia. As the Public Health Director for Rabun County, I am well aware of the health challenges faced by the populace and applaud any initiative to provide enhanced health education. The health library envisioned in the project could conceivably be located within the same building as the Health Department and would allow Public Health staff to utilize it to provide a level of health education not possible with current funding constraints. In any given year the Health Department provides direct services to about 23% of the county's population, and over 5 years about 58% of the population has received direct services. Of course 100% of the population is benefited by the full complement of services provided to the community.

Videoconferencing equipment at the hospital could potentially help fill some of the gaps that we have in physician coverage. The rural mountainous location of Rabun County, coupled with the poor socioeconomic status compared to the State average (median household income \$37,119 vs. \$50,834 for Georgia) makes it difficult to recruit and retain physicians. In Rabun County there are 897 persons per physician compared to the State average of 494. The top causes of death (heart disease, stroke, lung cancer, kidney disease, and pneumonia) are all significantly more frequent than the Georgia average. Videoconferencing could assist in education and training of existing medical staff – both in the Health Department and the hospital – and if it supported telemedicine could also provide some specialty consultation not currently available.






