This quarter we were able to seat 180 students in our Basic Computer Literacy Training. Classes are held during the week day, evening and weekend to accommodate a variety of schedules. Students must complete this basic class in order to receive the laptop and broadband connection. We were able to connect 107 total new subscribers who completed this class during the quarter. The remaining 73 were either still finishing the basic class or scheduled for installation after the quarter end.

In our Key Indicators Report, we had projected 146 total new subscribers by the end of this quarter, we have achieved 107. The variance is due to a delay with one shipment of computers. The vendor quoted ship date was three weeks earlier than when the computers actually arrived. If not for that, we would have been right on target.

A computer vendor was not able to meet the quoted ship date, therefor we exhausted our inventory which required us to re-schedule and push-out our installation dates to our new subscribers. The participants were very understanding, however this delay caused the failure of reaching our quarterly goal.

We have modified our procurement procedure to order computers with a greater lead time.

We were not able to meet this quarters objective because of a shipment of laptop computers that arrived three weeks later than promised. This affected approximately 40 participants who we could assign a laptop.
