The University of Hawaii Systems Recovery Act project Ke Ala Ike: Connecting Hawaii's Community Colleges, Universities, Schools and Libraries is requesting one of their partners mentioned in the original application on pages 15 and 17 be granted a sub award to transfer to their strategic business partners the Hawaii Department of Education (HDOE) and the Hawaii State Public Library Systems (HSPLS) equipment provided for HDOE and HSPLS sites specified in the award.
