Dear Administrator Strickling:

The Commonwealth of Virginia has demonstrated a strong commitment to invest in affordable broadband services and applications. The American Recovery and Reinvestment Act (ARRA) funding provides the opportunity for outstanding projects to obtain the funding and support necessary to provide services and opportunities to those in unserved/underserved areas and we are grateful to have the opportunity to participate in these programs.

In Round Two, the Commonwealth saw a dramatic decrease in the number of projects submitted for consideration – a total of 45 projects compared to the 137 submitted for Round One. Of these 45, there are a mere 24 projects (across all categories) submitted "by Virginia entities, for Virginia Citizens" – and a number of these are resubmissions (at NTIA's urging) from Round One.

Upon review, we believe that all 24 proposals (spreadsheet attached), which span all categories – Comprehensive Community Infrastructure (CCI), Public Computing Centers (PCC), and Sustainable Broadband Demand (SBD) – are worthy of funding as each offers a unique opportunity for economic/social opportunities and connectivity options. As such, we believe that each is worthy of full funding by NTIA and respectfully request that you consider our proposal accordingly.
