She was active in the Menominee Restoration movement serving as Ada Deer's assistant in Washington, D.C. and at home.

For the past 16 years Dr. Fowler has served the Menominee Indian Tribe of Wisconsin as the founding President of the College of Menominee Nation. In 1999 she was appointed by President Clinton to the President's Board of Advisors on Tribal Colleges and Universities and reappointed to that Board in 2006 by President George W. Bush. She has served on the Board of trustees for HLC, and she is currently a Board member of the American Indian College Fund and the American Indian Higher Education Consortium.

ORGANIZATIONAL CHART

A summarized organizational chart has been developed to identify the project within College of Menominee Nation's (CMN) organizational structure. The project will have two project directors. The first is the Vice President of Planning and Operations. He is listed as the main project director during the construction phases of the project. He directly supervises the Facilities Director, who coordinates CMN's construction projects. He typically serves as project director on most CMN construction projects and sits on CMN's senior management team. His direct supervisor is the President of CMN. He will continue to provide oversight throughout the project as he oversees the Director of Informational Technology (IT). Two new technology coordinators will be hired to provide critically needed technology support in this exceptional technological facility. These coordinators will be directly supervised by the IT director. The second project director is the Dean of Community Programs. He is directly supervised by the Vice President of Academic Affairs, who sits on CMN's senior management team. The Dean of Community Programs will have main oversight of the facility as its purpose and intent is to provide public access to broadband technology. He will oversee the Community Technology Center Director who will ensure the center's main focus remains on serving the community, coordinating activities, and providing community education and training opportunities. The Center Director will oversee the last new position, the Community Technology Instructor who will provide technology-based community trainings and workshops. Lastly the Dean of Technical Education will oversee staff, the skills lab and technical training activities taking place within the technology center.
