Project Indicators (This Quarter)

1. Please describe significant project accomplishments completed during this quarter (600 words or less).

OpenCape reached major milestones in the fourth quarter.

OpenCape awarded an Auditing Services Contract to O'Connor and Drew P.C. and began providing necessary documentation for A133 audit after the end of the fiscal year.

OpenCape received a Finding of No Significant Impact (FONSI) on environmental and cultural resources from construction of the OpenCape system from the NTIA under the National Environmental Policy Act (NEPA). The release of a FONSI allows OpenCape to move forward with its project and eliminates the need for a full Environmental Impact Statement.

OpenCape became a Common Local Exchange Carrier (CLEC) in order to gain access to Incumbent Local Exchange Carrier (ILEC) Central Offices. This is an essential element of OpenCape's strategy to own all underlying rights associated with the OpenCape system.

OpenCape awarded a contract for the Field Survey, Licensing and Permitting, and Engineering of the network outside plant (OSP) to UC/Synergetic of Mansfield, MA. UC/Synergetic immediately began surveying the the entire fiber optic route to assess in very fine detail the telephone poles, bridge crossings, and other infrastructure that will receive the OpenCape fiber optics. They began managing the process of preparing Verizon, NSTAR, and National Grid telephone poles and conduit to receive the OpenCape fiber while simultaneously engineering the detailed plans needed by the contractor OpenCape will select to build the network.

OpenCape issued in early October an RFP for the Network Design and Build, and the Network Operation and selected a successful respondent in November, 2010. Contract negotiations with the successful respondent are underway in the fourth quarter and are expected to conclude in January, 2010. This contract will represent the largest single contract award by OpenCape on the order of \$23-\$26 million.

OpenCape concluded its contract with the Commonwealth of Massachusetts to begin receiving its \$5 million match component.

OpenCape was the successful respondent to an RFP issued by Barnstable County to secure a lease for the County's public safety building. Lease negotiations are underway. When in receipt of the lease OpenCape will issue an RFP to renovate the building as the OpenCape Regional Collocation Center.

OpenCape continued its normal outreach to stake holders and community anchor institutions to include meetings with the FCC's Wireline Competition Bureau, Senator John Kerry's staff, the Hyannis Rotary Club, the International Brotherhood of Electrical Workers local 103, public school districts, and New England recipients of BTOP grants.

OpenCape held meetings with OSHEAN, a round 2 BTOP recipient, to jointly develop a solution to an eight mile overlap of fiber in the New Bedford, MA area.

OpenCape held meetings with the Barnstable County Regional Emergency Preparedness Committee 700Mhz Sub-Committee. The Committee is made up of local police and fire chiefs, and other emergency services leaders. OpenCape has funding within its grant for 700Mhz radios. The Committee is developing the necessary organization and strategy to acquire a 700Mhz waiver from the FCC, along with other issues, such as acquiring a 700Mhz core and mobile equipment.

OpenCape began the process of formalizing agreements with water district and other tower owners for placement of radio and antenna equipment associated with its public safety microwave overlay.

OpenCape continues to reach out to the Army Corps of Engineers to begin the process of permitting its directional bore under the Cape Cod Canal.

OpenCape began negotiating modifications of utility pole and conduit Master Agreements with regional pole owners. OpenCape will require at least seven such agreements with Verizon, NSTAR and NationalGrid. Simultaneously, OpenCape has negotiated with pole owners the most expeditious manner to process license applications and move make ready work forward.

3. To the extent not covered above, please describe any challenges or issues faced during this past quarter in achieving planned progress against the project milestones listed above. In particular, please identify any areas or issues where technical assistance from the BTOP program may be useful (600 words or less).

OpenCape remains behind its Baseline Projection of 16% for this quarter at approximately 10% in Overall Project progress. In addition, OpenCape's Federal expenditures are less than 3% of total federal budget at this time; however, the pace of progress increased significantly in the 4th Quarter as anticipated and projected.

OpenCape lags its Baseline Projection and federal expenditure pace for several reasons: 1) OpenCape pursued its grant with a construction contractor as a partner. After consultation with legal experts and the NTIA, OpenCape concluded that federal procurement regulations would not permit it to conclude a contract with this partner. Rather, OpenCape had to issue new RFPs for all aspects of construction of the network; 2) the process of obtaining a Finding of No Significant Impact was far longer than anticipated; 3) the process of negotiating the many legal contracts associated with the project has been far longer than anticipated; 4) though OpenCape has a partnership with Barnstable County to renovate the regional collocation center, a determination was made that the County must go through a lengthy RFP process under Chapter 30 of the Massachusetts General Laws; and 5) the process of negotiating Master Agreements with utility pole and conduit owners was far longer than anticipated.

OpenCape has successfully adjusted to items 1 through 5 in the previous paragraph and transitioned in a manner that will permit it to increase pace. Rather than moving forward with a single vendor selected through a pre-grant RFI process for the design, build and operation of the entire OpenCape system, a decision was made to break up the project into several logical RFPs. This has allowed OpenCape to award a contract for field survey, licensing and permitting, and engineering while it goes through the lengthy process of negotiating a design, build and operate contract with another vendor.

OpenCape has made the adjustment and is moving forward at a pace that will ensure on-time completion.

OpenCape will license the Operator to operate sixty percent (60%) of the total fiber optic strands (User Fibers) in both dark and lit services to fulfill the obligations of the grant award.

OpenCape's Field Survey, Licensing and Permitting, and Engineering contractor, UC/Synergetic, will complete all field survey and make significant headway in license applications for pole and conduit access. They will coordinate with OpenCape's environmental engineering contractor, Horsley Witten, and the Design, Build, and Operate contractor on the further refinement of the path and begin the engineering of the fiber plant.

OpenCape will have completed a contract with its Network Design and Build, and Network Operation contractor. The contractor will finalize all engineering and ramp up for construction to begin in Y1Q2.

OpenCape will have received a lease from Barnstable County to the Public Safety Building and will issue an RFP for its renovation.

OpenCape will continue its normal outreach to stake holders and community anchor institutions to include the planning of a regional summit on broadband.

OpenCape will resolve the overlap with OSHEAN, a round 2 BTOP recipient, along an eight mile overlap of fiber in the New Bedford, MA area.

OpenCape will work with the Barnstable County Regional Emergency Preparedness Committee 700Mhz Sub-Committee further progress the issue of organization and strategy to acquire a 700Mhz waiver from the FCC and acquiring a 700Mhz core.

Y1Q4 progress has been very good. OpenCape anticipates forward progress to continue at this pace, but is always concerned about obstacles such as the failure to obtain Master Agreements with utilities, lack of capacity within the utilities to process license applications or perform make ready work at a pace that will ensure the on-time completion of the project. Thus far, the utilities are working cooperatively to try and ensure their most rapid response.

The permitting of the Cape Cod Canal directional bore with the Army Corps of Engineers is not progressing at a pace acceptable to OpenCape. We have ramped up our efforts in this regard to move this important element forward faster.
