The draft Environmental Assessment was submitted to NTIA on December 16th, ahead of required date of January 3rd. Permitting is coming along well; we have received a Nationwide permit #12 from the Corp of Engineers for crossing the Wetlands, WYDOT has reviewed our permit documents and is processing them for January issue; Teton County is prepared to issue the permit for the limited areas of their jurisdiction that we cross; the US Forest Service and Grand Teton National Park Service will issue permits upon completion of the EA document. Finally, we are in the final stages of entering into a Franchise Agreement with the Town of Jackson, WY. Engineering design and construction documents are approximately 60% complete, including the RUS contract documents and design drawings. An informal pre-bid meeting for potential contractors was held at the Jackson, WY, Town Hall on November 9th 2010. Recipient is still adhering to reporting deadlines.
