AVFN was notified of Grant Award on August 18<sup>th</sup>. Due to the considerable time lapse between the application's inception and Grant Award every facet of the application and partnership required review and legal consultation to insure total understanding of expectations and clarification of grant requirements by NTIA. AVFN asked for and was granted a 2 week extension for Grant Acceptance in mid-September. On September 30<sup>th</sup> (the last day of the Q3 reporting period) AVFN formally accepted the Grant. However, we do not anticipate any delays or challenges to the overall project plan as a result of the time lapse in award acceptance.

AVFN anticipated acceptance of the grant and during the pre-acceptance period, AVFN initiated post-acceptance planning activities for the Grant including staffing and internal structure planning. AVFN prepared an RFP for Environmental Assessment and immediately upon Grant Acceptance released the required advertisement. Numerous meetings and phone calls were initiated to begin the process of procuring right of way for the project. A significant portion (approximately 30%) of the proposed fiber construction route is along Norfolk Southern Railways existing track system and requires coordination and approval from Norfolk Southern. AVFN also met with Alabama and Georgia Public Partners during the pre-acceptance period to apprise them of our award status and provide project updates. Since Grant acceptance was not until the end of the quarterly reporting period AVFN was excluded from hitting any of the key milestone categories. AVFN has the advantage of extensive experience in fiber construction, knowledge of the geographic area and the unique capability to ramp up quickly in Q4 as the result of the preliminary work accomplished during the pre-acceptance period.

- Review of existing Franchise Agreements with municipalities and counties and completion of additional agreements as necessary and required.
- Completion of all other licensing and permit requirements for first phase construction
- Land and structure acquisition for fiber termination of core AVFN network in Operation Centers including easement access, building space, patch
  panels and required fiber cross connect to render network operational immediately. Acquisition and make ready construction required in advance
