Northwest Open Access Network (NoaNet) completed their Baseline Project and Six Month Budget during the 4th Quarter of 2010. Work continued on the Environmental Assessment (EA) in preparation for submission and anticipated receipt of Finding of No Significant Impact (FONSI). Project planning meetings and dialogue was held with Sub Participants of the project relative to their roles and responsibilities. NoaNet has developed a significant amount of progress towards establishing agreements with Sub Participants during this quarter. Network Design continued integrating with our first round award and other key elements of the project design.

Northwest Open Access Network (NoaNet) initially experienced a delay in accepting their award due to some overlap with a Sub Participant's BTOP award. Since being awarded, NoaNet has worked diligently on the Environmental Assessment (EA) in anticipation of an on time completion. Though recently the NoaNet EA team was presented with new and refined information that is important to include in the EA. Therefore NoaNet requested an extension to allow the required additional mapping and Section 106 cultural analysis to be completed. It may have been possible to "force" a draft EA by the SAC due date of Feb 1, 2011, yet NoaNet strongly believes this extension will allow for thorough quality assurance/quality control of the EA and will mitigate the risk of further iterations due to missing, incomplete or conflicting data being presented. As explained in the request for extension NoaNet does not expect the extension to delay the overall project and therefore would appreciate any assistance on the approval of the extension.
