Project Indicators (This Quarter)

1. Please describe significant project accomplishments completed during this quarter (600 words or less).

The law school's strong history of delivering legal and educational services to economically vulnerable communities is being strengthened through Technology Assisted Legal Instruction and Services (TALIAS). The current awareness campaign for TALIAS includes the website: talias.law.nccu.edu, which has been completed and includes two additional digital video recordings about the project.

During this guarter, several NCCU Legal Clinic attorneys held planning videoconferencing sessions for the development of upcoming legal workshops. Workshop topics include: Domestic Violence, The North Carolina Fatherhood Development Initiative, Veterans Law, and Tenant Rights.

On July 16, 2011, NCCU School of Law hosted a Wills and Advanced Planning for Later Life Workshop for a sorority in Elizabeth City, NC. There were a total of sixteen participants. The supervising attorney and the students were at NCCU School of Law and the participants were at Elizabeth City State University. The supervising attorney gave a presentation about Wills from the Telepresence Room at NCCU School of Law. Then, participants and students had one-on-one video conferences to have their Wills completed. The participant's Wills were executed the next day.

On August 23, 2011, a new undergraduate course, Introduction to Law and the Legal Process, was implemented for students at NCCU and the partner institutions. This course provides an overview of the materials covered in the first year of law school, the meaning of law, sources of law, and the structure of the American legal system. The instructor is located along with NCCU students in the Telepresence Room at NCCU School of Law. Students at the partner institutions interact during class through HD videoconferencing rooms that were built at the respective campuses. There are a total of twenty-three students.

On August 18, 2011, there was an Inaugural Videoconferencing Session between NCCU School of Law and fourteen Legal Aid of North Carolina (LANC) offices to begin the use of the telepresence technology and to begin sharing ideas and experiences for legal programs. Attorneys at both the NCCU Legal Clinic and the LANC offices are excited about combining their resources and expertise to become more efficient with legal services by eliminating the geographical boundaries between the attorneys and their clients. The fourteen LANC offices are located in the following North Carolina cities: Raleigh, Ahoskie, Charlotte, Durham, Greenville, Gastonia, Greensboro, Morganton, Pembroke, Pittsboro, Winston Salem, Wilson, Sylva, and Wilmington. There were a total of fifty-one participants.

On August 26, 2011, Former Congresswoman Eva Clayton visited the Telepresence Room for a demonstration.

On September 7, 2011, NCCU School of Law started a monthly Eagle Empowerment Videoconferencing Seminar for undergraduate students at NCCU and the partner institutions. This event was also opened to the public. The first seminar was called Entrepreneurship. A local attorney discussed how to start a business, the laws, legal forms, and other important rights for students with entrepreneurial aspirations.

On September 16, 2011, the Pittsboro Office of LANC hosted a Community Education Videoconferencing session between their office, Richmond County Community College, and Lee County Community College. The workshop educated those citizens of the two communities about Wills.

On September 30, 2011, the North Carolina General Assembly Legislative Fiscal staff and the General Assembly Legislative Leadership staff toured the School of Law. During their tour, they visited the Telepresence Room and were given a presentation about TALIAS and the significance of delivering legal and educational services to economically vulnerable communities.

There have been four Foreclosure Prevention Workshops and attorney to client video conferences during this quarter.

This quarter we started an undergraduate class at NCCU School of Law and our four partner institutions. In developing the Memorandum of Understanding, we made the assumption that it would cover the class. However, we learned that we needed an Inter-Institutional Agreement. We developed the Inter-Institutional Agreement and each campus has signed it.

The Site Managers for Fayetteville State University, North Carolina Agricultural and Technical State University, and Winston-Salem State University were not hired by their respective campuses. They have been hired as temporary employees at NCCU School of Law. We have submitted sub-recipient agreements for each campus. Each campus is in the process of transferring the employees to their payroll.

Our travel expenditures were 33% below our reprojections because we did not travel as much this quarter because we used videoconferencing.
