## 11b. Describe any challenges encountered with vendors or subrecipients.

#### PROJECT CHALLENGES:

- (1) Broadband Mapping-The team has experienced some challenges in obtaining the full cooperation of some broadband providers and outreach continues to improve participation levels among the provider community.
- (2) State Capacity Building & Planning-Due to various factors including an administration change, agency reorganizations, personnel changes, and Public Safety broadband developments it was necessary to revaluate and delay these components to ensure the best approach and address sustainability. Resolution is expected in Q4-2012/Q1-2013.

#### REPORTING NOTES:
