Broadband service represents a fundamental building block in the development of Ohio's future economy. Just as roads, rivers, rail and electric service were essential to the creation of a thriving national economy, access to high speed networks will be critical to compete in 21<sup>st</sup> century global markets.

To ensure Ohio workers and businesses can effectively compete in world markets, access to superior, yet affordable broadband services must be available everywhere. Governor Strickland established Connect Ohio in December 2007 with that goal in mind. Ohio has made a significant investment to establish our Connect Ohio program. Through those efforts, we now have up-to-date broadband availability mapping and research on broadband adoption and use available to guide our efforts, but our work is not done.

The State recently renewed its contract with Connect Ohio through the next fiscal biennium (June 2011). Unfortunately, due to fiscal constraints, the State was not able to fund the program as originally intended. Connect Ohio is seeking NTIA grant funding in order to fully support efforts in the areas of sustainable adoption and public computing. Ohio Public Adoption through Libraries project would serve to extend the State's vision for a broadband enabled state.

We value the opportunity to participate in the BTOP Sustainable Broadband Adoption program in this way, and urge you to consider fully funding this important initiative.

In order to bring necessary education, job creation, health information, delivery of government services, and a variety of social benefits to our citizens, it is critical that sufficient access to broadband services be widely available. Libraries are critical to providing these services to citizens without access to broadband at home.

In addition, libraries help the community understand and make full use of the benefits of broadband by providing an adequate supply of computers, curriculum to ensure effective use, and a program which will help citizens to adopt broadband as an integral part of their daily lives.

The State Library of Ohio and Connect Ohio, a non-profit public-private partnership established by the Governor of Ohio to promote the benefits and use of broadband have formed a partnership to increase the number of Public Access Computers available to library patrons and to ensure the delivery of curriculum and training to these patrons. Connect Ohio's Adoption through Public Libraries project will enable this by providing training, technical support, public awareness, and a coherent strategy that can be executed statewide. Connect Ohio's application will provide more than 100 new training jobs and produce over 200,000 incremental connected households in Ohio over the next two years, if funded.

By providing a sufficient supply of modern computers, the State Library of Ohio's Public Access through Libraries project will enable Ohio libraries to offer many of the benefits of broadband to their patrons. A recent survey conducted among library patrons statewide concluded that fewer than 40% of the users at the libraries have broadband at home. This meets the NTIA's definition of underserved population, and it is clear that the access to broadband at the library meets a vital public need.

The State Library of Ohio fully supports Connect Ohio's Adoption through Public Libraries project application. By making stimulus funds available through it and the State Library's Public Access through Libraries project we expect that great strides will be made statewide towards serving the public computing needs of Ohio residents. The increased capacity will not only result in greater adoption of broadband and its benefits, but will also provide needed access to government services, broader markets, job seeking tools, and social benefits to all Ohioans.

I am writing on behalf of the Ohio Public Library Information Network (OPLIN) to express support for Connect Ohio's proposal for a federal stimulus grant under the Broadband Technology Opportunities Program (BTOP) from the Dept. of Commerce, National Telecommunications and Information Administration, Round 2: Sustainable Broadband Adoption.

I understand Connect Ohio's project is titled "Ohio Public Adoption through Libraries, part II program (OPAL II)," which collaborates with the State Library of Ohio, whose project is titled "Ohio Public Access through Libraries, part I program (OPAL I)." The intent of OPAL II is to provide the training, technical support, and public awareness campaign that will ensure that citizens are able to use the workstations purchased through OPAL I to learn not only how to use broadband technology, but about its value in their lives. In addition to having ready access to broadband in a public place, computer users can complete a basic slate of curriculum which will help them to see the economic, social, and educational benefits of broadband clearly and to apply this value to their everyday lives in the forms of better education, healthcare, communication, and access to government services.

Throughout the recent economic downturn, libraries across Ohio have been overwhelmed by an unprecedented demand for public computers. Much of this demand has been driven by the needs of job seekers; many new job seekers go to public libraries for introductory computer training, help with job searches, assistance with online applications, guidance in developing resumes and much more. This increased demand for community computer access in public libraries has also been driven by increased reliance on the Internet to deliver assistance from social service agencies and federal, state and local governments.

Connect Ohio's proposed project will allow public libraries to go one step beyond their current services to those in need of an Internet computer; it will provide computer users with the training and the incentives they need to assess and appreciate the value of having broadband access at home. It will also stimulate the small businesses that currently use the Internet sporadically at the library. More and more of our economy is based on small businesses which will be increasingly dependent on access to broadband, computer equipment and the training to understand how to effectively use these tools to expand their business.

OPLIN provides Internet access bandwidth and circuit capacity to each Ohio public library system proportional to the library system's needs. We look forward to working with the local libraries participating in this project by continuing to provide high-quality broadband to the beneficiaries of the OPAL I and OPAL II projects. We hope that our support of this project is mirrored by support from the BTOP.

Ohio University-Chillicothe will provide matching funds with Connect Ohio by providing at least \$125 for each hardware purchase to implement the training, technical support, and public awareness in Pickaway County, Ross County, Perry, Vinton, Hocking, and northern Jackson counties. The estimated need of computers for the training in the six counties would be 310 computers with some equipped with projection monitor (LPDC Projector) to aid in the instructional process. The hardware will be purchased over a two year period.

Ohio University-Chillicothe understands that for each training hour for the six modules, the University receives \$30 of which \$9 is our match for the grant and will be deducted from the reimbursement. The University will provide 4,400 hours of Ohio Connects approved training modules in the six counties assigned to the University.

The Ohio University-Chillicothe campus welcomes the opportunity to work with individuals who need to learn to access broadband services.

Rio Grande Community College serves the Community College district of Gallia, Jackson, Meigs and Vinton Counties. We are aware of the on-going need to provide the citizens in these counties with much-needed computer skills. We therefore commit to this outstanding opportunity. We request the following for our district.

- Vinton County We request 400 training hours and 20 computers to assist the residents of the county. While we do not have a specific location currently available to offer the training, RGCC has been in the process of identifying a suitable facility to offer college courses. Discussions are underway with several possible partners. We anticipate having a location available by summer. We commit to having a suitable training facility and computer lab for the county if these grant funds are made available.
- Gallia County The main campus is located in Village of Rio Grande in Gallia County. We have a library facility which is open to public use and provides public access to some outdated computers. We request 1,200 training hours and 90 computers. Training will be provided in the library or in one of our available classroom computer laboratories.






