

Pending the approval of Connected Tennessee's Sustainable Broadband Adoption application for second round of the National Telecommunications and Information Administration's (NTIA) Notice of Funding Availability (NOFA) for the Broadband Technology Opportunity Program (BTOP), our department agrees to commit \$369,600, from our existing contract, towards the match for this application.


