 - o Custer County School District CAI \$10,000
 - \$10,000 Fee to private land owner to obtain right-of-way for fiber lateral construction for connection of a tower site (La Veta Tower) to EAGLE-Net's existing fiber backbone fiber optic cable

9. <u>Construction - \$706,667</u>

Estimated Costs, Proposed Activities, and Additional Information

Construction costs associated in this category are shown for the remaining sites to be completed from the NTIA approved list of twenty-nine (29) School Districts (later revised to remove one CAI and to add one additional CAI), ten (10) School District E-Rate wins (later revised to nine E-Rate wins), core network construction on I-25, and core network construction on Highway 160 to be completed during the initial extension period.

Silverton School District

Fiber Construction Costs - \$569,097

- \$80,000 Fiber Construction within the Town of Silverton (0.75 miles)
- \$385,213 Fiber Placement and Installation along route from the City of Durango to Cascade Village (27 miles)
 - \$1,588,279 Projected Federal Funds utilized through December 31, 2014 for construction on this route
 - \$972,775 Additional estimated amount to be paid using Other (non-grant) Funds to complete this route
- \$25,919 Project Management, Inspections, Travel costs, and materials storage associated with construction of the City of Durango to Cascade Village route
- \$77,965 Fiber Construction within the City of Durango (1.1 miles)

Ouray School District and Ridgway School District

Fiber Construction Costs - \$13,520

- \$13,520 Fiber IRU exchange agreement with Tri-State in the Montrose, Ridgway, and Ouray area
 - The agreement includes an exchange of approximately 30.6 route miles and 122.4 fiber miles of fiber IRU's. The details and approval of the exchange and the required waiver of the Sale/Lease provision are in AAR #2496945



I-25 North Core Network

Fiber Construction Costs - \$63,915

- \$51,915 Purchase of conduit, fiber, and fiber splicing from the Colorado/Wyoming border at I-25 to the grant name Peering Site, the NCAR-Wyoming Super Computing Center (NWSC), in Cheyenne, WY (12.8 miles) - Projected Federal Funds utilized through December 31, 2014 for construction on this route total \$290,786
 - Ninety-six (96) fiber strands and one vacant conduit from the Colorado/Wyoming border at I-25 to a crossing near the intersection of I-25 and I-80
 - Forty-eight (48) fiber strands and one vacant conduit form the crossing near the intersection of I-25 and I-80 to the NWSC
- \$12,000 Zayo IRU (1 mile)
 - Four strand IRU with Zayo to extend EAGLE-Net's current 511 mile Zayo IRU from Cheyenne, WY, to Branson, CO, into the NWSC

Steamboat Springs School District

Circuit / Colocation Costs - \$10,728

 \$10,728 - Includes the first year of a five (5) year agreement for fiber lease and colocation costs from a local provider for completion of the connection to the Steamboat Springs School District

Custer County School District

Fiber Construction Costs - \$9,505

 \$9,505 - Fiber construction to provide a connection from a tower (La Veta tower) to a handhole / splice point on EAGLE-Net's Highway 160 build (0.7 miles)

Wireless Construction Costs - \$39,902

 \$39,902 – Wireless construction costs at three tower sites and the Custer County School District (three wireless links) for the wireless route to the Custer County School District

By the time construction resumes in the spring/summer of 2015, there will be \$1,600,000 in funding for construction that can be utilized at EAGLE-Net's discretion for underserved / unserved schools.
