B. Executive Summary, Project Purpose and Benefits

Essay Question

10. Executive Summary of the proposed project:

The historical Northwest corner of Nevada, where gold was first discovered, still resembles the vast high desert displayed in many old cowboy movies. Lyon County alone covers in excess of 2,016 square miles, which is bigger than the state of Rhode Island at 1,213 square miles. These vulnerable rural areas are lacking access to high speed broadband service which needs to become available to the general public. Therefore, in order to provide a solution, Lyon County School District is partnering in this BTOP, PCC grant application with unserved and underserved communities, healthcare, library System, County Resources, Colleges, Sheriff's Department, Native American Tribes, and Lyon and Mineral Counties all proposing to open public Computing Centers in six common areas within the two counties. The area in Northern Nevada to be served includes Dayton, east to Silver Springs, north to Fernley, south to Yerington, east to Schurz and west to Smith Valley. (A horseshoe, "U" shaped area - see uploaded map)

Public Computing Centers within the counties are designed to reach an estimated 38,000 people (U.S. Census Bureau, Estimates 2008) who otherwise would not have the opportunity to enjoy such services due to geographically dispersed communities at 17.3 persons per square mile, (U.S. Census Bureau, Estimates 2008) which are currently underserved within the two counties. Today, in excess of forty-five percent of the student population is currently on the free and reduced lunch program and the unemployment rate for Lyon County is at 19.1% (10.7 U.S.),

currently the second highest unemployment state in the country. The average wages of the vulnerable population to be served is \$47,924 (2008 est.) which is 15% lower than the US Census Bureau reports a median income for the state of Nevada. The impact of Broadband related access for the vulnerable populations especially in zip codes 89447, 89429 and 89427 will be highly beneficial. These strategically located PCC's will offer an intergenerational opportunity for users to be introduced to basic computer skills as well as sophisticated training in 21st Century computer knowledge.

This project also intends to:

- *Provide targeted training and multimedia computer access to the public, including but not limited to students, families, teachers, seniors, youth correctional facility, public libraries, tribal organizations, and hard to reach populations.
- *Supply connection and access to advanced college level classes offered by Western Nevada College.
- *Enhance broadband opportunities to public libraries.
- *Provide job databases and job skill training opportunities for unemployed, homeless, low-income, disabled citizens, and at risk youth.
- *Offer language training and multi lingual educational resources for ESL families.
- *Provide GED graduation programs.
- *Furnish long distance conferencing capability in community buildings and avoiding the prohibitive expense of traveling typical long distances.
- *Expand awareness of available access points thus maximizing return on the Federal Investment in Technology.

The total project cost is \$1,064,675.00. We are requesting \$745,006.00 in BTOP Grant funds and are committed to providing 30% matching support in the amount of \$319,669.00. Training will be provided at all sites to include basic computer utilization skills, research capabilities, and internet search options in addition to specific training geared to the various needs of the individual population areas being served. At last families will be able to use self help computer skills to improve knowledge for basic need issues to include health issues, job skills, homework help sites, educational needs, and quality of life.

Computers are a necessity rather than a luxury these days, however in areas where 1.) High speed internet access is not available 2.) A lower socio-economic population resides, 3.) Costs are

prohibitive and 4.) Opportunities to improve are scarce, the quality of life is low, and the inner desire to improve seems too big of a hurdle.

The leaders from many walks of life within Lyon and Mineral Counties have met together in a town hall atmosphere to join together in a supportive partnership of a one time opportunity for change created by the BTOP, PCC grant award opportunity. Each has submitted a letter of partnership ensuring their support to implement quality standards in their effort to open Public Computing Centers throughout the described areas. The Lyon County School District, in hopes of supporting the students, families, and citizens of the area agreed to write and submit the application on all of our behalf. City Mayors, County Manager and their employees, Tribal Chairmen and Tribal Councils, State Personnel, Local business people, nonprofit organizations, hospital Administrators, and citizens of Lyon and Mineral Counties all see the need and benefits the PCC's would provide.

The unconventional unity this project has created throughout such a rural area makes up of a strong force of constituents from many walks of life. However, all have joined together in support of this project to benefit an entire community that is tired of being labeled, "Nevada, the most distressed state in the current economic downturn". But instead, recognizes this as an opportunity to advance with new resources to help prosper one another. It is realized that the success of the PCC program will come from the efforts of each partnering entity, many volunteers, and support within the communities.

11. Project purpose:

The purpose of this PCC project is to provide high speed broadband internet service and computer access to the public residing in currently under-served and unserved areas.

A local problem that continues to get in the way of meeting typical high speed connections similar to what is available in the urban areas of the U.S. is the vast miles stretched across the desolate terrain and the mountainous geography of these unserved areas which has deterred quality broadband service companies from installing expensive high speed fiber or internet service in the past. The few areas that are do currently receive service have either very slow speeds or only dial up capability, and a resident can pay in upward of \$200.00 per month for some services offered.

With the current opportunity the BTOP PCC grant award is making available, public computer centers will be available to otherwise under-served or unserved areas by opening convenient drive to locations throughout the communities. Offered at PCC's will be stronger internet connection, better hardware and software, support services for training, and education. Individuals, schools, libraries, medical, healthcare providers, community colleges, Native American Reservations and other community supported organizations such as Senior Centers, local Boys and Girls Clubs, and County Human Services Departments will all receive access to computers.

When receiving the BTOP award for this region of Northern Nevada, the proposed public computing centers will provide the residents with distance learning access to view and enroll in advance classes that otherwise are not available to them as well as be able to take advanced college level courses offered by Community Colleges and earn college credits. Job searching assistance programs and Human Services facilities will be able to offer greater training and job preparedness offered by large industries, and business establishments. Law enforcement services can supply a wide variety of education, prevention and interdiction services in addition basic law enforcement functions such as youth mentoring, and prisoner re-entry education. Seniors will have the ability to use social networking sites to keep up with their grandchildren and children and talk with folks from distant locations while still in their local centers. Tribal populations will have computer access within the reservation.

With the jobless economy faced in Northern rural Nevada, the homeless, the elderly, and the high desert community as a whole is struggling. The PCC project offers hope and a solution to the current problems facing our citizens living within affected rural areas. The PCC locations will provide a source of informative computer sites necessary for personal issues by offering help and hope for improvement.

Another problem with publicized attention affecting Nevada as it is currently one of the States in our country with a very high suicide rate. A Center for Disease Control and Prevention (CDC) research team explored the relationship between social connectedness and self-directed violence in 4,131 middle and high school students in a high-risk community. The community was characterized by high rates of poverty, unemployment, and single-parent households much like the demographics within Lyon County. Connectedness to family was by far the strongest predictor. Taking the findings into account, the authors suggest that programs promoting youth connectedness and connectedness to adults should include promotions of family connectedness

as well, and should intervene especially with youth and adults exhibiting depressive symptoms (which had a strong association with non-suicidal self-harm, suicidal ideation, suicide plans, and non-fatal suicidal behaviors). Lyon County terrain is vast and because of lack of programs and the many miles between crisis prevention locations often the depression and secrets go unspoken. The PCC locations can provide a private, safe connection to chat rooms and crisis centers as a possible lifeline. At last, finding connectedness might be just the opportunity needed for help and support at a difficult time in one's life. Public Computer access could be an answer not previously available in this rural area.

Many stressful issues face this area and partnering organizations such as Lyon County Healthy Coalition will be able offer assistance throughout the county with improved communication via public computing centers. Computer internet access provides a means for connecting to helpful local agencies as well as outside resources which are necessities that vulnerable populations without computer internet access are prohibited from exploring. PCC's can be a valuable solution by providing means for families without current computer availability to address individual problems and know they will be provided answers. Receiving training in computer literacy from community partners able to direct the public to this information is invaluable and satisfying. Neighbors helping neighbors follows the theme "It takes a village to raise a child." Together, through mutual community efforts and the purpose of BTOP in providing broadband education, training, easy access points, computers and equipment to rural communities we can grow together in an effort to rise up as a stronger more educated community.

Potential jobs will be created by the PCC project helping citizens in the area. In addition, volunteers will help with supporting the centers in many positive ways. Being needed and serving others is very therapeutic and distracts thoughts of loneliness and depression. Having close ties with others is vital to every aspect of our health, be it mental, emotional or physical. The PCC's will serve many purposes and the helpful advantages of these facilities will positively serve the community in many ways.

12. Recovery Act and Other Governmental Collaboration:

Lyon County School District serves 9000 students in an area of exceeding 2,016 miles. Within that area, the number of students in Title 1 schools receiving funding is 3,342. The policy as rewritten in 1994 is to improve fundamental goals of helping at-risk students. According to the U.S. Department of Education, the purpose of Title 1 funding, "is to ensure that all children have a fair, equal and significant opportunity to obtain a high quality education and reach, at

minimum, proficiency on challenging state academic achievement standards and state academic assessments." Funds can be used to assist schools in meeting the educational goals of low-income students, migrant students, students with limited English proficiency, homeless students, students with disabilities, neglected students, delinquent students, at risk students or any student in need. At-risk students include single-parent home, low academic performance or low income family. Parents never want their children to fail but how can they help them?

The BTOP PCC program can leverage federal or state developmental programs by providing the parents of the low-income, homeless, and students qualifying under the Title 1 parameters who may have never had access to computers their first opportunity to access one. Classes will be provided for knowledge and skills to use a computer and the training it takes to help their children with academics. Without the expense of long commutes, together, both parents and students will now have a close location outside of the classroom to do research, homework, and a greater opportunity to thrive and learn together. Distance learning facilities will provide higher education with access to colleges such as Western Nevada College to earn units in post secondary classes. Parents can investigate small business development center programs for possible new business ventures and an introduction to e-commerce opportunities.

Over the next two years, Federal Funds for Special Education Students and Sped programs in Lyon County School District will total 1.3 million dollars. How wonderful it would be to provide virtual field trips on video conferencing screens at the PCC's that parents could easily access. Travel is often difficult so to open the doors to the beauty of the ocean, and be able to have access to turning over sea creatures with your own hands through the magic of video cameras and video screens both special education students and their families can enjoy this together at a BTOP funded PCC.

The opportunities mentioned are substantial and meaningful for the vulnerable population identified. What a great way the collaboration between BTOP money and other federal or state developmental programs as described above will lead to greater project efficiencies while sharing time and new experiences with an autistic child, a disabled individual or a healthy friend.

13. Technology Strategy:

The technical goal is to provide PCC locations that are easily accessible to the public and are safe, secure, and able to meet high standards allowing people of all age's access to an

opportunity currently not available. This will be the bridge over an educational divide that has been long awaited.

An outside contractor will be hired to provide a 1.5 Mb of internet access to each site. PCC's will be opened serving the community with new HP low profile desktop computers with Microsoft Windows, Microsoft Office, Firefox Internet browser, anti-virus and backup reimaging software, and ready for training software installation to provide course opportunities in subjects that fit the need of the particular area of service.

Gigabit Enterasys switches will be used to provide a robust connection. All computers will have filters in order to provide content filtering, antivirus protection and spyware protection.

Symantec Endpoint Protection II integrates combines protective technologies such as Cisco ASA 5505 firewall, antispyware, antivirus, intrusion prevention, and controls which peripherals are allowed to be used such as CD burners, and other USB devices. This prevents endpoints from being infected by viruses which can be brought in from outside sources.

Some PCC project locations will supply distance learning opportunities for the public. With interactive video equipment, video projectors, computers, and SMART Boards, new opportunities will be available for the first time in our Computing Centers throughout Lyon County and its citizens. Training to properly use this equipment will be provided by Lyon County School District. Users will be required to have completed this training.

Each PCC location has been selected for its convenient location near the rural community it is intended to serve. Locations are currently in-use public buildings such as Senior Centers, City Hall, Community Centers, or Classrooms, which are already open to the public on a daily basis. Although due diligence is one safety measure, surveillance cameras are already available at some of the sites.

14. Public Availability:

The area covered by a PCC award extends over 2,016 square miles, divided into five general areas of coverage allowing the general public access to computing center sites.

The farthest South west portion will have a PCC located at the County Library in Smith Valley, serving a community strong in agriculture. This area of ranching and farming can obtain information at a computer site located in the central part of town close to all schools. There will be no charge to the public for their use.

East of Smith Valley is the city of Yerington, the county seat of Lyon County incorporated in 1907. One of its treasures is the Jeanne Dini Center which in 1912 served as an active school house. In 1980, citizens came together to rehabilitate the facility where the second PCC will be located. Classes will be offered in a historical theatre where local artists display their art in the

gallery, and a theatre also within. The theater currently has a large screen which will have capability to show an audience of 145+ viewers a training class, distance learning, or virtual travel. Revenue will be earned to help defray costs when contracting use of the PCC for outside business employee training, etc. Local Sheriff Department will host a variety of education, prevention, and interdiction seminars. Yerington Piute tribe will access the theatre for speakers, films and cultural events. Lyon Council on Alcohol and Other Drugs will use the facility to show "Say NO to Drugs films to school students and children attending the Boys and Girls club, both within walking distance to the PCC. Public access is excellent and includes ramps for disabled folks.

East of Yerington is home to the Walker River Piute tribe located in Schurz, a community in Mineral County. A PCC will be open on the reservation for all tribal members and the public to use. There will be no cost to the public for the use of this PCC.

Following the old Pony Express pass north, is Silver Springs. A PCC location is planned for a building that currently offers Adult Education and GED classes. This is centrally located for easy public access owned by the school district; therefore usage will be available at no cost to the public.

Yet another Pony Express stage stop and early railroad town is north in Fernley. The mayor has offered a part of the city hall to facilitate a PCC. Distance Learning will be provided at this location which has easy access for the community and again, the public will use the computers at no charge.

West of Fernley is a Pony Express route where gold was discovered in the 1800's now called Dayton. In this town the Senior Center will also host a PCC. This location offers easy access and will be open to the public at no charge.

15. Restrictions on Center Use:

During the hours of operation, there is generally no restriction in use of the PCC centers. However, if Western Nevada College, for example, is hosting a class open to the community for college credits, the class will be posted in the newspaper and the public will be able to participate, therefore, computers will not be open at that particular location for independent use at that time.

If a public group desires to use a PCC for training, it too will be pre scheduled and posted for public knowledge and independent use will not be available. PCC's are for public use, therefore pre-scheduled events will be allowed. The purpose of these centers is to encourage public use and access to broadband service. Organizations and other entities that provide outreach may

This will help facilitate classes to the communities in those rural areas.

From 2005 through 2007 Lyon County's PCPI percentage of the National PCPI is decreasing. Between low per capita income within Lyon County and being such a rural, under-served and unserved high desert area, the PCC's will be serving every specified group on the demographic chart.

A large Hispanic population lives in this area due to the agriculture and ranching job opportunities. Although children learn English in school, many parents are looking for opportunities to learn English as their second language. ESL classes will be held at PCC's with software to accommodate.

Lyon County has a low population of Black/ African-Americans, Asian, and Pacific Islanders, the PCC will accommodate people of all cultures and ethnicity while offering equal opportunity to have access to computers, high speed internet, and distance learning.

Sometimes travel is difficult in this community for the disabled because there is no public bus transportation available and they may have to rely on others for transportation. The world can now be at any disabled community members' fingertips through the long awaited high speed internet access and public computing centers in rural Lyon and Mineral County area. What a joy to have access to informative sites. All locations will have easy wheelchair access and already be up to code throughout the PCC.

Retired Senior Citizens will have convenient day use while children are in school allowing them quiet time in the centers and easy comfortable access. Classes will be available if computer use is

new to them at a pace that will offer them excellent success. All locations have convenient, safe parking areas with well lit access for their safety.

Students and at risk youth will be able to complete homework assignments and class projects. Many students have been without computer access outside of school. The opportunities are great for the youth as they can take online classes for college credits, make up deficient credits for graduation, or take distance learning classes. This better prepares students for higher education and sends them to college with a better knowledge of what is expected from them as students earning a college degree.

The programs offered at the PCC's will help all citizens within this vulnerable community to gain necessary vital skills for self improvement in education as well as in life.

30. Accessibility

People with disabilities will have accessibility into the existing public facilities which are already in compliance with the Americans with Disabilities Act (ADA), a civil rights law prohibiting discrimination on the basis of disability in the private and public sectors. Because all locations are wheel chair compatible and have existing ramps built where needed all PCC locations are readily accessible and useable to any individual with disabilities. In addition, restrooms currently meet ADA Standards.

At this time primarily English will be taught to the Spanish speaking population, as Lyon County currently has a very low population of other multilingual residents. Therefore, ESL classes will be offered at the PCC's.

rural areas restricts your ability to clearly tune into many radio stations. FM station KSVL plays a variety of music and has local talk show hosts that will give free announcement air time of local PCC events and classes that so local radios can easily receive reception. Lyon County School District is partnered with Connect-Ed, a service where the Superintendent or any principal can send a message to every phone of every student household. We can reach the homes of 9000 students with announcements about the PCCs. Lyon County Healthy Coalition is partnering up with us and will get the word out to the folks in the communities as they distribute food at food banks, offer health clinics, and communicate daily with all the service organizations throughout the area. This will especially serve the poverty level families we hope will connect with computer centers. Two local reservations serving the Walker River Piute Tribe and the Yerington Piute Tribe are partnering with us as they recognize the opportunities the PCC's will offer to their residents. They have offered to publish information through their Tribal Coalition and through their local newsletter called Agai Dicutta Yaduan. Once a week a local newspaper is published and free nonprofit announcements are read by all. A weekly schedule would be posted. One thing that thrives in small towns is Local Service Organizations. With their weekly meetings they will gladly announce the classes and training being offered at the PCC in their community. Churches will support announcements to their congregations. The PCC's will serve our senior communities and postings of events will be tacked to their bulletin boards. The water district often sends fliers out with their billing. A flier could be stuffed into their envelopes for public awareness. With these listed outreach strategies, the rural areas will be well informed of locations and trainings being offered at Public Computing Centers.

36. Training and education programs

A Project Manager with knowledge of education software and different curriculum for folks of all ages will be contracted to schedule classroom instructors and volunteers to facilitate evening training in a variety of subjects. Depending on the vulnerable population's needs classes will be designed to accommodate various levels of computer instruction and training of Microsoft office, Access and Excel. Because of the unnerved and under-served areas never having access to internet, and the low income areas not affording computers, we anticipate many starting at the beginning level. Therefore, start-up classes will be provided and repeated regularly, so new users can enter at a beginning level at frequent intervals. Trainers will assist participants to succeed while encouraging them to gain computer skills and continue to grow in a new knowledge technology.

Training will be available in adult education such as GED education and preparation for testing. ESL classes will be offered throughout the county. Courses in conjunction with Western Nevada College will be ongoing.

Because we are a school district, we have access to knowledgeable trainers for each PCC location. Also, volunteers are already anxious to assist the public in this endeavor to include high school students and senior citizens.

Another struggle is finding locations for PCC's because structural buildings are scarce. Locations were strategically determined with public travel in mind. Each selected is approximately 25 miles from one another. The 25 miles between each location is desolate desert with no construction. Population of each area was evaluated in determining the total number of units required at each center. Proximity to school sites and student body counts were considered in hopes that families would be near the centers to reduce travel expense and time. Locations needed to be open and staffed during business hours to reduce paying facilitator costs. Lastly, matching funds had to be considered in determining proposed funding. The reality of finances played the most important in the project decisions.

Yerington, Jeannie Dini center measured 21'3" x 18'3". This area has a larger population, so 18 computers were decided upon by the tenants and Lyon County School District (LCSD), the building owner. Fernley City Hall has a vacant room with its own entry. It measured enough to hold 18 computers and with the larger population it can accommodate that. Dayton Community Center is owned by Lyon County. As an art and cultural center, the location will be perfect for a PCC with 18 computers. Walker River Piute tribe has a facility that can comfortably accommodate 18 computers and is located in the center of the reservation, close to Tribal headquarters. Easy access to this facility will make them available to Native American residents who have never had such an opportunity before. These largest PCC's will be equipped with a screen, and camera to provide distance learning. Smith Valley has a smaller building used as a public library also owned by LCSD. It has room enough for 10 computers. The Silver Springs Adult Ed/GED center will hold 18 computers in a classroom. The population is larger and with three schools in close proximity, the location is accessible.

These locations and units required for this project are reasonable for the type of geography in this desolate high desert area.

NEVER BE HEALED AFTER SESSION (The Associated Press, Friday, March 5, 2010) assuredly, the Public Computer Centers Project would not have been implemented during the grant period without federal grant assistance.

History suggests that Nevada's public schools may never recover from the budget cuts being required of them by legislators. Now, with the Legislature's special-session mandate that the district trim 6 percent from its operating budget, can we ever catch up? The Lyon County School District is facing a budget shortfall of about \$4 million for the coming year, and the district is currently working on ways to trim its budget for the 2010-11 fiscal years.

Because unemployment in Lyon County, Nevada is at 19.1%, the repercussions include families abandoning their homes and moving to other locations in search of jobs. This results in school enrollment dropping and a reduced budget for Lyon County School District. Student homelessness has increased, food banks are serving hundreds of people every day, 6,000 calories worth of food is being sent home with students on weekends in discrete back packs to ensure they are eating at least 3,000 calories on Saturday and Sunday while away from the school breakfast and lunch programs. Local businesses are closing and opportunity for improvement is looking frightfully bleak. The economic shortfalls suffered by many in recent times is only exacerbated in smaller rural communities that have been without and still do not have computers and internet access available as basic tools for success.

Without the assistance from President Obama and the funding of the BIP and BTOP grants in Nevada, be assured that a project such as this would not be considered today or in the near future.
