REASON(S) FOR AMENDMENT

The NT10BIX5570055 Navajo Tribal Utility Authority Broadband Technology Opportunities Program (BTOP) grant has met the requirements of the Special Award Conditions (SAC) for National Environmental Policy Act (NEPA) compliance. The Final EA has been approved and the attached Mitigated Finding of No Significant Impact (FONSI) and has been signed by the BTOP Director of Compliance and Audits. The analyses of the Final EA indicate that the proposed action is not a major Federal action significantly affecting the quality of the human environment. Restrictions on the release of funding associated with this SAC are removed as of the date of the lifting the EA SAC in the system. Attached there is a new Special Award Condition (SAC) which includes the environmental protection measures specified by consultations with regulatory agencies in the Final Environmental Assessment that are either required, or requested, to be included in the implementation of the Project to minimize impacts to environmental, historic and cultural resources.
