REASON(S) FOR AMENDMENT Delays surrounding an extended issuance of the original Environmental Assessment (EA) Finding of No Significant Impact (FONSI), the subsequent EA Addendum for required route changes, and extenuating "make-ready" activities with a utility pole owner have pushed the anticipated completion date of construction activities until the end of the grant award period (July 31, 2013). Furthermore, last-mile service provider negotiations (SLAs) have required significant time and resource allocation, drawing away from other grant administration tasks. As such, REDI Net is requesting a 2-month extension (until September 30, 2013), specifically to complete "as-built" documentation after construction concludes and the required federal security interest forms (UCC filings).				
This Amendment approved by the Grants Officer is issued in triplicate and constitute an obligation of Federal funding. By signing the three documents, the Recipient agrees to comply with the Amendment provisions checked below and attached, as well as previous provisions incorporated into the Award. Upon acceptance by the Recipient, two signed Amendment documents shall be returned to the Grants Officer and the third document shall be retained by the Recipient. If not signed and returned without modification by the Recipient within 30 days of receipt, the Grants Officer may unilaterally terminate this Amendment.
