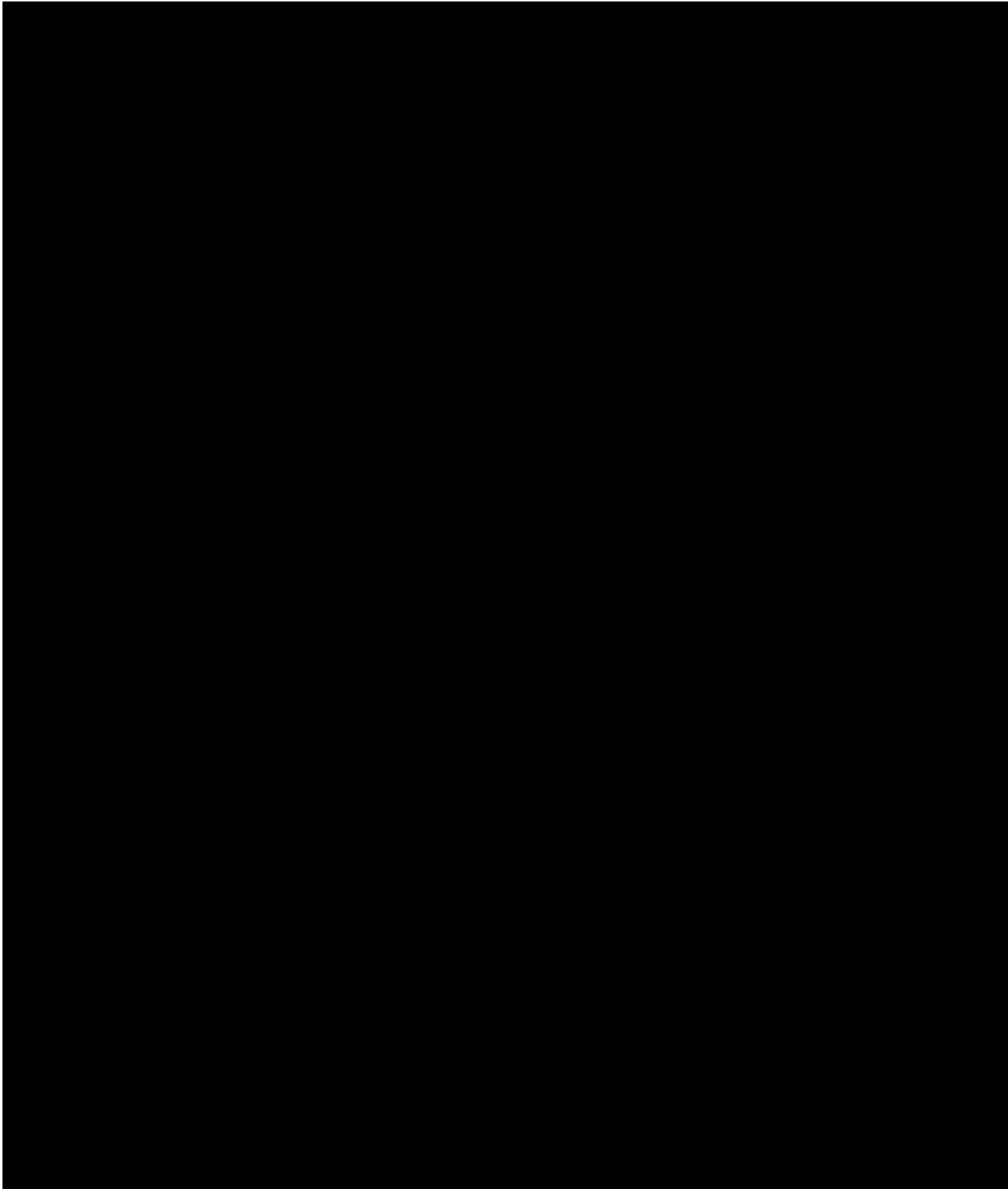


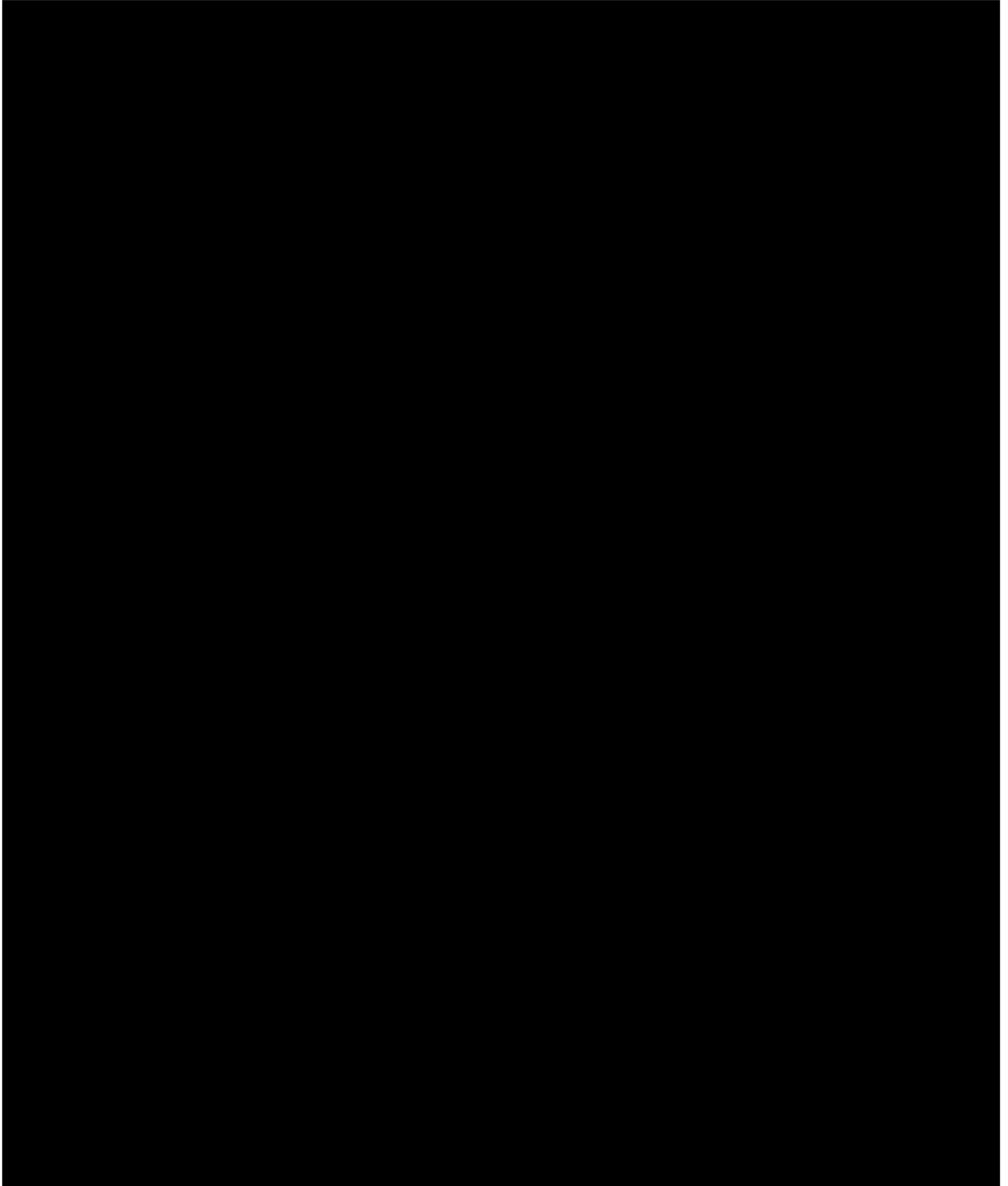

RESOLUTION NO. 2010-02

A RESOLUTION OF THE [THE CITY OF ESPANOLA], NEW MEXICO, FORMALIZING ITS ROLE AS A PARTNER IN REDI MIDDLE-MILE BROADBAND NETWORK

WHEREAS, in 2007, several local governments united in a groundbreaking effort called REDI (Regional Economic Development Initiative), which produced Northern New Mexico's first regional and comprehensive economic development strategic plan to address the region's systemic problems, including low incomes, high poverty rates, geographic isolation, lack of private investment and lack of opportunities for upward mobility;

WHEREAS, high-speed broadband was identified as *the region's number one economic development priority* because of its ability to achieve many of the region's goals, including 1) strengthening the private sector, primarily in areas of technology, media, renewable energy and green industry; 2) providing access to markets and services for remote home-based businesses and residents; 3) providing adequate bandwidth for 21st century applications in the region's schools and community and four-year colleges; 4) supporting distance learning and telemedicine applications upon which rural residents depend; 5) leveraging the efforts of rural electric cooperatives in green grid and smart grid deployment; and 6) providing secure and efficient networks for public safety, homeland security and emergency response;

WHEREAS, lack of access to affordable backhaul and middle-mile services has been a persistent barrier to economic and community development in Northern New Mexico;

WHEREAS, [the City of Espanola] lacks access to affordable backhaul and middle-mile services for its own governmental uses; and

WHEREAS, [the City of Espanola] strongly supports a publically-owned, open middle-mile network as the most viable solution for providing high-speed broadband access to government, businesses and residents in rural areas, where the case for private investment is weak.

NOW, THEREFORE, BE IT RESOLVED THAT:

1. [The City of Espanola] is a partner in the Round 2 Broadband Technology Opportunity Program (BTOP) submitted by the North Central New Mexico Economic Development District (NCNMEDD) on behalf of the Northern New Mexico region;
2. [The City of Espanola] is a member of the North Central New Mexico Economic Development District (NCNMEDD), and has designated a representative to serve on a Broadband Technical Committee that will advise and support the

NCNMEDD Board on the construction phase of the project and on reinvestment activities after construction is completed; and

3. **The City of Espanola** plans to purchase services for its community anchor institutions from the REDI Broadband Network once it is operational.

As we discussed, Agavue LLC (“Agavue”) is an established broadband service Provider that is proposing to expand its service area to serve residents, businesses and critical anchor institutions in certain census blocks in Taos, Costilla, Santa Fe, Colfax and Rio Arriba counties in New Mexico (the “Target Service Areas”). REDINet (the “PROVIDER”), through the North Central Mexico Economic Development District, is proposing a middle- mile fiber project in the Target Service Areas. Provider also intends to apply under ARRA for funding for its proposed project in the Target Service Areas.

Each of Agavue and PROVIDER recognizes the lack of high speed broadband services in the Target Service Areas. Each of Agavue and PROVIDER also recognizes that the approval of their respective ARRA applications will increase the competitive capabilities and efficiencies of businesses and residents in the Target Service Areas through increased broadband speeds and allow Agavue and PROVIDER to offer such services at a cost that could not otherwise be afforded by the businesses and residents of Target Service Areas. As a result, each of Agavue and PROVIDER wish to outline potential partnership arrangements between Agavue and PROVIDER with respect to (i) Agavue’s use of PROVIDER’S proposed middle-mile infrastructure and (ii) the avoidance of any duplication of efforts and redundancies of last-mile projects in the Target Service Areas.

The specific terms of such potential arrangements would be as follows:

1. Agavue and PROVIDER will exchange information regarding their respective ARRA applications in sufficient detail to allow Agavue and PROVIDER to maximize the offering of high-speed broadband services to as many residents of the Target Service Areas as possible and in the most cost-efficient manner. Any information exchanged between Agavue and PROVIDER would be subject to the terms and conditions of a confidentiality agreement of even date between Agavue and PROVIDER;

2. Agavue and PROVIDER would enter into long-term arrangements regarding Agavue's use of PROVIDER'S middle-mile infrastructure for Agavue's last-mile offerings in the Target Service Areas. Such arrangements would be on commercially reasonable terms and conditions that are satisfactory to both Agavue and PROVIDER; and
3. In order to provide cost-effective broadband solutions in the Target Service Areas and in consideration of Agavue's use of PROVIDER'S middle-mile infrastructure, Agavue and PROVIDER would agree that PROVIDER would not duplicate Agavue's last-mile offerings in any of the Target Service Areas in any application for funding under ARRA. However, the foregoing understanding would not preclude PROVIDER from leasing any of its middle-mile infrastructure to any other third party, including competitors of Agavue in the Target Service Areas.

This understandings contemplated herein would become effective when signed by all parties. The understandings contemplated in this letter regarding exchanges of information and the use of PROVIDER'S middle-mile infrastructure are also subject to the availability and approval of ARRA funding for each of Agavue and PROVIDER.





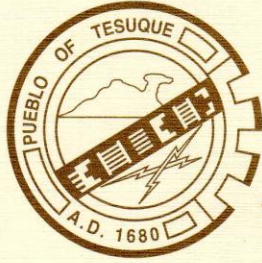

Dear Mr. Strickling:

Tesuque Pueblo is a partner in the North Central New Mexico Economic Development District's Round 2 CCI BTOP application for the REDI Middle-Mile Network. This project will provide a critical high-speed fiber connection to our tribal offices and police department, located along NM 285/84. Tesuque also plans to use this interconnect to provide broadband to its one hundred ten residents, who have no access to broadband services at this time.

With new demands being placed on tribal emergency services providers by federal agencies such as Homeland Security and Emergency Management to upgrade communications (*to include voice, data, access to geospatial information, internet/web use where applicable, to utilize or share information*) and to be NIMS compliant. Along with the US Department of Justice requiring compliance with Sex Offender Sentencing, Monitoring, Apprehending, Registering, and Tracking, these are only a few examples.

With high-speed service available, the police department could upgrade all radio equipment and other forms of communications. This has become an important priority. With new regulations and requirements mandated by Homeland Security and Emergency Management Responders, all law enforcement agencies nationwide are required to have in place "Narrow Band" radio frequencies and radios in operation by 2012.

The entire community would also benefit, such as community wide training, health awareness, mental health, and peace keepers to mention a few.


The ultimate long-range goal is to establish a "*Multi jurisdictional Training Facility*" that will employ innovative technologies (web-based) that will assist Law Enforcement (tribal, local, county, state, and federal agencies) as a whole in training, homeland security, and other technical applications. Once this facility has been established there will be undertakings to take this technology to a global level.



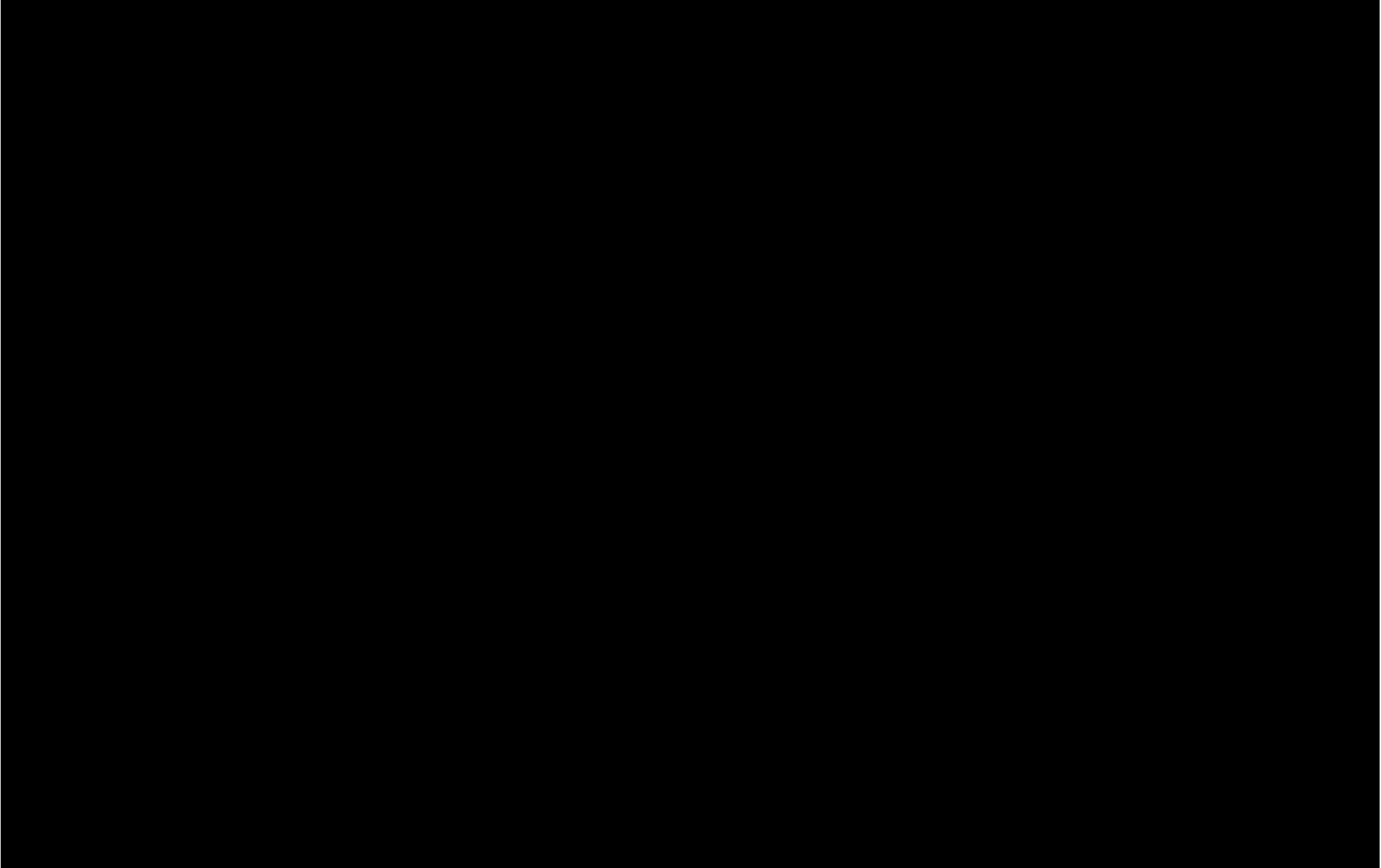

Dear Mr. Strickling and Mr. Villano:

Tewa Communications is a Wireless Internet Service Provider (WISP), which is a division of a federally-chartered Section 17 San Ildefonso Pueblo Enterprise Corporation owned by the Pueblo de San Ildefonso. Tewa Communications was established in 2006 because San Ildefonso Pueblo lacked telephone and internet service in much of the community, and requests to the incumbents to extend service fell on deaf ears. Since then, Tewa Communications has received funding from the USDA Rural Utility Service (RUS), initially in 2006 under RUS's Community Connect Grant and recently from Round 1 of the Broadband Initiatives Program (BIP). Tewa Communications currently provides service in many communities that are underserved, including the Pueblos of San Ildefonso, Santa Clara, and the communities of Espanola and White Rock. The Round 1 BIP award will allow us to extend our coverage to nearly 2,500 additional households in the nearby communities of El Rancho, Jacona, La Mesilla, Santa Clara Pueblo, Pojoaque Pueblo, Nambé Pueblo and Tesuque Pueblo as well as into portions of Santa Fe and Rio Arriba County.

San Ildefonso Pueblo and Tewa Communications have been active partners in REDI, Northern New Mexico's Regional Economic Development Initiative, and we strongly support the three REDI Open Network applications that will be submitted in Round 2 for Northern New Mexico. These include:

1. North Central New Mexico Economic Development District for *REDI Net* (BTOP CCI)

2. The City of Santa Fe for *Santa Fe e-cequia* (BTOP CCI)
3. Kit Carson Electric (BIP Last Mile)

The REDI Net application includes a critical fiber interconnect for both Tewa Communications and San Ildefonso Pueblo. Currently, Tewa Communications relies on Qwest for backhaul services. We have struggled since our inception to obtain adequate bandwidth at reasonable rates from Qwest, and this has limited our ability to grow and be competitive in the marketplace. A true open network, REDI Net will offer affordable middle-mile services to all last-mile providers, making broadband more accessible and affordable for everyone, including the high percentage of low income residents in the service area.

Additionally, if all three REDI Open Network projects are funded, the networks will form a seamless infrastructure which provides multiple points for backhaul interconnection in the region, as well as access to multiple markets for last-mile service provider partners like Tewa Communications. Through this regional infrastructure, Tewa Communications would be able to expand its service area into Santa Fe and Taos, increasing competition and reducing costs for end-users.

Tewa Communications is a committed last mile partner for REDI Net. We commit to purchasing wholesale bandwidth from REDI Net once it becomes operational, to better serve existing customers, make service more affordable, and further expand our existing service area.

The Pueblo de San Ildefonso, through Tewa Communications, which is a division of a federally-chartered Section 17 San Ildefonso Pueblo Enterprise Corporation owned by the Pueblo. Tewa Communications was established in 2006 because San Ildefonso Pueblo lacked telephone and internet service in much of the community, and requests to the incumbents to extend service fell on deaf ears. Since then, the Pueblo has received funding from the USDA Rural Utility Service (RUS), initially in 2006 under RUS's Community Connect Grant and recently from Round 1 of the Broadband Initiatives Program (BIP). Tewa Communications currently provides service in many communities that are underserved, including the Pueblos of San Ildefonso, Santa Clara, and the communities of Espanola and White Rock. The Round 1 BIP award will allow us

to extend our coverage to nearly 2,500 additional households in the nearby communities of El Rancho, Jacona, La Mesilla, Santa Clara Pueblo, Pojoaque Pueblo, Nambe Pueblo and Tesuque Pueblo as well as into portions of Santa Fe and Rio Arriba County.

San Ildefonso Pueblo and Tewa Communications have been active partners in REDI, Northern New Mexico's Regional Economic Development Initiative, and we strongly support the three REDI Open Network applications that will be submitted in Round 2 for Northern New Mexico. These include:

1. North Central New Mexico Economic Development District for *REDI Net* (BTOP CCI)
2. The City of Santa Fe for *Santa Fe e-sequia* (BTOP CCI)

The Pueblo has designated a representative to serve on a Broadband Technical Committee at the North Central New Mexico Economic Development District (NCNMEDD) which will advise and support the NCNMEDD Board on the construction phase of the project and on reinvestment activities after construction is completed. Through the Broadband Technical Committee and the NCNMEDD Board, San Ildefonso Pueblo, NCNMEDD, and the other sub-recipients for this project will oversee construction of the network, contracts for network management and operation and maintenance, and future reinvestment and expansion activities; and

The Pueblo is a committed last mile partner for REDI Net. We commit to purchasing wholesale bandwidth from REDI Net once it becomes operational, to

better serve existing customers, make service more affordable, and further expand our existing service area.

Kit Carson Telecom is a Wireless Internet Service Provider (WISP), owned by Kit Carson Electric Cooperative, based in Taos, New Mexico. Kit Carson Telecom was established in 2000 because the Kit Carson Service area lacked internet service in much of the community and requests to the incumbents to extend service fell on deaf ears. Since then, Kit Carson Telecom has succeeded in its goal to provide service in many communities that are underserved in the Kit Carson Electric Service area and other parts of Northern New Mexico inclusive of Taos, Rio Arriba and Colfax Counties. Should the last mile Round 2 BIP be awarded to Kit Carson Electric, it will allow us to extend our coverage to nearly 2,500 additional households in the nearby communities of Amalia, El Rito North, El Rito West, Ojo Caliente, Penasco, Rotarte, Chamisal and other underserved and unnerved areas of Kit Carson Electric service area.

Through this regional infrastructure, Kit Carson Telecom would be able to expand its service area into Santa Fe and Taos, increasing competition and reducing costs for end-users.

Kit Carson Telecom is a committed last mile partner for REDI Net. We commit to purchasing wholesale bandwidth from REDI once it becomes operational, to better serve existing customers, make service more affordable, and further expand our existing service area.

On behalf of Ohkay Owingeh this letter provides our recommendation and strong support to be a contributing "Last Mile" partner to the North Central New Mexico Economic Development District's application for the REDI Middle Mile Network (REDI Net) under the Round 2 BTOP Comprehensive Community Infrastructure (CCI) program. Ohkay Owingeh, a federally-recognized Tribe, is located in Rio Arriba County just north of the City of Espanola. In 2006, Ohkay Owingeh received a \$640,000 RUS grant from the Community Connect program to install a WiMAX system that currently serves our tribal offices and tribal residents. Prior to installation of the system, the majority of the reservation had access to only dial-up services from the local service carrier, Windstream, and limited coverage from wireless internet service providers. The RUS Community Connect grant enabled us to provide high-speed internet access to our tribal offices and to 40% of its reservation lands. Our plan is to seek additional RUS and other funds in the future, to provide effective and efficient coverage (100%) to our community residents.

In addition, our tribal holding corporation, Tsay Corporation, is an active partner in REDI and together we support this initiative. This application will directly benefit Ohkay Owingeh in the following ways:

1. REDI Net includes a critical fiber interconnect for Ohkay Owingeh's WiMAX system which will enable us to obtain more bandwidth at lower rates. At full build out, our system will reach approximately 550 homes, making Ohkay Owingeh a critical last-mile provider in an underserved and low income community.
2. REDI Net provides an interconnect for the Ohkay Owingeh Library, which is a State Library site included in the State of New Mexico's Round 2 BTOP Public Computing Centers (PCC) application, easy grants no. 6216. The Ohkay Owingeh Library was also included in the awarded New Mexico State Library SBA application in Round 1. This REDI Net interconnect will easily provide 100 mbps of connectivity to the library, enabling a host of applications that can be used in training and digital content through the PCC and SBA programs.

3. REDI Net provides a high-speed interconnect for the Ohkay Owingeh Aviation Industrial Park, which is a critical driver for economic development in the Espanola Valley and the Northern New Mexico region. The 30-acre park includes flexible pad sites with complete infrastructure build-out, terminal and fixed-based operator facilities. Several of the projects for high-paying jobs in the aerospace, manufacturing and renewable energy sectors by the Regional Economic Development Initiative (REDI) are planned at this location.

Furthermore, Ohkay Owingeh is a committed last mile partner for REDI Net. We request support of this “last mile” initiative and additional support on behalf of our community. For example, much of our location remains underserved, and some isolated areas have no service at all. In the future, we intend to seek additional funding from RUS to ensure 100% service to our residents. By providing fiber to our community, REDI Net will enable us to establish a larger customer base to support rural deployment, use our Tribal rights-of-way and existing infrastructure to maximize cost efficiency, and secure more affordable interconnections with long-haul fiber. This additional fiber request will provide us with a stronger economic competitive base, increase affordability and ensure sustainability while providing broadband services to our most remote customers. In turn, this will change the paradigm that has kept tribal communities from realizing their full potential. High-speed broadband is indeed a solution to many of tribal community needs and it will allow us to become partners in solving Northern New Mexico’s challenges, including high drop-out rates, low incomes and loss of population from rural areas. It also allows us to explore new opportunities made possible by the American Recovery and Reinvestment Act such as renewable energy, telemedicine and distance learning.

Once fully operational, we intend to purchase wholesale bandwidth from REDI Net for our WiMAX system, subject to reasonable rates and terms, and look forward to the significant educational and economic development benefits this high-speed network will bring to our community and to this region of northern New Mexico.


