The University of Utah / Utah Education Network (U of U/UEN) had another very productive quarter to start 2012 and continues to build out the network and connect Community Anchor Institutions (CAI) on schedule. The U of U/UEN has successfully connected one hundred fifteen (115) of the total one hundred forty (140) CAIs for the project and has installed forty-four (44) miles of new fiber. The completion of the Salt Lake and Logan Middle Mile Optical Network segments of the project, which were included in an Award Action Request approved last fall, are progressing on schedule as well. All associated contracts have been signed including 20 year Indefeasible Rights of Use (IRU) agreements with two providers, Zayo Networks and Syringa Networks. All site surveys have been completed and the site preparations and fiber installation is underway. The installation of equipment and lighting of the fiber for the Salt Lake segment is scheduled for completion during the second quarter.

Other activities include equipment procurement and the continued development and distribution of information for community outreach purposes.

In all cases solutions were found and the project build out continued on schedule.
