1. Please describe significant project accomplishments completed during this quarter (600 words or less).

KINBER met the grant special award condition to have the project substantially complete by February 2012. In fact, many of the baseline milestones were exceeded.

At the end of Q1, 2012; KINBER reports 787 miles of fiber completed. Thirty-nine (39) Community Anchor Institutions (CAIs) are connected to the network. Sixty (of 62) building surveys have been completed and entrance construction has been completed on 43 sites. KINBER received approval on a final Environmental assessment that allows project coordination in Western Pennsylvania with another BTOP awardee, Zito Media LLC.

KINBER has completed the staging and burn-in activities for PennREN network equipment and has completed network equipment installations at six (6) of the twenty-three (23) planned locations to house equipment. KINBER staff have initiated negotiations for external network connectivity providers to deliver services to PennREN including Internet2, Internet, and MPLS based VPN services. We have also engaged and started integration planning and startup activities for network operations center services with outsourced provider (GRNOC - Global Research Network Operations Center). Staff have also initiated network IP and Autonomous System Number requests with ARIN for integration with external networks and providers.

KINBER staff submitted a satisfactory response to a request for a Performance Improvement Plan (PIP) by the NTIA. KINBER continues to have discussions with last mile providers to satisfy its open access requirement.

1. Please describe significant project accomplishments planned for completion during the next quarter (600 words or less).

In 2012 Q2, KINBER will continue equipment installations at designated locations per the project schedule and begin segment testing on select network segments to prepare for segment turnover activities. We will have over 1,000 miles of fiber completed and at least 43 community anchor institutions connected to the network. All equipment will be procured. Equipment will be staged and delivered to ten (10) of the twenty-three (23) sites requiring equipment. At least one segment will be lit and tested.

KINBER will finalize its 2013 operating budget and service offering catalog as well as develop pricing models. KINBER will continue the search to hire two additional network engineers and advertise other positions in sales and administration. These job titles and responsibilities are yet to be determined. No federal grant funds will be used for any of these postions.

The KINBER staff and board will continue to build the organization's visibility through public meetings, a marketing campaign and creating a framework for handling sales and service inquiries. Additionally, KINBER's website will become more robust with content and information. KINBER will be hosting the first annual Member Meeting, which is open to the public, in April. The member meeting is envisioned as an opportunity for public officials, anchor institution representatives, and the public to learn more about KINBER and what the PennREN network will be offering. It will also be a place for people to collaborate on projects and technology solutions for their institutions. The KINBER Board and staff will be holding a "Town Hall" session to share their vision for the future of KINBER and answer questions from attendees.

Negotiations with last mile providers will continue as will discussions about an IRU of KINBER fiber to meet the NTIA open access

Although we do not anticipate any new challenges in 2012, Q2 we continue to wait for make ready and right of way permits and this could result in delays. We have some segments that can not be completed and tested due to small portions of the network that have not yet received all of the necessary approvals. Specifically, there is an Amtrak crossing in Paradise, Pa. (Segment C) that we have been waiting over a year for approvals on the permits that were filed in 2011. These delays could force much of the segment testing into the last few months of the grant award period.
