 Mainline fiber construction has been completed in three of the five funded service areas. Equipment procurement and installation is proceeding quickly.  Delays at the beginning of the project have affected ENMR's ability to reach milestone objectives. As of 9/30/11 the total project dollars spent equates to 56%, at approximately 55% of the award period, compared to baseline estimates of 58%. Based on recent productivity we are expected to surpass the targeted 66% completion by the end of award year 2.
