The Minnesota State Government has been shut down since July 1, 2011 and it has not been resolved as of the date of this report. It is Zayo's understanding that the state permitting agencies were 6 weeks behind on permitting before the shutdown. If the shutdown goes for three or four weeks this could a delay of ~10 weeks. Zayo also had some issues with limited ROW's. Zayo has found existing conduit along most of the areas where this exist. Zayo has submitted purchase requests to BTOP to allow us to purchasing this existing conduit to help us avoid the limited ROW areas and BTOP is working to approve.

The biggest challenge that Zayo sees coming up is trying to catch up with our baseline plan after the Minnesota State shutdown. It is hard to predict at this particular time how far we will be behind and how much we will have to catch up until after the shutdown ends so that we know how much time we have missed. We are figuring that if this delay goes on for another 3 weeks this could result in a 9 week delay as it is our understanding that the permitting agencies were 6 weeks behind before the shutdown. Zayo will continue to contact CAI's and last mile providers as we build out. Even with delays, it is Zayo's plan to be 90% complete by the end of the first eight quarters.
