Please describe significant project accomplishments completed during this quarter (600 words or less).</b></p> <p>During the last quarter the Request For Proposal (RFP) for the construction of the Middle Mile Digital Microwave (DMW) sites was evaluated, and price agreements have been awarded. Three term positions were announced and interviews are being conducted. It is expected that these positions will be hired within the next four to six weeks. The site inspections have been completed and the Environmental Assessment will be finalized and submitted. (submitted on 07/13) The Overlap Maps were submitted. Additionally, maps have been forwarded based on request from various Tribal responses. The sole source request for contacting general counsel was approved and the contract finalized. Site lease agreements are still being reviewed for notification requirements and any restrictions that may apply. The project was presented to the State's Project Certification Committee for the Planning Phase and received approval for budget release of \$7,175K.</p>
