The New Jersey BTOP team will purchase 37 deployable assets equipped with microwave and satellite backhaul, and end-user devices. The project calls for allocating 27 deployable assets (COWs and SOWs) for the three proof-of-concept networks, and 10 assets in ready standby which will be deployed as necessary throughout the State and Region. The deployables based networks will include LTE equipment, microwave, satellite, and appropriate Band Class 14 devices (Band Class 14 is the portion of radio spectrum that is licensed to FirstNet and designated for broadband services for the public safety community).

The New Jersey BTOP team will procure User Equipment (UEs) – specifically vehicular modems, dongles (USB wireless antenna devices), tablets and air cards – that can be used with the LTE Band Class 14 services. Users of the deployable-based network will include State law enforcement, fire service, EMS and NJ Transit personnel.
