In response to the NOAA partial suspension of grant funds, the State undertook to re-cast the project to avoid the potential delay of the partial suspension. The revised project would not actually deploy an LTE network; instead, it would prepare government-owned sites statewide to accept the future nationwide network. The State submitted a revised budget reflecting the re-cast project and is in the process of incorporating NTIA comments into those budget documents. Finally, the State took major steps toward bringing additional staff onto the project team, including selection of contractors and interviewing FTE candidates.
