The new leased fiber lit in 2011 positions these CAIs to connect at speeds up to 1 gigabit. Since only a small portion of the network (80 of 2,000 miles is operational, the new service offerings are not available. Once fully deployed, these CAIs will realize a significant increase in broadband speeds as they move from 3-5 megabits to 50-100 megabits.

Since construction has yet to begin, there are no services currently being offered. Once operational, the network will offer the following services: Dark Fiber, Lambda/Wave Services, Ethernet Services ranging in speeds of 10 Mbps to 10 Gbps, and Internet services.

Our sub recipient, Illinois State University (ISU), has learned that it is imperative to appoint a single point of contact to work with CAIs. In the beginning, ISU had several staff members working with the same CAIs sometimes created confusion. The CAIs prefer working with one person even if it takes longer to respond to inquiries.

CMS is using Share Point as the central repository for program and project management. The capabilities inherent to Share Point enhance the collaboration among the team members and streamline record keeping through automation. For example, CMS stores permit documents in Share Point and uses "view capabilities" to sort and analyze the data by construction package, status, and permitting authority. This feature allows team members to quickly sort and access the information in a view that meets their specific need. Another example of how CMS is using Share Point is managing vendor weekly certified payroll. Vendors send their weekly certified payroll documents to a specific email address that automatically files the email and its attachments in the appropriate Share Point folder. These easy to use features in Share Point are saving staff time generating and filing reports.
